NOTE A – DESCRIPTION OF THE PLAN

The following description of the Chief Container Co., Inc. 401(k) Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General.* The Plan is a defined contribution plan covering all employees of the Company who have completed one year of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Fidelity Management Trust Company serves as the Plan's trustee and third-party administrator.

*Contributions.* Each year, participants may elect to defer a portion of compensation, as defined in the Plan, up to the maximum amount determined by current laws and regulations. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. The Company makes a matching contribution equal to 50% of salary deferrals that do not exceed 7% of compensation. Contributions are subject to certain annual limitations.

*Participant Accounts.* Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) Plan earnings, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The accounts are participant directed.

*Vesting.* Participants are immediately vested in their contributions. A participant is 100% vested in the Employer matching contribution plus actual earnings thereon after six years of credited service.

*Notes Receivable from Participants.* Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years. The Administrator may permit a longer repayment period if the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account. The loan interest rate is set by the Plan Administrator. Principal and interest is paid ratably through payroll deductions. Participant loans are valued at the unpaid principal balance plus accrued interest. Participant loans outstanding totaled \$177,831 at December 31, 2024 and \$150,271 at December 31, 2023 and are presented in the statements of net assets available for benefits as notes receivable from participants.

*Payment of Benefits.* On termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan allows for in-service withdrawals at age 59 ½. A participant may elect to withdraw all or a portion of their entire vested account after reaching age 59 ½. At age 70 ½, 72 or 73 (depending on when a participant was born) and separated from service, a portion of the balance will be required to be distributed each year.

*Corrective Distributions.* Occasionally, participant contributions and earnings thereon are returned to participants in order for the Plan to pass certain Internal Revenue Code compliance tests. The Plan returned \$18,409 contributions and earnings to affected participants for the year ended December 31, 2024.

*Forfeitures.* Participants who leave the Plan may forfeit certain amounts. Forfeitures are used by the plan to reduce future employer contributions. The Company did not utilize any forfeitures to reduce the employer match for the year ended December 31, 2024. There was \$4,277 in unapplied forfeitures at December 31, 2024.

## NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting.* The financial statements of the Plan are prepared using the accrual method of accounting.

*Investment Valuation and Income Recognition.* The Plan's investments are stated at fair value with the exception of the fully benefit-responsive investment contract, which is carried at contract value. As of December 31, 2024, the Plan holds investments in mutual funds and a guaranteed investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits.* Benefits are recorded when paid

*Expenses.* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

*Use of Estimates.* The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Subsequent Events.* The plan has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued.

## NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Contract value represents contributions plus credited interest less participant withdrawals and fees. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Fund seeks the preservation of capital plus competitive intermediate-term returns. The fund is backed by a diversified portfolio of fixed-income assets held in the general account of the issuer. Guarantees are subject to the claims paying ability of the issuer. Restrictions or fees may apply to exchanges or withdrawals. The Contracts provide for the payment of certain withdrawals and exchanges at book value during the terms of the Contracts. In order to maintain the Contract issuers' promise to pay such withdrawals and exchanges at book value, the Contracts subject the fund and its participants to certain restrictions. For example, withdrawals prompted by certain events (e.g., layoffs, early retirement windows, spin-offs, sale of a division, facility closings, plan terminations, partial plan terminations, changes in laws or regulations) may be paid at the market value of the fund's securities, which may be less than the book value balance or may restrict withdrawals in these events.

The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The actual average yield earned by the Plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The average yield for 2024 was 3.42%.

NOTE E – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE G – TAX STATUS

On September 7, 2021 the Plan was amended and restated by adopting a volume submitter 401(K)/Profit Sharing Plan through Fidelity Management Trust Company. The volume submitter plan has received a favorable opinion letter dated June 30, 2020 in which the Internal Revenue Service stated that the plan is in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. The Plan evaluates all significant tax positions as required by generally accepted accounting principles in the United States of America. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE I – PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan and any person who provides services to the Plan. For the year ended December 31, 2024 certain Plan investments are managed by Fidelity Management Trust Company who is also the record-keeper of the Plan. Some participants also have loans in the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

NOTE J – SUBSEQUENT EVENTS

The Plan was amended effective January 1, 2025 to become a Qualified Automatic Contribution Arrangement Plan (QACA). The plan is a type of 401(k) plan that includes automatic enrollment for employees, along with other features like automatic contribution increases (escalation) and specific vesting and matching rules. Employees are automatically enrolled in the plan after becoming eligible. An employee is eligible to participate in the plan once they have attained age 18 and complete 1 year of service with 1,000 hours. Participants are enrolled automatically in the Plan with a pre-tax deferral contribution of 6% of eligible compensation unless they affirmatively elect otherwise. Those participants with a deferral rate greater than zero will have that deferral increased annually by 1% each year on July 1<sup>st</sup> as a pre-tax deferral contribution until a deferral rate of 10% is reached. The 401(k) QACA safe harbor matching employer contribution is 100% of the first 1% of eligible participant's compensation contributed to the Plan and 50% of the next 5% of the eligible participant's compensation contributed to the Plan. Participants are 100% vested in the safe harbor matching contribution after completing 2 years of credited service.
