INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and 401(k) Committee
Met-Con Companies 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Met-Con Companies 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Met-Con Companies 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Met-Con Companies 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and

maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Met-Con Companies 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1 PLAN DESCRIPTION

The following description of the Met-Con Companies 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Met-Con Companies, Inc. and its related and participating employers (as defined and collectively referred to as the Company or Plan Sponsor), whereby eligible employees are permitted to make pretax contributions that are tax deferred under Section 401(k) of the Internal Revenue Code (the Code). The Company appointed Fidelity Management Trust Company (Fidelity) to be the trustee of the Plan, and authorized Fidelity to invest and manage the assets of the Plan and provide administrative services. The Company is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All employees who have completed 3 months of service, as defined, are eligible to participate, provided they are at least 21 years of age and not a leased employee or member of a union. Entrance dates are the first day of each month following the date eligibility requirements are met.

Contributions

Participants may contribute up to 100 percent of their defined compensation to the Plan, subject to certain maximum limitations imposed by the Code. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions subject to the maximum limitation imposed by the Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3 percent of eligible compensation. Each year thereafter, automatically enrolled participants' deferral election percentage shall be automatically increased by 1 percent, up to a maximum of 15 percent. Contributions are automatically invested in a designated fund until changed by the participant. The Company contributes 50 percent of the first 6 percent of the participants' eligible compensation that a participant contributes to the Plan. The Company has reserved the right to amend the Plan to suspend, modify, or terminate its matching contributions. Contributions are subject to certain statutory limitations.

The Company may also make discretionary non-elective contributions at the option of the board of directors. Such discretionary contributions shall be allocated to each participant's account in the ratio that his or her compensation bears to the total eligible compensation paid to all eligible participants. The Company did not make any discretionary non-elective contributions for 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contribution and Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service as follows:

Years of Service	Vesting Percentage
Less than 2	0%
2	25%
3	50%
4	75%
5 or more	100%

Benefits Paid to Participants

Upon death, permanent disability, retirement, or other termination of employment, participants are entitled to receive the vested balance of their accounts. Vested benefits are distributed in the form of a lump-sum amount, installments over a specified period of time, or partial withdrawal. The Plan allows participants to withdraw funds from their account without a minimum service period after the age of 59 ½ as defined in the plan document. If at the time a participant is terminated, their account balance is less than \$1,000, it will be automatically distributed to the participant in a lump sum. The Plan provides for the automatic rollover of vested participant balances above \$1,000, but less than \$5,000 into an individual retirement account if the participant does not elect to have the distribution paid directly to an eligible retirement plan in a direct rollover or to receive the distribution directly. Hardship withdrawals are also allowed, subject to the provisions specified in the Plan document.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$476 and \$8,991, respectively. The balance of forfeited employer contributions and allocated earnings thereon may be used to reduce employer contributions to the Plan or to pay Plan administrative expenses. During 2024, the amounts of employer nonvested contributions forfeited were \$13,353.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Paid to Participants

Benefits paid to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation in fair value of investments. The administration expenses disclosed on the statement of changes in net assets available for benefits are not significant.

Administrative expenses include fees for investment advisory and recordkeeping services. For the year ended December 31, 2024, the Plan incurred advisor fees paid to Capital Management totaling \$43,424. The Plan also received revenue sharing credits from investment providers, which were applied to recordkeeping fees charged by Fidelity. These credits exceeded the related expenses, resulting in a net credit of \$15,998. Accordingly, the total administrative expense reported reflects the net of fees and credits, totaling \$27,426.

Subsequent Events

The plan administrator evaluated subsequent events through July 24, 2024, the date which the financial statements were available to be issued.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan follows guidance for fair value measurements that provides a framework for measuring fair value under GAAP. This guidance emphasizes that fair value is a market-based measurement, not an entity-specific measurement, and sets out a fair value hierarchy with three categories:

Level 1: Inputs consist of unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs consist of observable inputs other than quoted prices for identical assets (Level 1). If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Mutual funds are valued based on quoted prices of identical shares in active markets for shares held by the Plan as of year-end.

Money Market Fund

The money market fund is valued at the net asset value as reported by the money market fund based on quoted market prices.

The methods described above may produce fair values that may not be indicative of net realizable values or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 6 TAX STATUS

The Plan was adopted under the Fidelity Volume Submitter Defined Contribution Plan. The Internal Revenue Service (IRS) has issued an opinion letter dated June 30, 2020, which stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Code. The prototype plan's opinion letter has been relied upon by the Plan. The Plan Administrator believes the Plan is currently being operated, in compliance with the applicable provisions of the Code, and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
