Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kansas State University Foundation Defined Contribution Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Kansas State University Foundation Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the "Auditor's Responsibilities for the Audit of the Financial Statements" section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the “Auditor’s Responsibilities for the Audit of the Financial Statements” section of our report. We are required to be independent of Kansas State University Foundation Defined Contribution Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Kansas State University Foundation Defined Contribution Retirement Plan’s ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan’s transactions that are presented and disclosed in the financial statements are in conformity with the plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the “Scope and Nature of the ERISA Section 103(a)(3)(C) Audit” section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1. Description of the Plan

General

The following description of Kansas State University Foundation Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Kansas State University Foundation (the Foundation) for the benefit of its employees. Employees are immediately eligible to participate in the Plan as a contributing participant upon commencement of employment. Participants aged 21 and over who are not normally scheduled to work less than 20 hours per week qualify for mandatory employee contributions and employer nonelective contributions. Employees excluded as normally scheduled to work less than 20 hours per week become eligible for mandatory employee contributions and employer nonelective contributions after completing one year of service consisting of 1,000 hours worked. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Teachers Insurance and Annuity Association of America (TIAA) serves as the issuer of the TIAA Traditional Annuity contract held by the Plan and as a recordkeeper of the Plan. TIAA, FSB was the custodian of the Plan's mutual funds until October 2023. Effective October 20, 2023, the Plan was amended and restated ("Plan Amendment") and Lincoln Financial Group Trust Company, Inc., (Lincoln Trust) became the Plan's new custodian and Lincoln Retirement Services Company, LLC (Lincoln Retirement) became the Plan's primary recordkeeper. Plan assets transferred to Lincoln Trust were transferred into funds comparable to those offered by the previous custodian. The conversion initiated a "Black Out" period beginning October 16, 2023, and continued through November 3, 2023. During this period, funds could not be diversified or withdrawn from the Plan until Lincoln Retirement had time to accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions and the contributions were deposited based upon existing investment elections. At the end of the Black Out period, participants were able to access their accounts. Following the Plan's transfer to Lincoln Trust, certain Plan participants still hold individually-controlled annuity contracts with TIAA and College Retirement Equities Fund (CREF).

Contributions

Eligible participants are required to make mandatory employee contributions of 5.5% of eligible compensation as a condition of employment. The Foundation is required to make a nonelective contribution of 10% of a participant's eligible compensation to each participant who makes a mandatory employee contribution.

The Plan also permits employees through a voluntary salary deferral election to have the Foundation make annual contributions out of eligible compensation as either pre-tax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Employee rollover contributions are also permitted. Prior to October 20, 2023, the Plan provided for employer matching contributions of 10% of eligible compensation for participants not subject to mandatory employee contributions whose voluntary elective deferrals were at least 5.5% of eligible compensation and who worked 1,000 hours during the plan year. Effective October 20, 2023, the Plan no longer permits employer matching contributions.

Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing contributions into any of the investment account options selected by the Foundation and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Foundation's contribution, and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their voluntary and mandatory employee contributions as well as the Foundation's contributions plus earnings thereon.

Notes Receivable from Participants

The Plan Document includes provisions authorizing participants to borrow from their fund accounts. The minimum amount of a loan shall be \$1,000 with a maximum of three loans outstanding at one time. Effective October 20, 2023, the maximum number of outstanding loans was reduced from three to two. The maximum amount of the participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. If a participant already has a loan, the \$50,000 maximum is reduced by the highest outstanding loan balance in the 12-month period prior to the loan. All loans are covered by demand notes and are repayable over a period not to exceed five years. Interest on the loans is based on 1% over Prime Rate. Principal and interest is paid monthly through direct remittance by the participant and is not funded through payroll deductions.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum, installments, ad-hoc distributions, or purchase of an annuity. Effective October 20, 2023, the available forms of distribution are lump-sum and installments. A participant may elect to receive a distribution of their rollover contributions at any time. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution retirement plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Variable annuity accounts, the pooled separate account and mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is a readily determinable fair value and is the basis for current transactions.

The fair value of guaranteed investment contracts (excluding fully benefit-responsive investment contracts) are calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the Foundation are recorded in the year in which the respective plan compensation is paid and the employee contributions are deducted.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Plan Loans

Under TIAA, participants can obtain loans issued directly from funds owned by TIAA. TIAA issues loans to Plan participants outside the scope of the Plan. Participants pledge as security a portion of their balance in the TIAA Traditional Annuity, which represents 110% of the outstanding loan balance. The maximum amount that may be borrowed is limited to the portion of the plan balance that consists of only unmatched pre-tax deferrals (*i.e.*, GSRA-group supplemental retirement annuity). The amounts pledged as collateral at December 31, 2024 and 2023, were approximately \$42,000 and \$54,000, respectively.

The Employee Benefits Security Administration (EBSA) has expressed concern that the pledging of collateral of a participant's balance could be considered a prohibited transaction; however, formal guidance has yet to be issued by the EBSA.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Foundation or the Plan, at the Foundation's discretion.

The Plan has a non-allocated plan expense account to pay necessary and reasonable plan related expenses in accordance with the Department of Labor's guidance. The Foundation is responsible for determining what expenses the third-party administrator will reimburse from the account. Starting with the year ended December 31, 2024, additions to the account from revenue sharing credits were \$12,728 and expenses paid from the account were \$12,728. The account's balance at December 31, 2024, was \$16 and is included in the investments at fair value on the statements of net assets available for benefits

Note 3. Certification of Plan Custodians

The Foundation has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF, and Lincoln Trust, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Traditional Annuity Accounts are classified as a Level 3 investment.

Note 5. Investment Contract with Insurance Company

The Plan has entered into investment contracts with TIAA. TIAA maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract is fully benefit-responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by TIAA, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the Plan to qualify for

exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Due to contract provisions, participant account balances in TIAA guaranteed investment contracts were not transferred to Lincoln Trust in October 2023 and are instead being transferred from TIAA to Lincoln Trust in monthly installments over a 60-month period beginning November 2023. These monthly installments are invested according to each participant's current investment elections on file with Lincoln Retirement at the time each installment is transferred.

All guaranteed investment contracts under the Plan are traditional investment contracts for both years ended December 31, 2024 and 2023.

Note 6. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are mutual funds, units of variable annuity accounts or units of a pooled separate account that are managed by an entity related to TIAA, a recordkeeper for the Plan. The Plan's traditional annuity contract is maintained in TIAA's general account.

The Plan paid \$49,156 and \$75,570 of direct plan administrative fees to its third-party service providers during the years ended December 31, 2024 and 2023, respectively. The Plan received revenue sharing credits of \$12,728 during 2024 and \$0 during 2023. These funding credits are netted with administrative expenses in the statements of changes in net assets available for benefits. The Foundation provides certain administrative services at no cost to the Plan.

Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Foundation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 9. Reconciliation of Financial Statements to Form 5500

For financial statement reporting, revenue sharing credits are netted against administrative expenses. For Form 5500 purposes, administrative expenses are shown gross of revenue sharing credits and those credits are included in other income.

Note 10. Tax Status

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code of 1986, as amended. Effective October 20, 2023, the Plan operates under a volume submitter 403(b) plan document sponsored by Lincoln Retirement, which was pre-approved by the Internal Revenue Service according to an advisory letter dated March 31, 2017. Therefore, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 11. Subsequent Events

Subsequent events have been evaluated through September 10, 2025, which is the date the financial statements were available to be issued.
