Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Snyder Paper Corporation Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of November 30, 2024 and 2023 (in liquidation), the related statements of changes in net assets available for benefits for the years ended November 30, 2024 and 2023 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Snyder Paper Corporation Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended November 30, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Snyder Paper Corporation Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Basis of Accounting

As discussed in Note 8 to the financial statements, the Plan Administrator and Management of Snyder Paper Corporation Retirement Plan approved a plan of liquidation August 1, 2023 and determined that liquidation is imminent. As a result, the Plan's financial statements for the years ended November 30, 2024 and 2023 are prepared on the liquidation basis of accounting. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Note 1: DESCRIPTION OF THE PLAN

The following description of the Snyder Paper Corporation Retirement Plan (the Plan) provides only general information. Refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a noncontributory, defined benefit pension plan sponsored by Snyder Paper Corporation (the "Company", "Sponsor", "Employer" or "Plan Administrator"). The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Committee is responsible for oversight of the Plan. The Plan's Retirement Committee determines the appropriateness of the Plan's investments, monitors investment performance and actuarial services and reports to the Company's Board of Directors.

Some administrative functions are performed by employees of the Company. No compensation is remitted to the Company for these services.

Plan assets are held and managed by Truist Bank, the trustee and the qualified institution of the Plan, which invests employer contributions and Plan earnings, makes investment transactions as directed by the Retirement Committee and provides certain recordkeeping services. McGriff Insurance Services is the actuary for the Plan and performs certain plan administration. Sterling Capital Management, LLC acts as the Plan's investment advisors.

On June 13, 2023, the Retirement Plan Committee of the Plan approved the termination of the Plan effective August 1, 2023. See Note 7.

Eligibility

The Plan covers all employees of the Company who will or who have completed one year of service and were hired prior to April 1, 2009.

Funding Policy

The Plan's funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During 2024 and 2023, the Company made contributions of \$1,099,119 and \$500,000, respectively. The Company's contributions for 2024 and 2023 exceeded the minimum funding requirements of ERISA.

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. On June 13, 2023, the Retirement Plan Committee of the Plan approved the termination of the Plan effective August 31, 2023. See Note 7.

Vesting

The Plan provides that participants become 100% vested after five years of service.

Note 1: DESCRIPTION OF THE PLAN (Continued)

Pension Benefits

Any eligible employee as determined above who has attained the normal retirement age (65), so long as the employee reached the fifth anniversary of the commencement of participation in the Plan, is entitled to receive a pension. The monthly benefit shall be the participant's frozen accrued benefit as of the last day of the plan year beginning before January 1, 1994 plus 1.25% of final average compensation or career average compensation multiplied by years of service as defined by the Plan document.

Participants who are between 55 and 65 and have 15 years of service may retire at the option of the participant and will receive a reduced benefit. The reduction is 1/15th for each of the first 5 years and 1/30th for each of the next 5 years by which the benefit commences prior to the normal retirement age. The Plan was frozen as of January 31, 2017, and no additional benefit accruals are earned after that date.

Death Benefits

If an active employee eligible for early retirement dies, the surviving spouse shall receive a monthly survivor benefit under the modified joint and survivor benefit option as defined in the Plan.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Due to the decision to terminate the Plan effective August 31, 2023, the financial statements as of November 30, 2024 and 2023 have been prepared using the liquidation basis of accounting.

Use of Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein; disclosure of the actuarial present value of accumulated plan benefits as of the date of the financial statements. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value but may also be reported at net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Note 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (continued)

The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Valuation of Other Financial Instruments

The carrying value of the Plan's receivables approximate fair value.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Plan contributions are made and are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, September 12, 2025. See Note 7 for relevant disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

Note 3: INFORMATION CERTIFIED BY THE QUALIFIED INSTITUTION

The Plan Sponsor has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements was obtained by management and agreed to or derived from information certified to be complete and accurate by Truist Bank, the qualified institution:

- a) Total investments, at fair value, and accrued interest and dividend income included in the statements of net assets available for benefits at November 30, 2024 and 2023.
- b) Investment income information and net appreciation (depreciation) in the value of investments included in the statements of changes in net assets available for benefits for the years ended November 30, 2024 and 2023.
- c) All amounts included in Note 4, *Fair Value Measurements*.
- d) All information included in the supplemental schedule of assets (held at end of year) as of November 30, 2024 and the supplemental schedule of reportable transactions for the year ended November 30, 2024.

Note 4: FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - observable; or
 - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2024 and 2023:

Exchange Traded Funds: Valued at the daily closing prices reported in the active market in which the individual security is traded. The funds are registered with the Securities and Exchange Commission. Market value may or may not be the same as NAV.

Interest-bearing cash: Valued at cost, which approximates fair value. The fund is a short term investment option that utilizes a bank deposit account affording the account Federal Deposit Insurance Corporation (FDIC) insurance coverage.

Note 5: TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter November 9, 2015 that the Plan and related trust were designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan received a favorable determination letter on January 17, 2025 that applies to amendments from May 2016 to April 2024.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. During the years ended November 30, 2024 and 2023, the Plan incurred trustee fees of \$18,320 and \$20,423 and investment management fees of \$31,485 and \$28,926, recordkeeping, actuary fees and other professional fees of \$87,421 and \$65,288, respectively.

At November 30, 2024 and 2023, the Plan held certain investment funds, which are managed by the trustee. These transactions qualify as party-in-interest transactions. Any purchases and sales of investments are open market transactions at fair value. Consequently, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Certain Plan assets are maintained in an interest-bearing insured deposit account with Truist Bank. Truist Bank is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 7: PLAN TERMINATION

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Benefits attributable to employee contributions, taking into account those paid out before termination.
2. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding Plan termination.
3. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations.
4. All other vested benefits (that is, vested benefits not insured by the PBGC).
5. All nonvested benefits.

Note 7: PLAN TERMINATION (Continued)

On May 31, 2023, the plan sponsor notified plan participants of their intent to terminate the Plan effective August 1, 2023. All participants became fully vested in their accrued benefits at that time.

The Company has filed for a determination letter from the IRS regarding the Plan's qualified status upon termination. A favorable determination letter was received January 17, 2025 and the Company fully settled all Plan liabilities through a combination of lump-sum distributions to eligible participants and the purchase of annuity contracts from one or more insurance companies in May 2025. Upon satisfying the above obligations, any excess amounts were refunded to the Plan Sponsor.

As of November 30, 2024, the Plan recorded a liability for estimated payments to participants upon liquidation of \$21,039,445, an estimate of accrued interest expense to be earned in liquidation of \$407,135, an estimate of investment losses to be incurred in liquidation of \$823,656 and an estimate of accrued expenses expected to be incurred in liquidation of \$180,359.

All Plan assets were distributed to plan participants by June 2, 2025.
