**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Carl Buddig and Company Deferred Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was established on October 29, 1983. The Plan has been amended throughout the years to comply with tax legislation. The Plan is a defined contribution plan covering all full-time employees of Carl Buddig and Company (the Company) who are age 18 and are not represented for collective bargaining purposes by any bargaining unit, excluding any employee hired on a nonpermanent basis until he or she completes at least 1,000 hours of service during consecutive 12 months of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective April 1, 2024, the Plan was amended to limit the number of total loans that can be outstanding to a participant at any time to two; however, participants are only allowed one outstanding residential loan at any time.

**Contributions**

Each year, participants may contribute up to 75% of pre-tax annual compensation, as defined in the Plan subject to certain Internal Revenue Code (IRC) limitations. Participants may also contribute after-tax Roth elective deferrals, which are treated in the same manner as pre-tax deferrals. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at 3% unless they affirmatively elect not to participate in the Plan or elect a different deferral percentage. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Matching amounts may be contributed at the option of the Company's Board of Directors. The Company matched 30% of every dollar, up to 6% of each employee's compensation, of all employees' contributions for the year ended December 31, 2024. Safe Harbor contributions are 3% of each participant's compensation for the Plan year. The safe harbor contribution totaled \$1,790,493 for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Allocations can be changed daily and funds are rebalanced annually to reflect the elected investment mix.

**Vesting**

The Plan maintains up to 11 separate accounts for each participant:

- (a) Employer Matching Contribution Account
- (b) Employer Regular Profit Sharing Contribution Account
- (c) Safe Harbor Contribution Account
- (d) Pre-Tax Contribution Account
- (e) Roth 401(k) Account
- (f) Prior Profit Sharing Account
- (g) Vested Profit Sharing Account
- (h) Carl Buddig Pension Plan Account
- (i) Old Wisconsin Pension Plan Account
- (j) Rollover Account
- (k) Roth 401(k) Rollover Account

The Employer Matching Contribution Account holds matching contributions to the Plan and will vest 20% after two years of service and 20% per year thereafter for employees hired on or after January 1, 2021. Employees hired prior to January 1, 2021 are immediately 100% vested in these contributions.

The Employer Regular Profit Sharing Contribution Account holds profit sharing contributions to the Plan and will vest 20% after two years of service and 20% per year thereafter.

The Safe Harbor Contribution Account holds the Company's contributions for the participant covered by the Plan. The participant is immediately 100% vested in these contributions.

The Pre-Tax Contribution Account and Roth 401(k) Account hold the participant's contribution to the Plan and are 100% vested to the participant.

The Prior Profit Sharing Account holds the participant's balance of the distribution rolled over from the inactive Carl Buddig and Company Employees' Profit Sharing Plan and Trust. The participant will vest 20% after two years of service and 20% per year thereafter.

The Vested Profit Sharing Account holds vested profit sharing contributions to the Plan and is 100% vested to the participant.

The Carl Buddig Pension Plan Account holds the participant's balance of the distribution rolled over from the inactive Carl Buddig Pension Plan. The participant is 100% vested in the account.

The Old Wisconsin Pension Plan Account holds the participant's balance of the distribution rolled over from the inactive Old Wisconsin Pension Plan. The participant is 100% vested in the account.

The Rollover Account and Roth 401(k) Rollover Account hold any rollover contributions into the Plan from another qualified plan and are 100% vested to the participant.

**Investment Options**

The Plan currently offers a variety of mutual funds, one collective fund, and a self-directed brokerage option as investment options for participants. All investments are participant directed.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of \$50,000 or 50% of the vested portion of their account balance, whichever is less. Loan terms range from 1 to 15 years depending on the utilization of the funds. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through periodic payroll deductions.

**Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive the balance of his or her account in a lump sum payment or annual installments over multiple periods, as defined. A participant whose service is terminated for any other reason is entitled to the distribution of the then vested portion of the various account balances. Participants having an immediate and heavy financial hardship without any other source of funds may request a hardship withdrawal of their Pre-Tax Contribution or Roth 401(k) Accounts.

If no election for distribution is made within 60 days after the end of the Plan year in which the participant terminates employment, terminated employees with vested account balances of less than \$1,000 may be required to take a lump sum distribution. Terminated employees with vested account balances of less than \$5,000 but more than \$1,000 may be automatically rolled into an IRA account for the participant. If the vested balance exceeds \$5,000, distribution will be made only if the participant consents.

**Forfeitures**

When terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. There were \$52,590 of forfeitures used to pay administrative expenses and \$-0- of forfeitures used to reduce Company contributions for the year ended December 31, 2024. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$520,531 and \$336,918, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Transfers**

Along with the Plan, the Company also sponsors 401(k) plans for other participant groups. If employees change their status during the year, their account balances are transferred into the corresponding plan. For the year ended December 31, 2024, Plan net transfers to other 401(k) plans sponsored by the Company were \$(6,267).

**Subsequent Events**

The Plan has evaluated subsequent events through August 19, 2025, the date the financial statements were available to be issued.

**NOTE 3 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 3 FAIR VALUE MEASUREMENTS (CONTINUED)**

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Fund* – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Self-Directed Brokerage Accounts* – Valued at the fair value as reported by Charles Schwab for the individual investments reported in the various portfolios subject to the investment adviser’s review and approval. Investments include principally stocks, ETFs, mutual funds, certificates of deposit, and interest bearing cash. Stock, ETF, mutual fund investments are valued on the basis of readily determinable market prices. The fair value of certificates of deposit is estimated by discounting the future cash flows using rates currently offered for deposits of similar remaining maturity. Cash, both interest bearing and non-interest bearing, is valued based on cost, which approximates fair value in a non-inflationary economy, and is protected by the FDIC up to certain limits.

**NOTE 4 CERTIFICATION OF INVESTMENT INFORMATION**

The qualified institution of the Plan, Vanguard Fiduciary Trust Company, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 5 PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds and a collective fund managed by The Vanguard Group, which is affiliated with Vanguard Fiduciary Trust Company, the qualified institution of the Plan. Therefore, transactions with the qualified institution qualify as party-in-interest. Fees paid by the Plan for investment management services and recordkeeping amounted to \$132,880 for the year ended December 31, 2024.

**NOTE 6 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

**NOTE 8 PLAN TAX STATUS**

The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
