Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule listed in the table of contents, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or are derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1. Description of Plan

Boston Semi Equipment LLC (Company) sponsors the Boston Semi Equipment LLC 401k Profit Sharing Plan and Trust (Plan) and is the Plan's administrator. The following description of the Plan provides only general information. Participants and other interested persons should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution and safe harbor 401(k) plan. Established in 2010, the Plan was merged with Boston Semi ATE LLC 401(k) Retirement Savings Plan (formerly known as MVTTS Technologies, LLC 401(k) Retirement Savings Plan) in 2017. Effective February 1, 2017, the Company adopted a new Plan document sponsored by Fidelity Management & Research Company. Fidelity Management Trust Company (Trustee) is the Plan's trustee; Fidelity Workplace Services, LLC is the Plan's recordkeeper; CBIZ MHM, LLC is the Plan's third-party administrator; and First National Advisors LLC is the Plan's investment advisor. The Plan enables eligible employees of the Company to voluntarily defer pre-tax and/or after-tax compensation (otherwise known as Roth Contributions) to provide income for their retirement in accordance with Section 401(k) of the Internal Revenue Code (Code). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

Eligibility

The Plan covers eligible employees of the Company working in the United States who have attained the age of

21. The Plan excludes (i) non-resident aliens who do not receive any earned income from the Company which constitutes U.S. source income (effectively, employees working at the Company's foreign subsidiaries), (ii) employees covered under collective bargaining agreements, unless participation is provided for in those agreements, and (iii) leased employees.

Investments

Participants may direct their contributions into various investment options offered by the Plan. If a participant does not provide investment direction to the Trustee, the Trustee will invest the participant's contributions in a target date fund which, generally, maintains a diversified asset portfolio that is adjusted during the life of the fund to reduce investment risk in relation to an approximate retirement date based on the age of the participant.

Participants' Accounts

Individual accounts are maintained for each participant of the Plan. Each participant account is self-directed and credited with the participant's contributions, the Company's matching contributions, and any earnings on associated investments or debited with any losses on such investments.

Eligible employees may contribute up to 92 % of their pre-tax compensation to the Plan, subject to limitations specified under the Code. For 2024, the maximum allowable annual contribution under the Code was

\$23,000. Participants aged 50 and older are permitted to contribute an additional \$7,500, as catch-up contributions, resulting in a potential pre-tax contribution limit of \$30,500 for qualifying individuals. In addition, participants are permitted to contribute amounts representing rollovers from other qualified plans.

The Plan allows participants to defer funds into a "Roth 401(k) deferral." These deferrals are subject to federal income taxes, and the maximum allowable combined contributions of the Roth 401(k) and pre-tax deferrals in 2024 was \$23,000.

Automatic Enrollments

New employees are automatically enrolled in the Plan on their first day of employment with the Company at a pre-tax contribution rate of 3% of allowable compensation. Participants' deferrals are also subject to an annual auto escalation of 1 % of allowable compensation up to a maximum of 6% of allowable compensation. Employees may change their contribution percentage and/or opt out of participation in the Plan at any time.

Employer Contributions

The Company matches 100 % of the first 1 % of allowable compensation that an eligible Participant contributes to the Plan and 50 % of the next 5 % of allowable compensation contributed to the Plan (representing a total match of up to 3.5 % of allowable compensation). The employer matching contributions are funded each pay period, with a true-up contribution at year end. There is no match on rollover contributions. The employer contribution receivable as shown in the accompanying statements of net assets available for benefits of \$8,217 and \$9,809 at December 31, 2024 and 2023, respectively, represents true-up contributions.

Discretionary Company Contributions

The Company has the option to make additional contributions to the Plan on a discretionary basis, up to a limit of 4% of an eligible participant's compensation. Since the Plan's inception, the Company has not made any discretionary contributions.

Vesting

Participants are fully vested in their account balances at all times, including all Company matching contributions and all discretionary Company matching contributions, if any.

Participant Loans and In-Service Withdrawals

Active participants are permitted to borrow against their Plan accounts up to the lesser of \$50,000 or 50% of their vested account balances. All loans are evidenced by a promissory note and secured by the vested account balance of the participant borrower. Interest is charged at a rate determined by the Trustee. At December 31, 2024, interest rates on loan balances outstanding ranged from 4.50 % to 9.50 % per annum. New loan terms may not exceed five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended. Principal amortization and interest payments are paid by the participant in equal installments through payroll deductions. If a participant's employment terminates at a time when the participant has an outstanding loan balance, all outstanding principal and interest become due and payable.

In-service withdrawals are allowed in certain circumstances, such as for active military service, age 59½ withdrawals, disability, and hardship withdrawals, subject to provisions of the Code.

Benefits

Following termination of employment, whether through retirement, disability, or death, participants are entitled to receive a lump-sum or installment cash payment, except as otherwise provided in the Plan document and subject to restrictions imposed under the Code.

Forfeitures

To the extent that the Company overfunds its matching contribution, such excess is held in the Plan's forfeiture account. Any forfeitures occurring during a Plan year may be used to pay administrative expenses under the Plan at any time, if so directed by the Plan administrator. Any forfeitures not used to pay administrative expenses under

the Plan shall be applied to reduce the employer contributions for the following Plan year. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$96 and \$134, respectively. During 2024, approximately \$60 of employer contributions were paid from the forfeiture account.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed by the Plan.

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with generally accepted accounting principles (GAAP) in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported or disclosed in the financial statements. Actual results could differ from those estimates.

Contributions

Participant contributions to the Plan are collected by the Company through payroll deductions and forwarded to the Trustee.

Benefits Paid to Participants

Distributions from the Plan are paid directly by the Trustee to the participants and are recorded in the period in which they are paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year, net of certain investment related expenses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Related fees, as determined and charged by the Trustee, are recorded as administrative expenses and are expensed when they are incurred. In accordance with the terms of the Plan document, delinquent participant loans are treated as defaulted loans if repayment is not made within a defined cure period, at which time, the participant is treated as having received a taxable deemed distribution under the Code.

Administrative Expenses

Investment-related and recordkeeping expenses of the Plan are paid from the Plan's assets. Certain investment-related expenses are recorded as reductions of net investment income and are not identifiable on the financial statements. Personnel and facilities of the Company are used by the Plan for its accounting and other activities at

no cost to the Plan. In addition, the Company has elected to pay, but is not required to pay, certain other administrative costs of the Plan, including the cost of the third-party administrator and the Plan's audit.

Subsequent Events

The Plan has evaluated subsequent events through August 13, 2025, which is the date the financial statements were available to be issued.

Note 3. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA- required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

On June 30, 2020, the Internal Revenue Service (IRS) stated that the non-standardized pre-approved plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Company directly pays any other fees related to the Plan's operations.

Administrative expenses paid to Fidelity Workplace Services, LLC by the Plan for recordkeeping services approximated \$21,500 for the year ended December 31, 2024. Fees paid to First National Advisors LLC, and its predecessor affiliate, for investment advisory services were \$10,500 for the year ended December 31, 2024.

Note 6. Plan Termination

The Company expects and intends to continue the Plan indefinitely, but reserves the right to amend the Plan, including discontinuing or changing the level of future matching contributions, or terminating the Plan at any future date.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASC ASC 820 are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 Inputs to valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability

Level 3 Significant unobservable inputs, including the Company's own assumptions in determining the fair value of investments

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and Level 3 inputs are only used when higher level inputs are not available.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023 from prior years.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued based on the underlying unit value of the assets held. The trust invests primarily in various investment contracts that are valued at the Net Asset Value ("NAV") of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
