**Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Boston Brace International, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Boston Brace International, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



**Note 1 - Description of Plan**

The following description of the Boston Brace International, Inc. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible full-time employees of the Company. Employees must complete three months of service and have attained the age of eighteen to be eligible participants and to be eligible to receive nonelective Company contributions. The Plan is subject to the provisions of *Employee Retirement Income Security Act of 1974 (ERISA)*. The Board of Directors oversees governance of the Plan. The Plan’s Administrative Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Directors.

**Contributions**

The Plan contains salary reduction features under Internal Revenue Code Section 401(k). The Plan allows for salary reduction contributions for each participant. Participants may contribute up to the maximum amount allowed by law. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market fund as investment options for participants. The Company makes safe harbor matching contributions. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant’s contribution and an allocation of the Company’s contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Any active participating employees, who are not separated from service, are immediately 100% vested in their contributions, employer contributions, plus actual earnings thereon.

**Payment of Benefits**

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or in installments over a stated number of years.

**Administrative Expenses**

All expenses of administration will be paid out of the Plan unless paid by the Company.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Forfeited Accounts**

Forfeited nonvested accounts are used to reduce future employer matching 401k contributions. For the years ended December 31, 2024 and 2023, forfeited nonvested accounts totaled \$576 and \$676, respectively.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes must be repaid over a period no longer than 5 years, unless the note is used to acquire a participant's principal residence, in which case, the term may not exceed 15 years. The notes are secured by the balance in the participant's account and bear interest at a rate ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined periodically by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting whereby revenues are recognized when earned and expenses are recognized when incurred. The Form 5500 is converted to the cash basis of accounting.

**Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credits losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Note 2 - Summary of Significant Accounting Policies (continued)**

**Investment Valuation and Income Recognition**

The Plan's investments consist of shares in various mutual funds and a money market account offered by a registered investment company. The shares are valued at the net asset value of shares held by the Plan at year end.

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair market value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Liabilities**

The Plan had distribution checks returned totaling \$884 during December 31, 2024 and 2023, which are recorded as other liabilities.

**Payment of Benefits**

Benefits are recorded when paid.

**Operating Expenses**

All expenses of maintaining the Plan are paid by the Company.

**Unrecognized Tax Benefits**

The Company's income tax filings are subject to audit by various taxing authorities. The Company believes its tax positions will be sustained upon examination by taxing authorities. There are no uncertain tax positions for the years ended December 31, 2024 and 2023.

**Note 3 - Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring use of Level 3 inputs for the periods presented.

*Level 1 Fair Value Measurements*

The fair value of mutual funds and money market funds is based on quoted net asset values of the shares held by the Plan at year-end. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

**Note 7 - Tax Status**

The Volume Submitter Plan Administrator has informed the Company that the Internal Revenue Service has determined by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan may have been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Boston Brace International, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1 - Description of Plan**

The following description of the Boston Brace International, Inc. (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible full-time employees of the Company. Employees must complete three months of service and have attained the age of eighteen to be eligible participants and to be eligible to receive nonelective Company contributions. The Plan is subject to the provisions of *Employee Retirement Income Security Act of 1974 (ERISA)*. The Board of Directors oversees governance of the Plan. The Plan’s Administrative Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Plan’s Board of Directors.

**Contributions**

The Plan contains salary reduction features under Internal Revenue Code Section 401(k). The Plan allows for salary reduction contributions for each participant. Participants may contribute up to the maximum amount allowed by law. Participants who have attained age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market fund as investment options for participants. The Company makes safe harbor matching contributions. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant’s contribution and an allocation of the Company’s contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Any active participating employees, who are not separated from service, are immediately 100% vested in their contributions, employer contributions, plus actual earnings thereon.

**Payment of Benefits**

On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or in installments over a stated number of years.

**Administrative Expenses**

All expenses of administration will be paid out of the Plan unless paid by the Company.

**Note 1 - Description of Plan (continued)**

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Forfeited Accounts**

Forfeited nonvested accounts are used to reduce future employer matching 401k contributions. For the years ended December 31, 2024 and 2023, forfeited nonvested accounts totaled \$576 and \$676, respectively.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes must be repaid over a period no longer than 5 years, unless the note is used to acquire a participant's principal residence, in which case, the term may not exceed 15 years. The notes are secured by the balance in the participant's account and bear interest at a rate ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined periodically by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

**Note 2 - Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting whereby revenues are recognized when earned and expenses are recognized when incurred. The Form 5500 is converted to the cash basis of accounting.

**Use of Estimates**

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credits losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

**Note 2 - Summary of Significant Accounting Policies (continued)**

**Investment Valuation and Income Recognition**

The Plan's investments consist of shares in various mutual funds and a money market account offered by a registered investment company. The shares are valued at the net asset value of shares held by the Plan at year end.

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair market value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Liabilities**

The Plan had distribution checks returned totaling \$884 during December 31, 2024 and 2023, which are recorded as other liabilities.

**Payment of Benefits**

Benefits are recorded when paid.

**Operating Expenses**

All expenses of maintaining the Plan are paid by the Company.

**Unrecognized Tax Benefits**

The Company's income tax filings are subject to audit by various taxing authorities. The Company believes its tax positions will be sustained upon examination by taxing authorities. There are no uncertain tax positions for the years ended December 31, 2024 and 2023.

**Note 3 - Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring use of Level 3 inputs for the periods presented.

*Level 1 Fair Value Measurements*

The fair value of mutual funds and money market funds is based on quoted net asset values of the shares held by the Plan at year-end. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Although the Plan may have been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
