Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Note 1 - Plan description

The following description of Fidelity & Guaranty Life 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established to permit participants to take advantage of the benefits of Section 401(k) of the Internal Revenue Code ("IRC"). The Plan is a defined contribution plan covering substantially all domestic employees of Fidelity & Guaranty Life Business Services, Inc. (the "Company") who are 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Retirement Savings Plan Administration Committee is responsible for oversight of the Plan. The Retirement Savings Plan Administration Committee also determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to of 75% of pre-tax annual compensation, as defined in the Plan, subject to statutory limitations of the IRC. Employees 50 years of age or older may defer a maximum of \$30,500 and \$30,000, respectively, for 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified employee benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Employees may also defer up to 100% of any bonus designated by the Company provided the total contribution does not exceed the lesser of 75% of eligible compensation, as defined by the Plan, or maximum statutory limits. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

The Company, at its discretion, may match employee contributions made during the Plan year in an amount determined by the Company, expressed as a percentage of employee earnings. During 2024 and 2023, the Company matched 100% of employee contributions up to 5% of employee eligible compensation. Participants also direct the investment of Company contributions.

The Company may contribute an additional amount, not to exceed the amount allowed by law. If such contribution is made, it shall be allocated among all employees of the Company who worked no less than 501 hours during the year and were employed as of December 31 of that year, based on a percentage of the employee's total annual compensation paid. As of December 31, 2024 and 2023, discretionary contributions of \$3,622,581 and \$2,878,703, respectively, were approved and remained receivable.

Participant accounts

Each participant's account is credited with the participant's salary deferral and rollover contributions, plus an allocation of employer contributions, Plan earnings, and realized and unrealized gains and losses on investments. Participants are afforded several investment options covering a wide range of investment objectives and risks. Participants may allocate their contributions across these options in any proportion they wish and can change this allocation at any time. Transfers of account balances between elected investment options may also be made at any time.

Vesting

Participants are automatically 100% vested in their own contributions plus earnings thereon. Effective January 1, 2013, employer matching contributions vest automatically.

Payment of benefits

Upon termination of service due to death, disability, retirement or other reasons, participants may elect to receive either a lump-sum amount equal to the vested value of their account or periodic installments over their life expectancy. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In-service withdrawals are permitted on the participant's vested balance when a participant reaches age 59 and a half. Hardship distributions are permitted if certain conditions are met. After the withdrawal, the participants may not make savings or other contributions to the Plan for six months.

Forfeited accounts

Forfeited balances of terminated participants' nonvested accounts are used to reduce future employer contributions to the Plan. As of December 31, 2024, and 2023, unallocated forfeitures were \$219 and \$1,660, respectively. In 2024, employer contributions were reduced by \$7,007 of forfeited nonvested accounts.

Notes receivable from participants

Participants may borrow from their fund accounts up to the lesser of \$50,000 or one-half of their vested interests and a minimum of \$1,000. The loans are secured by the balance in the participant's account. Loans will bear a reasonable rate of interest comparable to the interest rate charged on similar commercial loans at the time of borrowing. Interest income from these loans is treated as income to the Plan and is allocated with other earnings on investments and credited to each participant's account. Interest is charged between 4.25% and 9.5% on all outstanding loans as of December 31, 2024. Principal and interest are repaid through payroll deductions.

Administrative expenses

The Company pays substantially all administrative expenses of the Plan. Certain investment management fees and other charges paid to the custodian are offset against fund performance in net appreciation in fair value of investments and are not, therefore, separately reflected as administrative expenses.

Note 2 - Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Savings Plan Administration Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Discretionary contributions are recorded in the year approved by the Company.

Notes receivable from participants

Participant notes are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Subsequent events

The Plan has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued.

Note 3 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 -Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

Level 2 -Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability; and

Level 3 -Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of units of a bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 4 - Related party and party-in-interest transactions

The Plan has investments in shares of mutual funds managed by Fidelity Management Trust Company ("Fidelity"). Fidelity is the trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

During the year ended December 31, 2024, the Plan paid recordkeeping fees in the amount of \$65,113 to Fidelity Investments Institutional Operations Company, Inc., an affiliate of Fidelity.

Fees paid by the Plan to RBC Institutional Consulting and RBC Wealth Management for investment advisory services totaled \$50,000 for the year ended December 31, 2024.

Note 5 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their employer contributions.

Note 6 - Tax status

The Plan obtained its latest opinion letter on March 31, 2014, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Note 8 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental schedules were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity.
