To the Trustees and Plan Participants

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Buckingham Asset Management, LLC 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 1. Description of the Plan

The following brief description of the Buckingham Asset Management, LLC 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established effective March 1, 1994 and was most recently restated effective January 1, 2022. The Plan sponsor is Buckingham Asset Management, LLC (the Company). On June 30, 2024, the management company of Buckingham was purchased by Focus Financial Partners. As part of this process, Buckingham merged with The Colony Group, LLC, another firm owned by Focus Financial Partners.

The Plan is comprised of two parts, elective and nonelective contributions. Each part has its own set of eligibility and entry date requirements. The Plan covers all employees over 20 ½ years of age.

Plan Merger

Effective December 31, 2024, the Plan merged into The Colony Group, LLC 401(k) Profit Sharing Plan. All assets were transferred to The Colony Group, LLC 401(k) Profit Sharing Plan effective with the plan merger. As a result, no assets belong to the Buckingham Asset Management, LLC 401(k) Profit Sharing Plan as of December 31, 2024.

Eligibility – Elective Contributions

Eligible employees participate in the Plan after completing one month of service. Entry date into the plan is the first day of the month following or coinciding with or next following satisfying the participation requirement. Once meeting eligibility requirements, employees are automatically enrolled in the plan with an initial deferral rate of six percent (6%) of base salary unless the participant makes a contrary election. The Plan also contains an automatic escalation feature whereby participants who are automatically enrolled have their contribution rates increased by 1% annually, up to 12%.

1. Description of the Plan (continued)

Eligibility – Nonelective Contributions

Eligible employees participate in the Plan upon satisfying 1,000 hours of service within the eligibility computation period. The initial eligibility computation is defined as the first six months of service. Subsequent eligibility period is the Plan Year, beginning with the Plan Year that includes the first anniversary of the employee's employment date. The entry date into the plan is the first day of the Plan Year coinciding with or immediately preceding the date on satisfying the participation requirement.

Nonelective Contributions

The Company may make profit sharing contributions as outlined by the Plan agreement. To be eligible for the profit-sharing contribution, the employee must have worked at least 1,000 hours during the year and be employed on the last day of the year. During 2024, no profit-sharing contribution was declared.

All contributions are subject to maximum amounts as permitted by the Internal Revenue Service (the IRS).

Participant Accounts

All Plan investments are participant directed. Plan participants have the option of having their contributions invested in a variety of mutual funds, a money market fund, or a self-directed brokerage fund. Each participant's account is credited with the participant's contributions, and allocations of (a) the Company's contributions, (b) Plan earnings or losses, and (c) charged with administrative expenses, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Under the provisions of the Plan, participants are immediately 100 percent vested in their contributions plus actual earnings thereon. Participants are also 100 percent vested in rollover contributions and safe harbor contributions, if any. Employer profit sharing contributions begin vesting after two years of service, with 25 percent vesting each year until participant are 100 percent vested after five years of service, as defined. participant accounts may be used to reduce Company profit sharing contributions, in accordance with Plan provisions.

Benefits

On termination of service for any reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants electing to receive benefits after the normal retirement age of 65 may choose either a lump-sum amount or annual installments. The Plan permits in-service and hardship withdrawals under certain conditions. Participant loans are not permitted.

Administrative Expenses

Substantially all the costs of administering the Plan are paid by the Company. Certain costs are paid by participants.

Forfeited Accounts

At December 31, 2023, forfeitures of \$39,905 were available for future use. During the year ended December 31, 2024, forfeitures of \$2,589 were used to reduce expenses, in accordance with Plan provisions.

Other Income

During the year ended December 31, 2024, the Plan received revenue sharing income of \$9,476 which was credited to participant accounts.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in the company contribution portion of their account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are accounted for on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest from investments is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Distribution fees are charged directly to the participant's account and are included in administrative expenses. Participant accounts may also be charged with quarterly management fees, based on participant balances.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. Investment Information Certified by Custodian

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends, and interest for the year ended December 31, 2024, were obtained or derived from information supplied to the plan administrator, and certified as complete and accurate, by the custodian, Alerus Financial, N.A.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

4. Fair Value Measurements (continued)

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Cash Equivalent Fund

The money market fund is considered a cash equivalent fund. It pays interest at stated rates. The fund publishes its NAV daily, which is maintained at \$1 per unit.

Self-Directed Brokerage Accounts

The Plan permits self-directed brokerage accounts of actively traded securities with quoted market prices. Self-directed brokerage accounts are comprised of mutual funds, unit investment trusts and money market funds, all of which are valued at the daily closing price as reported by the fund. The mutual funds, unit investment trusts and money market funds held by the Plan are open-end investment funds that are registered with the Securities and Exchange Commission. These investment funds are required to publish their daily net asset value and transact at that price. The investment funds held by the Plan are deemed to be actively traded.

There were no Plan assets as of December 31, 2024.

5. Administration of Plan Assets

The Plan's assets are held by the custodian of the Plan. Company contributions are held and managed by the custodian, which invests cash received, interest, and dividend income and makes distributions to participants under the direction of the Plan management and recordkeeper.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

6. Related Party Transactions and Prohibited Transactions

As noted in Notes 1 and 5, the Plan has a number of service providers. Such parties are parties-in-interest under ERISA.

During the year ended December 31, 2024, the Plan administrator identified that participant contributions totaling \$864,930 were remitted to the plan in violation of Department of Labor (DOL) regulations. The Plan administrator funded this amount to the Plan in 2024.

The Plan administrator does not anticipate that the self-correction of the late remittance will have an adverse effect on the Plan's tax status.

7. Income Tax Status

On November 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). The plan document has been amended subsequent to the determination letter. The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan, as amended, was designed and has been operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Subsequent Events

Management has evaluated all subsequent events through June 27, 2025, which represents the date the financial statements were available to be issued.
