To the Administrative Committee of the

Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the accompanying financial statements of ICR, Inc. Retirement Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ICR, Inc. Retirement Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis of Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ICR, Inc. Retirement Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following description of the ICR, Inc. Retirement Trust provides only general information. Participants should refer to the Plan agreement for the complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees' of ICR, Inc. Retirement Trust. The Plan was established February 1, 2014 and has been amended as needed.

All full-time and part-time employees, age 21 and older, excluding independent contractors, interns, temporary employees, seasonal employees and non-resident aliens, are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration of Plan Assets

The Plan is administered under a service agreement with CMC Interactive.

Contributions

Participants may defer a portion of their annual pay to the extent that their contributions comply with Internal Revenue Code (IRC) limitations. These contributions are not subject to Federal income taxes until withdrawn, in accordance with section 401(k) of the IRC. Catch-up contributions are also permitted for participants who reach 50 years of age by the end of the year.

The Plan provides for Company discretionary and qualified non-elective contributions. For 2024 and 2023, the Company contributed 0% and 12.5% of each eligible employee's annual pay.

The Plan also allows participants to make rollover contributions from other tax qualified plans, which will always be fully vested. Rollover contributions are included in the accompanying financial statements as a component of participant contributions.

Participants direct the investment of their contributions and the Company discretionary contributions into various investment options offered by the Plan.

1. Description of Plan (Continued)

Participants Accounts

A separate account is maintained for each investment option of a participant by type of contribution. Each participant's account is credited with the participant's salary-deferral contributions, rollovers, employer discretionary contributions, and Plan earnings (losses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their salary-deferral contributions, rollovers, and employer matching contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25%-9.5% which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Payment of Benefits

On termination of service or retirement, a participant may elect to receive payment of their account balance in a lump sum amount from the trust fund. However, if the value of the vested balance is less than \$1,000, a lump-sum distribution will be made regardless of whether participant elected to receive it. In the event that a participant dies before retirement, the participant's beneficiary will receive periodic payments over the life of the beneficiary. Under a special rule, participants may elect to waive the annuity form of distribution. Alternative forms of distribution are single lump-sum payment in cash, installments over a period of not more than the assumed life expectancy of beneficiary or the purchase of a different form of annuity. Participants qualifying for hardship withdrawal may receive portion of their contributions, plus investment returns earned thereon.

Plan Termination

Although it has not expressed any intentions to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provision set forth in ERISA.

Forfeited Accounts

At December 31, 2024 and 2023, there was \$5,439.68 in forfeited non-vested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fulling benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition.

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s committee determines the Plan’s valuation policies utilizing the information provided by the investment advisors and custodians. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investment. During the year ended December 31, 2024 and 2023, administrative expenses totaling \$6,293 and \$4,775, respectively.

Payment of Benefits

Benefits are recorded when paid.

Excess Contribution Payable.

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributes the excess contributions to the applicable participants prior to March 15 of the following year.

Date of Management's Review Subsequent Events

Subsequent events were evaluated through September 5, 2025, which is the date the financial statements were available to be issued.

3. Tax Status

The Company adopted a volume submitter Profit-Sharing Plan with CODA (Prototype Plan), which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. The letter stated that the Prototype Plan is designed in accordance with applicable standards on the Internal Revenue Code. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements. Therefore, earnings on contributions to the Plan are not subject to tax under present income tax laws and contributions to the Plan are not subject to Federal income tax to the employees until distribution from the Plan. Management believes that amendments adopted since receipts of the determination letter do not affect the tax status of the Plan.

3. Tax Status (Continued)

The Plan's trustees have determined that no uncertain tax positions exist at December 31, 2024 which require disclosure in accordance with Accounting Standards Codification 740-10.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audit for any tax period in progress.

4. Financial Information Certified by the Trustee

The Company has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

5. Fair Value Measurements

In May 2017, the FASB issued ASU 2017-07, Fair Value Measurement (Topic 820): Disclosures for Investments in Certain Entities That Calculate Net Asset Value per Share (or Its Equivalent), which exempts investments measured using the net asset value (NAV) practical expedient in ASC 820, Fair Value Measurement, from categorization within the fair value hierarchy. The guidance requires retrospective application and is effective for public business entities for fiscal years, and interim periods within those years, beginning after December 16, 2017. For all other entities, the guidance is effective for fiscal years, and interim periods within those years, beginning after December 16, 2017. Early adoption is permitted. Management elected to early adopt the provision of this new standard.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have lowest priority.

5. Fair Value Measurements (Continued)

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

Level 2 Fair Value Measurements

The fair value of corporate bonds and U.S. government securities are calculated using a market approach on yields currently available on comparable securities of issuers with similar credit ratings. Investments in certain restricted common stocks are valued at the quoted market price of the issuer's unrestricted common stock less an appropriate discount. The fair value of the certificates of deposit is based on amortized cost or original cost-plus accrued interest.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Charles Schwab Trust Bank and its Business Trust Division (BTD). Charles Schwab Trust Bank is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$6,293 for the year ended December 31, 2024. Notes receivable from participants are also party-in-interest transaction.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. Subsequent Event

Management has adopted ASC 855, subsequent events (formerly SFAS No. 165) effective for interim and annual periods ending after June 16, 2017. Management has evaluated events occurring after the date of the Statements of Net Assets Available for Plan Benefits through September 5, 2025 and determined that no material transactions have occurred that would impair the financial position or results of operations as of December 31, 2024.

9. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
