Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of L.W. Schneider, Inc. 401(k) & Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.



NOTE 1 DESCRIPTION OF PLAN

The following description of L.W. Schneider, Inc. 401(k) & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and was originally established on November 1, 2007, for employees of L.W. Schneider, Inc. (the Company). The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective August 15, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company has selected an employee of the Company to serve as administrator of the Plan. Among the duties of the administrator are the maintenance of participant records, the determination of the right of any person to a benefit, and other various duties.

Heartland Bank and Trust has been named trustee. Hand Benefits & Trust Company serves as the custodian and Benefits Plans Administrative Services, LLC serves as the third-party administrator.

Eligibility

Employees of L.W. Schneider, Inc. are eligible to participate in the deferral component and Company match component of the Plan upon completion of one year of service with a minimum of 1,000 hours. Participants may enter the Plan on the first day of the calendar quarter following when eligibility requirements are met.

Contributions

The Plan permits voluntary contributions by participants of pre-tax dollars up to the maximum amount as defined by certain Internal Revenue Code (IRC) limitations. Participants' elective contributions withheld from their compensation will be paid weekly to the Plan custodian. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions.

The Company discretionary matching contribution is equal to 100% of participant deferrals up to the first 3% of the participant's eligible compensation. The Company will additionally match 50% of deferrals in excess of 3% of the participant's eligible compensation, but not to exceed 5% of eligible compensation. The Company may also contribute a profit sharing amount, at the discretion of the Company's Board of Directors, to eligible employees who are employed on December 31 of the Plan year. Contributions are subject to certain limitations. There were no profit sharing contributions for the years ended December 31, 2024 and 2023. The company paused their match in September of 2023. The match remains paused, although a company match was contributed for one pay period during the 2024 Plan year.

Contributions (Continued)

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, and an allocation of Plan earnings and losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, participant account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

The amounts contributed by the employee are fully vested. A participant is fully vested upon reaching normal retirement age, death, or permanent disability. For Company contributions before August 1, 2013, the amount contributed by the Company on behalf of the employee is 100% vested. For Company contributions after August 1, 2013, participant's interest in their share of these contributions vest in accordance with the following schedule based on their years of service:

Notes Receivable from Participants

Effective August 15, 2023, participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate of the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Benefit Payments

Benefits are payable to the participant upon:

- a) death or retirement from the service of the Company on or after normal retirement date (age 65) or on account of disability; or
- b) resignation or dismissal from the service of the Company prior to normal retirement date.

If the benefits are payable in the event of (a) and (b) above, the benefits payable would be the total of the participant's own contributions, and the vested amount of Company's matching contributions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the vested benefits are between \$1,000 and \$5,000, the Plan administrator may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. If the balance is more than \$5,000, an election to receive the benefit must be made. Benefits will be paid in a lump sum payment.

Each participant or former participant may, in writing, designate a beneficiary or beneficiaries to whom distributions of his interest in the custodial account shall be made in the event of the participant's death.

In-service withdrawals are available to participants if the participant has reached the age of 59½. Withdrawals are allowed from all of the participant's accounts. Hardship withdrawals are available to participants who have specific needs subject to Plan provisions.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts were \$19,886 and \$18,975, respectively. Forfeitures are used to reduce Company contributions, pay Plan expenses, or are reallocated to participants. Total forfeitures used to reduce Company contributions were \$-0- and \$11,971 for the years ended December 31, 2024 and 2023, respectively. No forfeitures were used to pay Plan expenses or reallocated to participants for the years ended December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable are recorded as distributions based on the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as administrative expenses in the accompanying statements of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through September 9, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Hand Benefits & Trust Company, the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The Financial Accounting Standards Board Statement (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access;

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Fund: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS) indicating that the Plan is designed in accordance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 7 PLAN TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Hand Benefits & Trust Company, the qualified institution of the Plan. Therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Certain administrative functions are performed by employees of the Company, for which no compensation is received.

NOTE 9 PROHIBITED TRANSACTIONS

During 2023, the Plan Sponsor failed to deposit participant deferrals and loan payments within the required time frame as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The Plan Sponsor corrected the prohibited transactions in 2024 by depositing the missed contributions and lost earnings.
