Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of E.R. Jahna Industries, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of E.R. Jahna Industries, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and December 31, 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of E.R. Responsibilities of Management for the Financial Statements



NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

Note A - Description of Plan

The E. R. Jahna Industries, Inc. 401(k) Plan (the Plan) was established on April 1, 1995, by E.R. Jahna Industries, Inc. (the Company) to hold investments of the defined contribution 401(k) plans of participating employers. At December 31, 2024, there are two related corporations that participate in the Plan. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all eligible, full-time employees of the Company who have satisfied eligibility conditions. The primary purpose of the plan is to provide employees of the Company with financial benefits upon retirement. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974 (ERISA)*.

Contributions. An employee becomes a participant in the plan when they have satisfied eligibility requirements and reached their entry date. An employee's entry date is defined as when he or she completes 90 consecutive days of service and have attained the age of 18. Employees are eligible to participate in employer matching and profit sharing contributions upon reaching their entry date and upon completion of one year of service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a collective investment trust as investment options for participants. Only in the case of profit sharing distributions, contributions are automatically invested in a designated balanced fund until changed by the participant. If the employee is not a participant in the 401(k) plan and has not set up their account and investment options, T. Rowe Price puts the funds into an account in the designated fund for the profit sharing contribution. The Company contributes 100% of the first 3% of base compensation that a participant contributes to the Plan plus 50% of each participant's elective deferrals in excess of 3% but not to exceed 5%. Additional profit sharing amounts may be contributed at the option of the Company. During the year ended December 31, 2024 and 2023, the Company made profit sharing contributions to the Plan of \$1,386,429 and \$1,441,574, respectively. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts. Each participant's account is credited with their participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with certain investment fees charged by investment companies. The Plan sponsor pays for audit and certain other fees charged by T. Rowe Price. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are vested immediately in their contributions and the Company's matching contributions plus actual earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 6 years of credited service. Upon the death or permanent disability of a participant, their entire balance becomes fully vested.

Note A - Description of Plan - Continued

Notes receivable from participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined at the inception of the loan, is set at 1% above the prime rate, as defined. Notes outstanding at December 31, 2024 and 2023, bear interest rates ranging from 4.25% to 9.50%. Principal and interest is paid ratably through weekly payroll deductions.

Payment of benefits. On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installments over a fixed reasonable period of time. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Forfeitures. At December 31, 2024 and 2023, forfeited non-vested accounts total \$41,371 and \$41,839, respectively. These accounts will be redistributed to plan participants. In 2024 and 2023, total forfeitures plus investment returns were \$41,369 and \$41,837 and redistributed forfeitures were \$41,837 and \$62,603, respectively.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for disclosure of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as deemed distributions based upon terms of the Plan document.

Administrative and Investment Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

Date of Management Review

Subsequent events were evaluated through August 11, 2025, which is the date the financial statements were available to be issued.

Note C - Trust Agreements

Reliance Trust Company is the trustee for the Plan, manages the Plan assets, executes investment transactions for the Plan, and makes distributions to participants as directed by the Plan administrator. E. R. Jahna Industries, Inc. serves as the Plan administrator.

Note D - Certified Investments by Reliance Trust Company

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The following is a summary of the unaudited information regarding the Plan as of and for the years ended December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Reliance Trust Company, the Trustee, and furnished to the Company. The Company has obtained certifications from the Trustee as of and for the years ended December 31, 2024 and 2023, that such information is complete and accurate.

Note E - Fair Value Measurements

The Plan's investments are stated at fair value based on the following hierarchy of fair value measurement inputs:

- Level 1 The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

- Level 2 The fair value of collective investment trusts is based on quoted net asset values of the shares in markets that are not actively traded.

Note F - Parties-in-Interest

Certain Plan investments are managed by T. Rowe Price Retirement Plan Services, Inc. (T. Rowe Price) and, therefore, these transactions qualify as party-in-interest transactions.

T. Rowe Price provides certain administrative services to the Plan pursuant to a Recordkeeping Services Agreement (RSA) between the Company and T. Rowe Price. T. Rowe Price receives revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to T. Rowe Price for its administrative services to the Plan.

If the revenue received by T. Rowe Price from such mutual fund service providers exceeds the amount owed under the RSA, T. Rowe Price remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or be allocated to the accounts of participants. During 2024 and 2023, there was excess revenues of \$32,604 and \$28,140 credited to the plan and administrative expenses of the plan were reduced by \$20,625 and \$12,425, respectively. Total fees paid to T. Rowe Price in 2024 and 2023 from the Plan were \$25,165 and \$16,905, respectively.

At December 31, 2024 and 2023, Plan investments totaling \$19,605,621 and \$16,625,723 are shares of mutual funds and collective investment trusts of T. Rowe Price. Purchases and sales of these shares qualify as party-in-interest transactions.

Note G - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note H - Right to Terminate Plan

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the Plan's provisions and those of *ERISA*. In the event of Plan termination, participants would become 100% vested in their accounts.

Note I - Tax Status

The Plan sponsor adopted a new Non-Standardized Defined Contribution Pre-Approved Plan and Trust effective February 1, 2022. The IRS issued an opinion letter on the acceptability of this plan and trust in a letter dated June 30, 2020. The Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
