Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Riggs Industries, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For



information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following description of the Riggs Industries, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all hourly and salaried employees of Riggs Industries, Inc. (Riggs) and its wholly owned subsidiaries, Somerset Welding & Steel, Inc.; Lincoln Contracting & Equipment Co., Inc.; and Somerset Steel Erection Co., Inc. (the Companies), who have reached age 18 and have completed 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute to the Plan up to 75% of their compensation, as defined in the Plan, subject to Internal Revenue Code (IRC) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Companies contributed 100% of the first 6% of compensation contributed by employees in matching contributions, subject to certain limitations. All participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions subject to IRC limitations.

The Plan includes an automatic enrollment policy. Under this policy, if an individual does not submit an automatic enrollment waiver or elect a deferral rate, the employee will be automatically enrolled in the Plan at a 3% deferral rate.

The Companies may also provide a discretionary annual contribution to the Plan. There was no discretionary contribution made into the Plan for the year ended December 31, 2024.

Participants must complete one year of service and be employed on the last day of the Plan year to be eligible for the discretionary contribution. Participants must also have at least one hour of service during the Plan year to receive the employer discretionary contribution.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

The Plan administrator maintains separate participant accounts for each participant. Each participant's account is credited with their voluntary contributions; the Companies' matching contributions, including discretionary contributions; and an allocation of investment income (loss) of the elected investment funds. Allocations of fund investment income (loss) to the participants' accounts are based upon the ratio of the participant's account balance to the total balance of all participant account balances in the fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies' match and discretionary contribution portion of employee accounts, plus actual earnings thereon, is based on years of continuous service. A participant vests pro rata over six years of credited service.

Participants automatically become fully vested with respect to employer contributions upon attaining age 65, permanent disability, death, or death while on a leave of absence to perform military service.

Benefits

On termination of service due to death, disability, or retirement, a participant may receive a lump-sum amount equal to the vested value of his or her account. Hardship withdrawals are also permitted in certain cases. Terminated employees receive a lump-sum amount if their account balance is less than \$7,000. If their account balance is greater than \$7,000, the participant and his or her spouse must consent to receive a lump-sum distribution.

Normal retirement occurs at age 65; however, an active employee may begin to receive in-service withdrawals at age 59½.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and a maximum equal to the lesser of 50% of their vested balance or \$50,000, reduced by the participant's highest outstanding loan balance during the prior 12 months. Participants may have no more than one loan outstanding at any one time. Repayment terms generally may not exceed five years. The loans are secured by the balance of the participant's account and bear interest at the prevailing rate at the time of the loan. Participant loans currently bear interest varying from 4.25% to 9.5%.

Forfeitures

Forfeited amounts of terminated participants' non-vested accounts are retained in the Plan to be used as permitted by the Plan agreement. Employer contributions reduced by the forfeitures within the Plan totaled \$13,000 in 2024. On a periodic basis, the Plan allocates forfeiture account balances to active employees as per stated within the Plan document. Forfeited accounts totaled \$7,289 and \$7,071 at December 31, 2024 and 2023, respectively.

Plan Termination

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at a measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Companies consider the principal or most advantageous market in which they would transact and consider the assumptions that market participants would use when pricing the asset or liability.

The three levels of inputs that may be used to measure fair value are as follows:

Level 1 - This level consists of observable inputs, such as quoted prices in active markets for identical investments that the Companies have the ability to access.

Level 2 - This level consists of inputs that include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs, other than quoted prices in active markets, that are observable either directly or indirectly.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

Level 3 - This level consists of unobservable inputs in which there is little or no market activity for the asset or liability, which require the reporting entity to develop its own estimates and assumptions relating to the pricing of the asset or liability, including assumptions regarding risk.

During the year ended December 31, 2024, there were no transfers between levels.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Mutual Funds - These are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund on the last day of the Plan's year-end using a quoted price in an active market and are classified within Level 1 of the fair value hierarchy.

Money Market Funds - These assets are valued at cost, which approximates fair value, and classified within Level 1 of the fair value hierarchy.

Common Collective Trust (CCT) - The Plan has a CCT invested in the Federated Capital Preservation Fund (the Fund). CCTs are public investment vehicles valued using the NAV provided by the trustee on the last day of the Plan's year-end. NAV is based on the value of underlying investments, primarily guaranteed investment contracts, synthetic guaranteed investment contracts, short-term securities and mutual funds, minus its liabilities, and then divided by the number of shares outstanding. The CCT provides for daily redemptions by the Plan at reported NAV. There is no restriction in place with respect to the daily redemption of the CCT. Unfunded commitments are not applicable to the Plan and the redemption notice period is 12 months.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Interest income is recorded in the period earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with these investments and the level of uncertainty related to changes in the value of these investments, it is at least reasonably possible that changes in the near term could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation. Annual discretionary employer contributions are recorded in the relevant period in accordance with the terms in the Plan document.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Investment Management Fees and Operating Expenses

Investment management fees and operating expenses charged to the Plan for investments in the various funds are paid by the Companies. Administrative expenses are paid by the Companies or the Plan, as provided by the Plan document.

Payments of Benefits

Benefits are recorded when paid. There were no amounts due to participants who have withdrawn from the Plan but have not been paid as of December 31, 2024 and 2023.

Consideration of Subsequent Events

The Plan sponsor evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through August 29, 2025, the date the financial statements were approved and authorized for issue.

4. Certification of Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Bank of America, N.A., a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

5. Tax Status

The Plan is a non-standardized pre-approved plan document of Bank of America, N.A. The Internal Revenue Service has determined and informed the trustee, by a letter dated June 30, 2020, that the Plan and related trust are acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan has since been amended. However, the plan administrator, the trustee and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes is included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a taxing authority. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments in mutual funds and the common collective trust are managed by the trustee. Additionally, the Plan paid certain administrative fees for trustee and recordkeeping services. Fees paid by the Plan for trustee and recordkeeping services were not significant for the year ended December 31, 2024. These transactions are not, however, considered prohibited transactions under Section 408(b) of ERISA regulations.

The Plan has notes receivable from participants subject to specific guidelines as defined by the Plan document (Note 1). These transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory or administrative exceptions from the IRC and ERISA's rules on prohibited transactions.
