## **Note 1. Description of Plan**

The Fort Wayne Medical Oncology and Hematology, Inc. 401(k) Retirement Plan (the "Plan") is a defined contribution plan for the benefit of the employees of Fort Wayne Medical Oncology & Hematology, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants should refer to the Plan document, which legally governs the operations of the Plan, and is available for more detailed information.

### Eligibility

Employees who have attained 21 years of age and reached 90 days of service are eligible to participate in the Plan by making voluntary contributions and receive the Company's safe harbor match. Entry dates for participant and safe harbor contributions are January 1, April 1, July 1 and October 1.

Employees, who have attained 21 years of age and completed 1 year of service (1,000 hours), are eligible for a discretionary company match. Entry dates for the match contribution are January 1 and July 1. Employees, who have attained 21 years of age, completed one year of service and are employed on the last day of the Plan year, are eligible for a discretionary profit sharing contribution. Entry is immediate once eligibility requirements are met for the profit sharing contribution.

### Contributions

Participants may make voluntary pre-tax and/or Roth contributions of eligible compensation, in whole percentages or dollar amounts, up to the annual limits set by the Internal Revenue Code.

The Company provides a safe harbor contribution equal to 3% of eligible participants' wages. The Company may also make discretionary match and/or profit sharing contributions to eligible participant's accounts.

### Participant Accounts

Each participant's account is credited with the participant's contribution, Company contributions, plus an allocation of Plan earnings and is charged with distributions and an allocation of expenses. Plan earnings and expenses are allocated to participants' accounts on a pro rata basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All amounts in participant accounts are participant-directed.

### Investment Options

Participants may invest their accounts in various mutual funds, portfolio choices, or a fixed interest money market. In addition, the Plan offers a self-directed brokerage choice through Charles Schwab Bank, the Plan's custodian. These funds differ in potential investment return and risk, and may be changed by the Company.

## **Note 1. Description of Plan (Continued)**

### Distributions

Distributions under the Plan are payable when a participant retires, dies, or otherwise ceases to be an employee and are payable in the form of lump-sum or partial withdrawals. Distributions are also allowed when a participant reaches age 59 1/2 or has a qualifying hardship within the Plan.

### Vesting

Participants are immediately vested in their elective (voluntary) and safe harbor contributions. Participants become 33% vested in the Company discretionary contributions after one year of service, 67% vested after two years of service, and 100% vested after three years of service.

### Forfeitures

Participants who terminate from the Plan prior to becoming fully vested must forfeit a percentage of their Company discretionary contributions. These forfeitures are used to reduce Company contributions or pay Plan administrative expenses. At December 31, 2024 and 2023, there was approximately \$0 and \$1,200, respectively, available to pay Plan administrative expenses or reduce future Company contributions. During the year ended December 31, 2024, forfeitures totaling approximately \$1,200 were used to reduce Company contributions or pay Plan administrative expenses.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Prior to May 1, 2013, participants were able to borrow up to the lesser of one-half of their vested account balance or \$50,000. The remaining balance of loans bear interest at prevailing market rates as determined by the Plan administrator at the time the loan was granted and are 9.25% at December 31, 2024. Principal and interest is paid ratably through periodic payroll deductions. Loans must be repaid within five years unless the loan is for a primary residence. The loans are secured by the balance in the participant's account and mature through 2037.

### Termination of the Plan

The Company expressed intention to terminate the plan on May 16, 2025. Upon termination, participants became fully vested in their accounts. See Note 8 for more information.

## **Note 2. Significant Accounting Policies**

### Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting.

### Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### Payment of Benefits

Distributions to participants are recorded when paid.

### Subsequent Events

The Plan administrator has evaluated events and transactions for possible recognition or disclosure through August 18, 2025, the date the financial statements were available to be issued.

## **Note 3. Information Certified by the Plan's Custodian**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the custodian, Charles Schwab Bank, and was not subjected to any auditing procedures performed by the independent public accountants.

Net investment income from the investments and interest from notes receivable from participants, as shown in the accompanying statement of changes in net assets available for benefits, including interest and dividend income and net realized and unrealized appreciation in fair value of investments.

**Note 4. Fair Value Measurements**

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market and mutual funds:* Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year end.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds and common stocks that are valued at quoted market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Transactions with Parties-In-Interest**

The Company provides certain accounting, recordkeeping, and administrative services for the Plan for which it receives no compensation. Administrative expenses for legal, accounting, and other services are rendered by parties-in-interest and are paid by the Company.

The Plan participants direct their investment activity through Charles Schwab Bank. Fees for these services are netted with the net realized and unrealized appreciation in fair value of investments reported on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation in fair value of investments.

**Note 6. Income Tax Status**

The Plan, which is a volume submitter cross-tested 401(k) profit sharing plan and trust, obtained its latest opinion letter on June 30, 2020, stating that the Plan is a qualified plan under Section 401 of the Internal Revenue Code. The Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan sponsor and Plan trustees are not aware of any course of action or series of events that have occurred that would adversely affect the qualified status of the Plan.

**Note 6. Income Tax Status (Continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan trustees have analyzed the tax positions taken by the Plan, and have concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan trustees believe it is no longer subject to income tax examinations for years prior to 2021.

**Note 7. Risks and Uncertainties**

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Subsequent Event**

In January 2025, the Company was sold and all employees were terminated, causing a partial plan termination. At that time, participants became fully vested in any company profit sharing contributions. On May 16, 2025, the trustees of the Plan signed the amendment to terminate the Plan effective June 30, 2025. All balances will be distributed, at the participant's direction.
