Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Edmonson Electric, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Description of the Plan

The following description of the Edmonson Electric, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan’s provisions.

General – The Plan is a defined contribution plan which was originally effective on August 1, 1999. The Plan was amended and restated effective January 1, 2022, to comply with the Internal Revenue Service (“IRS”) regulations for periodic plan restatement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is a single-employer plan and permits the employees of Edmonson Electric, Inc. (“the Company”) to participate in the Plan.

During 2024, the Administrative Committee of the Plan approved a merger of this plan into the IES Holdings, Inc. Retirement Savings Plan, effective December 31, 2024. As a result, all Plan assets were transferred from the Plan into the IES Holdings, Inc. Retirement Savings Plan on that date.

Eligibility – The Plan covers employees of the Company who have completed one year of service and are age twenty-one or older. A year of service is defined by the Plan as a year in which an employee is credited with 1,000 hours of service. The Plan permits for entry dates on the first of the month coinciding with or following the date eligibility requirements are met.

Contributions – Participants may, through salary deferrals, make regular 401(k) contributions up to the maximum allowed under Section 402(g) of the Internal Revenue Code (“IRC”). The Company contributes safe harbor matching contributions of 100% of participants’ salary deferrals up to 3% of their compensation, and 50% of participants’ salary deferrals in excess of 3% and up to 5% of their compensation. The Company may also make discretionary profit-sharing contributions. The Company did not make any discretionary profit-sharing contributions during 2024.

Participant accounts – Each participant’s account is credited and/or reduced with the participant’s contributions and withdrawals, employer safe harbor matching and profit-sharing contributions, allocations of the Plan earnings and losses, and charged with an allocation of administrative fees. Allocations are based on participant earnings, participant elective contributions, or account balances, as defined by the Plan. The benefit to which a participant is entitled is vested balance in the participant’s account.

Vesting – Participants are immediately 100% vested in their contributions and the employer safe harbor contribution plus actual earnings thereon. Participants vest 20% in the Company profit-sharing contributions after 2 years of service and vest 20% each year thereafter until fully vested after 6 years of service.

Payment of benefits – Distribution of a participant's vested account balance to the participant or his or her beneficiary may commence upon the earlier of retirement, death, disability, or separation from service. A participant may elect to receive an amount equal to the value of the vested interest in his or her account in a single lump-sum payment or direct rollover. Distributions are subject to the applicable provisions of the Plan document.

Note 1 – Description of the Plan (Continued)

The Plan allows participants to withdraw amounts from their account balances while actively employed. A participant experiencing financial hardship as defined in the Plan document may, with sufficient evidence, withdraw a portion of their fully vested account. The amount of the withdrawal may not be greater than the immediate financial need. These hardship withdrawals are subject to IRC restrictions and penalties. The Plan also allows for actively employed participants to withdraw from their fully vested account balances once the age of 59 1/2 has been reached.

Note receivables from participants – Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may not have more than one loan outstanding at any given time. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the loan was used to acquire a principal residence, in which case the repayment period may exceed five years. There were no loans outstanding as of December 31, 2024.

Forfeitures – On December 31, 2024, and 2023, forfeited non-vested accounts total approximately \$0 and \$1,000, respectively. These accounts may be used to pay Plan expenses, offset future employer contributions, or reallocated to eligible participants. During the year ended December 31, 2024, no forfeitures were used, and the remaining balance was transferred during the merger.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Note receivables from participants – Notes receivable from participants are recorded at the unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are deemed distributions based upon the terms of the Plan document. Notes are secured by the vested balances in participants' accounts.

Benefits paid to participants – Benefits are recorded when processed and paid by the Plan.

Note 2 – Summary of Significant Accounting Policies (Continued)

Investments, investment valuation, and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value determinations, other than those measured using the net asset value (“NAV”) as a practical expedient, are made based upon a fair value hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date.

Level 2 – Inputs to the valuation methodology are other-than-quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and,

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy:

Pooled separate accounts – These investments are public investment vehicles valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market; however, the investments are in pooled separate accounts through the subaccounts of the trustee and, therefore, are classified within Level 2 of the valuation hierarchy.

Collective trust fund – This investment is an investment vehicle valued using the NAV provided by the administrator of the fund as the practical expedient. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is excluded from the valuation hierarchy consistent with accounting principles generally accepted in the United States.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought, sold, and held during the year.

Administrative expenses – The Company absorbs a significant amount of the costs of Plan administration. Plan recordkeeping and custodial fees paid by the Plan and are reflected in the financial statements as administrative expenses. Expenses related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative fees. Investment management expenses are charged to the Plan as a reduction of investment return.

Note 3 – Information Certified by Trustee

The following is a summary of the Plan’s financial information and data certified by John Hancock Life Insurance Company (U.S.A.) (the “Trustee”) as complete and accurate in accordance with 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Note 5 – Tax Status

The Plan is a pre-approved profit sharing plan (“Pre-Approved Plan”) sponsored by KB Pension Services, Inc., the third-party administrator of the Plan. KB Pension Services Inc. obtained its latest opinion letter dated June 30, 2020, in which the IRS stated the Pre-Approved Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended from the original opinion letter, Plan management believes that the Plan is currently being operated in accordance with the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt. Therefore, no provision of income taxes has been included in the Plan’s financial statements.

Note 6 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Note 7 – Party-in-Interest Transactions

Certain Plan investments are in pooled separate accounts through subaccounts of the trustee and, therefore, the investment transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants. Fees paid during the year for services rendered by parties-in-interest were based on customary and reasonable rates for such services. While these transactions qualify as party-in-interest activity, they are expressly exempted from prohibited transactions rules (ERISA, Title 1, and Section 408(b)).

Note 8 – Subsequent Events

Plan management has evaluated subsequent events through September 8, 2025, in connection with the preparation of these financial statements, which is the date the financial statements were available to be issued.
