1. Description of Plan

The following description of the Nyack Hospital Retirement Savings Plan (the “Plan”) provides general information about the Plan’s provisions. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions, copies of which may be obtained from the Plan Sponsor.

General

The Plan was established by Montefiore Nyack Hospital (“Hospital” or “Plan Sponsor”) on January 1, 1988 as a defined contribution savings plan. The Pension Committee (the “Committee”) is responsible for the general administration of the Plan.

In February of 2018, the Hospital changed its name from Nyack Hospital to Montefiore Nyack Hospital as a result of the Montefiore Health System, Inc. becoming an active parent of the Hospital.

Eligibility

All eligible employees as defined in the Plan document who have completed one year of employment service are eligible for participation. A year of service is defined as a twelve consecutive month period during which an employee is credited with at least 1,000 hours of service. To receive Hospital matching and non-elective contributions, a participant must complete a year of service (1,000 hours) and be employed on the last day of the plan year.

Contributions

Participants may make after-tax contributions of up to 14% of their annual salary, as defined in the Plan agreement. The Hospital makes a matching contribution equal to 100% of the employee’s first 2% of their annual salary and 50% of the employee’s next 2% of their annual salary. The matching contributions are based upon eligible participants’ voluntary contributions as described above. For the year ended December 31, 2024, matching contributions totaled \$949,187. In addition, the Hospital may make a discretionary non-elective contribution. For the 2024 plan year, the Hospital made non-elective contributions to the Plan for eligible participants in the amount of 3% of their annual salary. For the year ended December 31, 2024, non-elective contributions totaled \$1,386,390 of which the Hospital contributed \$1,252,223 due to forfeitures used.

Upon enrollment in the Plan, a participant may direct their contributions in any of the funds offered by the Plan. Employer contributions follow the participants’ allocations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Hospital’s contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. All investments are participant directed.

1. Description of Plan (*continued*)

Vesting

Participants are 100% vested in their contributions plus actual earnings thereon at all times. Vesting in the Hospital's matching contributions and non-elective contributions are based on years of continuous service with the Hospital as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
2 years	25%
3 years	50%
4 years	75%
5 or more years	100%

In addition, a participant will be 100% vested in the Hospital's matching and non-elective contributions if: (1) a participant attains the Plan's normal retirement age of 65; (2) a participant becomes permanently disabled; or (3) a participant dies.

Forfeitures

The Hospital's contributions in which participants are not fully vested are forfeited upon the participant's termination. The Hospital is entitled to offset the discretionary 3% base contribution by the amount of forfeitures made for the preceding period. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$109,533 and \$181,420. During 2024, \$213,345 of forfeitures were used to offset the Hospital's discretionary contributions and no forfeitures were used to reduce Plan expenses.

Expense Budget Account

The Plan and Transamerica Retirement Solutions Corporation ("TRSC") have entered into a revenue sharing arrangement whereby a portion of the revenue earned by TRSC from certain funds is passed through to the Plan for payment of permitted plan expenses or allocation to participants. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses, the Hospital created the Expense Budget Account. The Expense Budget Account is an account within the Plan and is used to record keep the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Expense Budget Account balance was \$97,871 and \$65,331 at December 31, 2024 and 2023. During 2024, \$76,867 was used from the Plan credit account to reduce Plan expenses.

1. Description of Plan *(continued)*

Benefits

Participants are entitled to the total value of their accounts in the form of lump-sum distributions, upon attaining the age of 59-½. There is a 10% excise tax on the taxable amount of any distribution taken before age 59-½. Upon the death of a participant, his or her beneficiaries are entitled to 100% of the total value of the participant's account. Participants suffering total and permanent disability will be considered retired and any amount credited to the participant's account will be distributed to the participant in a lump-sum distribution upon disability. Upon termination of employment, participants are entitled to all vested monies in the Plan.

Expenses

Administrative expenses represent investment management fees paid by the Plan. All other administrative expenses are paid by the Hospital and are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

Notes Receivable from Participants

The Plan offers a loan feature whereby a participant enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of the vested account balance or \$50,000 (whichever is less). A participant may not have more than one outstanding general purpose loan, nor one outstanding residential loan, at one time. The term of a general loan shall not exceed 60 months and the term of a residential loan shall not exceed 180 months. The interest rate to be charged for the term of the loan is determined at the time of issuance of the loan and such rate is determined by the pension committee quarterly.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make certain estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Fair Value Measurements (continued)

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All of the Plan's investments are stated at fair value except for the insurance company general account, which is valued at contract value since it is fully benefit-responsive. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The insurance company general account is valued at contract value, which represents deposits made to the contract, plus interest credited under terms of contract, less withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan will be treated as a deemed taxable distribution but will not offset against the participant account until a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is August 29, 2025.

5. Insurance Company General Account

The TFLIC Insurance Company General Account is benefit-responsive and part of the general assets of TFLIC (its general account). The Plan does not own any underlying securities of TFLIC's general account. The Plan has guaranteed benefits under the terms of the contract. TFLIC is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is determined by TFLIC, but may not be less than the minimum guaranteed rate.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Under the terms of the contract, participants are generally permitted to make distributions or transfers from the investment to non-competing funds at contract value. Certain events allow TFLIC to terminate the contract and settle at an amount different from contract value. Such events may include the following: (a) deposits required under the terms of the contract are not received by TFLIC; or (b) TFLIC determines it can no longer provide benefits under the contract because of a change to the Plan.

The credit risk of TFLIC was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best Company (A since January 2025), Moody's Investors Service (A1 since December of 2024), and S&P Global (A+ since May of 2024).

6. Common/Collective Trust

The Morley Stable Value Fund (the "MSV Fund") is an investment fund offered by Principal Global Investors Trust Company, the trustee of the MSV Fund. Morley Capital Management is the investment advisor of the MSV Fund. The objective of the MSV Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit payments. The MSV Fund consists primarily of a diversified portfolio of stable value investment contracts issued by life insurance companies, banks and other financial institutions, the performance of which may be predicated on underlying fixed income investments. The MSV Fund has no unfunded commitments as of and during the years ended December 31, 2024 and 2023.

The trustee of the MSV Fund determines the NAV each business day (valuation date) by dividing total assets less liabilities by the number of outstanding units. No distributions are made to unitholders as net investment income and net realized capital gains are reinvested into the MSV Fund in accordance with the MSV Fund's investment objectives. Unitholder transactions are processed daily at the current NAV and are considered as made immediately after the daily valuation.

7. Tax Status

The underlying non-standardized prototype plan has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020 stating that the written form of the underlying prototype document is qualified under Section 401(a) of the Internal Revenue Code ("IRC"). The plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

7. Tax Status (*continued*)

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

9. Party-in-Interest Transactions

Certain investments are managed by TFLIC. TFLIC is a custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

TRSC is the record-keeper for the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA.

10. Prohibited Transactions

During the 2023 and 2024 plan years, the Hospital failed to transmit to the Plan certain participants' contributions and loan repayments within the period prescribed by Department of Labor regulations. Delays in remitting these amounts to the Plan were due to an administrative oversight. For the 2023 amounts, the Hospital has made the necessary corrections to satisfy both the Department of Labor and IRS guidance. For the 2024 amounts, the Hospital has made the necessary corrections to satisfy both the Department of Labor and IRS guidance in July of 2025.

11. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
