(a) **General.** The Plan is a defined contribution plan established by Gorman Bros., Inc. for the benefit of employees of Gorman Bros., Inc. and its affiliates: Gorman Asphalt, Ltd. (and its division American Asphalt Distributors), The Cady Co., Inc., Mohawk Asphalt Emulsions, Inc., Gorman Terminals, LLC, and The Gorman Group, LLC (the Companies) which includes a qualified deferred arrangement as described in section 401(k) of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan is for the benefit of all full-time employees of the Companies who have completed one year of service and are age 19 or older. In addition, the Plan will allow any employee who has not attained age 19 and completed one year of service to commence participation if a contribution pursuant to Section 220 of the New York Labor Law is made on their behalf.

The Plan sponsor Gorman Bros., Inc and all its affiliates participated in an asset sale on February 2, 2024, and ceased all business activity. It is the sponsor's intention to terminate the Plan once all assets have been distributed to beneficiaries of the Plan. All participants on January 1, 2024, shall be 100% vested in their account balance.

(b) **Effective date.** The plan became effective on December 28, 1973, and was amended and restated effective as of January 1, 2016. This restatement was made to conform the Plan to new tax laws.

(c) **Contributions – Employer.** Each year, the Companies may contribute an amount by resolution of the Board of Directors. The Company may contribute a discretionary contribution (matching) based on a participant's salary deferred contribution. There were matching contributions for the year ended December 31, 2023.

(d) **Contributions – Employees.** Each year, participants may contribute the lesser of \$23,000 or 100% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Note 1 - **Description of Plan (Continued):**

- (e) **Participant's Accounts.** Each participant's account is credited with the participant's salary reduction contribution, the Company's matching and discretionary contributions, plan earnings, charged with an allocation of administrative expenses and realized and unrealized security gains and losses. The benefit to which a participant is entitled is that which can be provided from the participant's account.
- (f) **Vesting.** Participants are immediately vested in their salary reduction plus actual earnings thereon. Vesting in the employer matching contribution portion of their accounts plus actual earnings thereon is based on continuous service. A participant is 100% vested after six years of credited service.
- (g) **Investment Options.** The Plan provides for participant-directed investment programs as it allows participants to choose among various investment alternatives.
- (h) **Participant Notes Receivable.** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% (fifty percent) of their vested account balance, whichever is less. Loan terms range up to five years. Terms of loans for the purpose of purchasing a principal residence are determined by the Plan Administrator. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. The interest rate for the participant loans range between 4.25% and 9.50%. Principal and interest is paid ratably through payroll deduction.
- (i) **Payment of Benefits.** The Trust shall make or begin distribution of the benefits payable on a participant's (a) retirement after attaining his retirement date, or (b) sustaining total and permanent disability, or (c) death, based upon the balance in such participant's account as of the valuation date coinciding with or immediately preceding the date on which such participant retires, dies or becomes disabled. If a participant terminates his service before retirement date, payment will be made in accord with the plan document based upon the elections available.

- (j) **Forfeitures.** When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are utilized to reduce the sponsor contributions for the plan year. At December 31, 2023, forfeitures available to be used to reduce employer contributions were \$299,600.

Note 2 - **Summary of Accounting Policies:**

- a) **Basis of Accounting.** The Plan was terminated on March 31, 2024, as a standard termination and has changed its basis of accounting from the ongoing (accrual) basis, used in presenting the 2023 financial statements, to the liquidation basis used in presenting the 2024 financial statements. The November 30, 2024, financial statements includes accrued income and expenses expected to be earned and incurred through the end of its liquidation.
- b) **Investment Valuation and Income Recognition.** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

- c) **Participant Notes Receivable.** Notes receivable from participants are measured at their unpaid principal balance. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.
- d) **Payment of Benefits.** Benefits are recorded when paid.
- e) **Use of Estimates.** Management uses estimates and assumptions in preparing these financial statements in accordance with accounting principals generally accepted in the United States of America. These estimates and assumptions affect the reported amounts of assets and liabilities, and changes therein, the disclosure of contingent assets and liabilities, and the reported revenues and expenses. Actual results could differ from those estimates.

- f) **Subsequent Events.** The Plan evaluated its November 30, 2024, financial statements for subsequent events through September 11, 2025, which is the date the financial statements were available to be issued and noted no events occurring subsequent to November 30, 2024 and through the date of our evaluation requiring accrual or disclosure in these financial statements.
- g) **Tax Status.** The Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U. S. federal tax authorities. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of November 30, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 4 - **Fair Value Measurements:**

FASB ASC 820, Fair Value Measurement and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by the observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at November 30, 2024, and December 31, 2023.

Self-directed accounts: Accounts primarily consist of mutual funds, and collective investment trust that are valued on the basis of readily determinable market prices.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's investments are reported at fair value in the accompanying statement of financial position.
