Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Elgin Academy Defined Contribution Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits in liquidation as of November 30, 2024, the statement of net assets available for benefits as of December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits in liquidation for the period from January 1, 2024 to November 30, 2024 and the related statement of changes in net assets available for benefits for the for year ended December 31, 2023 (ongoing) , and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Elgin Academy Defined Contribution Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 30, 2024 and December 31, 2023 and for the period from January 1, 2024 to November 30, 2024 and for the year ended December 31, 2023, stating that the certified investment information as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities For The Audit Of The Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis For Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities For The Audit Of The Financial Statements section of our report. We are required to be independent of Elgin Academy Defined Contribution Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Terminating Plan And Liquidation Basis Of Accounting

As discussed in Note 1 to the financial statements, the Board of Trustees of Elgin Academy approved a plan of liquidation on May 13, 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the ongoing basis of accounting used in presenting the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Also as described in Note 1, pursuant to the Plan's termination, the net assets of the Plan were fully distributed as of November 30, 2024. Our opinion is not modified with respect to these matters.

Responsibilities Of Management For The Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities For The Audit Of The Financial Statements

Except as described in the Scope And Nature Of The ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with auditing standards generally accepted in the United States of America, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Elgin Academy Defined Contribution Retirement Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS November 30, 2024 And December 31, 2023

1. Description Of The Plan

The following description of the Elgin Academy Defined Contribution Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan sponsored by Elgin Academy (the School or Employer) for the benefit of its employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Teachers Insurance And Annuity Association (TIAA) served as the issuer of various annuity contracts held by the Plan and was the recordkeeper of the Plan.

On May 13, 2024, the Board of Trustees at Elgin Academy adopted a resolution to terminate the Plan as of July 8, 2024. The Plan continued operations through July 8, 2024 at which time it was terminated. Participants became 100% vested in their accounts on the termination date, and were required to take a distribution of their accounts. The accounts of any missing, unknown or unresponsive Plan participants were rolled over into an individual retirement account established for the Plan participant's benefit. As of November 30, 2024, all Plan assets have been distributed to Plan participants based on their preferred distribution option (lump sum, rollover or individually-owned annuity accounts). Approximately \$4.2 million of Plan assets were distributed to Plan participants through lump sum and rollover methods. The remaining \$8.4 million of Plan assets were deemed distributed as individually-owned annuity accounts.

Eligibility

Employees were immediately eligible to participate in the Plan as a contributing participant upon commencement of employment with the School. Students who were employed by the School, employees who normally worked less than 20 hours per week and certain other employees were generally excluded from participation in the Plan.

Contributions

The Plan permitted eligible employees through a salary deferral election to have the employee make annual contributions of up to 100% of eligible pretax compensation.

Notes To Financial Statements (*Continued*)

Participants who attained age 50 before the end of a Plan year were eligible to make catch-up contributions. Participants were also able to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan allowed for special code section 403(b) catch-up contributions for those participants with 15 years of service. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

The School contributed 2% of eligible compensation provided that the participant deferral election equaled or exceeded 1%.

Participant Investment Account Options

Investment account options available included variable annuity accounts, mutual funds and guaranteed investment accounts. Each participant had the option of directing their deferrals, rollover and employer contributions into any of the investment account options selected by the School, and could change the allocation to the extent permitted by the individual agreements.

Notes Receivable From Participants

Participants were permitted to borrow from their account a minimum of \$1,000, up to a maximum aggregate amount equal to the lesser of \$50,000 or 50% of the total value of the participant's vested account balance (Notes Receivable From Participants). Only Two loans were allowed to be outstanding to a participant at any one time. Loans were for a period not exceeding five years. The loans were secured by the balance in the participant's account. The loan interest rate was set at 1% above the prime rate. Principal and interest were paid ratably through payroll deductions.

Vesting

Participants were immediately vested in their voluntary contributions, any employer contributions, and actual earnings (losses) thereon.

Participant Accounts

Each participant's account was credited with the participant's contributions, the employer's contributions and allocations of Plan earnings and charged with withdrawals, an allocation of Plan losses and administrative expenses. Allocations were based on participant earnings (losses) or account balances, as defined. The benefits to which a participant is entitled was the benefit that was able to be provided from the participant's vested account.

Notes To Financial Statements (*Continued*)

Benefits

Amounts in a participant's account and earnings or losses thereon were distributed upon retirement, death, disability or other termination of employment. The form of retirement benefit payments were either a lump-sum payment, partial or installment payments or the purchase of an annuity.

Prior to termination, a participant was permitted to withdraw all or any portion of their vested account balance if the participant had attained age 59½ or the participant had demonstrated financial hardship, subject to the Plan's provisions. A participant was also allowed to withdraw all or any portion of their rollover contributions as an in-service distribution at any time.

Administrative Expenses

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the School.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

Due to the Plan's termination, management determined that liquidation of the Plan is imminent and the financial statements for 2024 have been prepared using the liquidation basis of accounting. Under the liquidation basis of accounting, assets are measured at the expected cash proceeds from liquidation and liabilities are measured in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) that otherwise apply to those liabilities. The 2023 financial statements were prepared on the accrual basis of accounting, except for claims payments, which are recorded when paid.

Estimates And Assumptions

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

The Plan's investments, other than fully benefit-responsive investment contracts, are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Investment contracts held by a defined contribution plan are generally reported at contract value except for those contracts that are non-fully benefit-responsive. In that instance, these contracts are required to be reported at fair value. A portion of the Plan's investment in the TIAA Traditional Annuity account is not a fully benefit-responsive investment contract and is reported at fair value in the statement of net assets available for benefits. The remainder of the balance in the TIAA Traditional Annuity and the investment in the TIAA Stable Value investment are fully-benefit responsive and have been reported at contract value in the statement of net assets available for benefits.

Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade date basis. Net change in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year and includes any realized gains and losses in securities that were bought and sold during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluates subsequent events through the date financial statements were available for issue, which is the date of the Independent Auditors' Report.

3. Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments held at November 30 2024 and December 31, 2023, and net change in fair value of investments and interest and dividends for the periods then ended, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Teachers Insurance And Annuity Association and College Retirement Equities Fund (TIAA-CREF). This information has not been audited by the Plan's independent auditors.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedules related to the following assets as of November 30, 2024 and December 31, 2023:

Guaranteed Investment Contracts

The Plan offers as investment options the TIAA Stable Value and the TIAA Traditional Annuity. The TIAA Traditional Annuity is offered through a variety of contract types, including: the Group Retirement Annuity (GRA); Retirement Choice Annuity (RC); Group Supplemental Retirement Annuity (GSRA); Supplemental Retirement Annuity (SRA); and the Retirement Choice Plus Annuity (RCP).

The TIAA Traditional Annuity and the TIAA Stable Value (collectively, the Annuities) are fixed-dollar annuity and investment products offered by TIAA, an insurance company. The Annuities are maintained in the TIAA general account. Contributions to one of the Annuities purchases a contractual or guaranteed amount of future benefits for the participants and are secured by the general assets of TIAA.

Group Retirement Annuity And Retirement Choice Annuity

The GRA and RC are not fully benefit-responsive and reported at fair value, which approximates contract value as estimated by TIAA. The GRA and RC contain liquidity restrictions where lump-sum withdrawals are permitted within 120 days following termination of employment, are subject to a 2.5% surrender charge, and contain certain limitations on the number of periodic installment payments.

Group Supplemental Retirement Annuity, Supplemental Retirement Annuity, And Retirement Choice Plus Annuity

The GSRA, SRA and RCP are fully benefit-responsive and are reported at contract value. The contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers, if any, less any withdrawals and transfers, if any.

The GSRA and SRA provide a guarantee of principal, a guaranteed minimum rate of interest of 3% and the potential for additional interest, if declared by TIAA. The RCP provides a guarantee of principal, a guaranteed minimum rate of interest between 1% to 3% re-determined annually each March 1, and the potential for additional interest, if declared by TIAA. Additional interest, when declared, remains in effect for the "declaration year," which begins each March 1. Additional interest is not guaranteed for future years. The crediting rate is supported by the investment performance of a large, diversified portfolio, is correlated with the highest quality debt security yields, and is adjusted for contract liquidity.

TIAA Stable Value

The TIAA Stable Value is fully benefit-responsive and reported at contract value. The contract value equals the accumulated cash contributions, interest credited to the Plan's contracts, and transfers, if any, less any withdrawals and transfers, if any.

The TIAA Stable Value provides a guarantee of principal, a guaranteed minimum rate of interest between 1% to 3% re-determined annually each March 1, and the potential for additional interest, if declared by TIAA. Additional interest, when declared, remains in effect for the “declaration year,” which begins each March 1. Additional interest is not guaranteed for future years. The crediting rate is supported by the investment performance of a large, diversified portfolio, is correlated with the highest quality debt security yields, and is adjusted for contract liquidity.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Guaranteed Investment Accounts

Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable Annuity Accounts

Certain variable annuity accounts are valued at the daily closing price as reported by the investment. These variable annuity accounts held by the Plan are open-end registered investment companies that are registered with the Securities and Exchange Commission. These investments are required to publish their daily NAV and to transact at that price. These variable annuity accounts held by the Plan are deemed to be actively traded.

The remainder of the variable annuity accounts are valued at the NAV of units held by the Plan at year-end. The individual variable annuity accounts are comprised, primarily, of shares of registered investment companies held through subaccounts of a separate account of an insurance company at December 31, 2023. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company approximates fair value of the investments. The investments are redeemable daily at the adjusted NAV under agreements with the insurance company. However, it is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in the market conditions, liquidity requirements, and the economic environment may significantly affect the NAV of the variable annuity accounts and, consequently, the fair value of the Plan's investments.

The Plan held no assets at November 30, 2024.

5. Income Tax Status

The School adopted a volume submitter 403(b) plan (the Volume Submitter Plan) sponsored by TIAA. The IRS has determined and informed the Volume Submitter Plan sponsor by a favorable opinion letter dated August 7, 2017, that the Volume Submitter Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Volume Submitter Plan's opinion letter is being relied on by the Plan. Although the Plan has been amended since receiving the opinion letter, Plan management believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and as such is exempt from Federal income taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

6. Party In Interest Transactions

Certain Plan investments were managed by entities related to TIAA-CREF. The related transactions qualified as allowable party in interest transactions.

Certain employees had outstanding loans with the Plan as of December 31, 2023. These loans were considered party in interest transactions allowable under ERISA.

7. Risks And Uncertainties

The Plan invested in various investment securities, which in general were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
