Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the WC Enterprises, Inc. 401(k) Profit Sharing Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of November 15, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the period and year then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the period ended November 15, 2024 and year ended December 31, 2023, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Opinion

Note 1 – Description of Plan and Significant Accounting Policies

The following brief description of the WC Enterprises, Inc. 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established under Section 401(a) of the Internal Revenue Code of 1986 (the Code), including a 401(k) salary reduction provision, covering all employees of WC Enterprises, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective November 15, 2024, WC Enterprises, Inc. 401(k) Profit Sharing Plan & Trust was merged into the Secure Future Pooled Employer Plan (PEP) in accordance with the provisions of the SECURE Act and applicable IRS and DOL regulations. All assets, participant account balances and plan obligations were transferred to the PEP which is administered by Secure Future.

Eligibility

For salary deferrals and transfers from other qualified plans, a participant becomes eligible on the first day of the month after the employee has completed at least 3 months of service and has attained age 18.

Contributions

Participants may elect to defer up to 92% of annual earnings, as defined in the Plan, subject to the maximum amount allowable by the Internal Revenue Service per year. The Company permits participants to make Roth 401(k) deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. For 2024 and 2023, the Company's matching contribution was 50% of participants' contributions, not to exceed 4% of the participants' compensation. There was no additional profit sharing contribution made for 2024 or 2023.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Participant Accounts

Each participant's account is credited (charged) with their individual contribution and an allocation of: (a) the Company's contributions, (b) Plan earnings (losses), and (c) charged with an allocation of any administrative expenses paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Each participant directs the trustee to invest his or her funds in the investment options established under the Plan. During 2024, there were \$46,028 in Company matching contributions and \$122,067 in employee contributions. During 2023, there were \$54,476 in Company matching contributions and \$145,701 in employee contributions.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the participants' accounts for employer contributions is based on years of continuous service. A participant vests in equal increments between their second and sixth years of service on their portion of employer contributions and the earnings (losses) on those contributions.

Plan Expenses

Certain administrative fees shall be paid by the Plan, as described in the Plan document. The Company pays for a portion of the professional service fees associated with the Plan. The services are provided by parties-in-interest to the Plan.

Payment of Benefits

Participants become eligible to withdraw from their accounts upon retirement, disability, death, termination, or as otherwise defined in the Plan document. Such withdrawals are paid in lump sum or installment payments equal to the vested value of the participant's account. Upon meeting certain other qualifications, participants may also be eligible for in-service distributions and hardship distributions.

Forfeitures

At November 15, 2024 and December 31, 2023, forfeited non-vested accounts totaled \$0 and \$7,655, respectively. Terminated participants' non-vested account balances are used to reduce future employer contributions or for Plan expenses. There were no forfeitures used to reduce employer contributions or Plan expenses during 2024 or 2023.

Notes Receivable from Participants

Participants may borrow up to 50% of their vested participant account balance, in amounts of \$1,000 to \$50,000. Participant loans are secured by the balance in the participant's account and bear interest at rates that are determined at the time of borrowing, which are commensurate with local prevailing rates, as determined periodically by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions. The interest rates charged during 2024 were between 4.25% and 9.50%.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. At November 15, 2024 and December 31, 2023, there were \$0 and \$3,013, respectively, in outstanding notes receivable from participants.

Use of Management's Estimates

The preparation of financial statements in conformity with generally accepted accounting principles (GAAP) require the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Subsequent Events

The Plan has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.

Note 2 – Information Prepared and Certified by Trustee

The trustee of the Plan Advisor Trust, Inc., holds the Plan's investments and execute all investment transactions. The related financial information included in the accompanying financial statements and schedule is based solely on information provided by the trustees. Note 3 – Tax Status

The IRS has determined and informed the Company by a letter dated January 15, 2021 that the prototype plan is designed with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain tax position that more likely than not would not be sustained by examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 – Related-Party Transactions and Party-in-Interest Transactions

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through a revenue sharing, rather than a direct payment.

Note 5 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date;

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability; and

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at November 15, 2024 and December 31, 2023.

- *Mutual funds:* Valued at the net asset value (NAV) of shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the period ended November 15, 2024 and year ended December 31, 2023, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.
