Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1. Plan Description

The following description of the Direct Travel 401(k) Plan (the “Plan”), effective December 1, 1997 and subsequently amended and restated July 28, 2022, provides only general information. Participants and all others should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of Direct Travel, Inc. (the “Company”) who are age 18 years or older and who have completed one consecutive month of employment, excluding union and leased employees. The entry date for eligible participants is on the first day of the month following or coinciding with obtaining eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Trustee and Administration of the Plan

The trustee of the Plan was Reliance Trust Company (the “Trustee”). The administrator of the Plan is the Company. The Trustee holds the assets of the Plan in accordance with the service provider contract with the Company. The investment committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 75 percent of annual eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Elective contributions may be designated as pre-tax or after-tax Roth 401(k) contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the Internal Revenue Service (IRS).

Newly eligible employees who do not affirmatively elect to have a specific deferral percentage contributed or opt out of deferring into the Plan will automatically have 3 percent of their annual eligible compensation deferred into the Plan. Employee contributions to the Plan are made through regular payroll deductions.

The Company may elect to make discretionary matching contributions on behalf of employees based on a defined percentage of the employees' eligible compensation, as determined by the Board of Directors. The Company has the right to designate all or a portion of the matching contributions as qualified. Matching contributions are funded each pay period. To the extent discretionary matching contributions are so designated, they are nonforfeitable and may not be withdrawn from the Plan prior to separation from service or attainment of age 59 ½. The Company made discretionary matching contributions equal to 50.0 percent of the first 5.0 percent of each participant's eligible compensation up to a maximum of 2.5 percent of the participant's eligible compensation during the year ended November 30, 2024. The discretionary matching contributions were \$1,851,443, net of forfeitures applied of \$26,474, for the year ended November 30, 2024.

The Company may also elect to make discretionary profit-sharing contributions on behalf of the employees for a Plan year. There were no profit-sharing contributions made during 2024 or 2023.

Note 1. Plan Description (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings, and charged with plan losses and an allocation of the administrative expenses. Allocations are based on the participants' compensation of account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balance into various investment options offered by the Plan.

Benefit Payments

On termination of service due to death, disability, or retirement a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the Plan document. The Plan administrator must approve any such hardship withdrawals.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon.

The employer's discretionary matching and profit-sharing contributions, if any, vest according to the following schedule:

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures can be used to reduce future company contributions or to pay administrative expenses of the Plan. At November 30, 2024 and 2023, forfeited account balances totaled \$59,084 and \$24,935 respectively.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Notes to Financial Statements

Note 1. Plan Description (continued)

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. Participants may have a maximum of two loans outstanding at any given time. The notes receivable are secured by the balance in the participant's account and bear interest at rates that are commensurate with prevailing rates ranging from 3.25 percent to 10.50 percent, as determined monthly by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions and mature at various dates through March 2038. Loans in the amount of \$35,773 were deemed a distribution in the current year.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The money market fund is valued at fair value based on quoted market prices. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

The net realized and unrealized investment gain or loss (net appreciation or depreciation in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are recognized on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company. In addition, fees related to the processing of certain participant-directed transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net depreciation of fair value of investments.

Note 2. Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 3. Information Certified by Reliance Trust Company

The Plan administrator has elected the method of annual reporting permitted by ERISA and accordingly, Trustee, a qualified institution, has certified that the following investment and participant notes receivable information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and participant loans as shown in the accompanying Statements of Net Assets Available for Benefits as of November 30, 2024 and 2023,
- Investment income as shown in the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended November 30, 2024.
- Investment information included in the Schedule of Assets (Held at End of Year) as of November 30, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of generally accepted accounting standards, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule is in conformity with the Department of Labor's rules and regulations for reporting and disclosure under ERISA.

Note 4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Note 4. Fair Value Measurements (continued)

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 5. Tax Status

The Plan is a pre-approved plan. The pre-approved plan has most recently received a favorable opinion letter dated October 6, 2020 from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

The Plan is required to operate in conformity with the Internal Revenue Service Code (the Code) to maintain its tax qualification. The Plan has been amended since receiving the most recent determination letter; however, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. As such, the Plan administrator believes the Plan continues to be qualified for federal income tax-exempt status.

Generally accepted accounting standards require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Plan Mergers

In February 2024, Blue Ribbon Business Travel 401(k) Profit Sharing Plan was merged with the Plan. Accordingly, assets of approximately \$2.9 million were transferred into the Plan.

Note 7. Exempt Party-in-Interest and Related Party Transactions

ADP Retirement Services is the Plan's recordkeeper and, accordingly transactions with ADP Retirement Services qualify as party-in-interest transactions that are exempt from the prohibited transaction rules. For the year ended November 30, 2024, fees in the amount of \$83,394 were paid to ADP Retirement Services.

Morgan Stanley Smith Barney LLC had an agreement with the Plan to provide investment-consulting services and accordingly transactions with Morgan Stanley Smith Barney LLC qualify as party-in-interest transactions that are exempt from the prohibited transaction rules. In June 2024, the Plan entered into an investment-consulting services agreement with Wells Fargo Advisors to effectively replace Morgan Stanley Smith Barney LLC. Transactions with Wells Fargo Advisors qualify as party-in-interest transactions that are exempt from the prohibited transaction rules. During the year ended November 30, 2024, advisory fees of \$101,836 and \$72,855 were paid to Morgan Stanley Smith Barney LLC and Wells Fargo Advisors, respectively.

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules and are exempt from the prohibited transaction rules. These transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 8. Subsequent Events

The financial statements and related disclosures include the evaluation of events up through and including September 12, 2025, which is the date the financial statements were available to be issued.

In January 2025, portions of the Universal Travel Services 401(k) Profit Sharing Plan and Singer Equipment Co., Inc. 401(k) Retirement Plan were merged with the Plan. Accordingly, aggregate assets of approximately \$2.3 million were transferred into the Plan during 2025.

The Company in its capacity as Plan administrator appointed ADP Retirement Trust Services, LLC as the Plan's Trustee upon resignation of Reliance Trust Company on December 31, 2024.

In September 2025, the Plan was amended to change the fiscal year end from November 30th to December 31st. The change will be effective for Plan year 2025.
