Report on the Financial Statements



NOTE 1 DESCRIPTION OF PLAN

The following description of Clinicare Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a qualified defined contribution retirement plan sponsored by related entities through common ownership, Clinicare Corporation, Crossroads Academy, LLC, Aurora Plains Academy, LLC and Auburn Lake Academy Corporation (collectively, the Sponsors, Employers, or Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Sponsors are the Plan administrator. John Hancock Life Insurance Company (U.S.A.) (John Hancock) is the insurance company of the Plan's assets. Members of management of the Sponsors are trustees of the Plan and are responsible for the administration and oversight of the Plan. MAP Retirement is the third-party administrator of the Plan. The investment advisor, Willshire Associates, Inc. is a co-fiduciary charged with the responsibility of advising the trustees on investment policy, providing performance analysis and monitoring services.

Eligibility

Prior to July 1, 2023, employees of the Sponsors are eligible to participate in the Plan upon the completion of 1,000 hours, one-year of service, and attainment of age 21 on a qualifying entry date. Effective July 1, 2023, employees of the Sponsors are eligible to participate in the Plan upon completion of 500 hours, six months of service, and attainment of age 21 on a qualifying entry date. Eligible employees become participants in the Plan on January 1, April 1, July 1, or October 1, coincident with or immediately following the attainment of these requirements.

Contributions

Participants may contribute up to 100% of their compensation, as defined, not to exceed the limits of the Internal Revenue Code (IRC). Unless elected otherwise, the Plan has implemented automatic enrollment for all eligible employees at a rate of 3%. The Plan allows participants to rollover distributions from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Sponsors may make discretionary matching contributions and qualified nonelective contributions to the Plan. The Sponsors made a discretionary matching contribution of 100% of the participant's contributions to the Plan up to 3% of contributions for the years ended December 31, 2024 and 2023. During 2024 and 2023, the Sponsors did not make a qualified nonelective contribution to the Plan.

Participant Accounts

Individual accounts are maintained for each participant of the Plan. These accounts reflect the participant's contributions and related Employers contributions as well as the participant's share of the Plan's investment income and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and any Sponsor qualified nonelective contributions plus actual earnings thereon. Vesting in the Sponsor's matching contribution portion of their accounts, plus actual earnings thereon, is based on years of credited service. A participant is 100% vested after three years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their account balance the lesser of \$50,000 or one-half of the participant's vested account balance. Loans to participants are treated as a separate investment of the participant and all principal and interest payments on loan balances are credited to the participant account from which the loan was made. The loans are secured by the vested balance in the participant's account and are repaid over various terms. Principal and interest is paid ratably through bi-weekly payroll deductions.

Benefit Payments

Benefits are paid to the participant or beneficiary upon death, disability, hardship, retirement, or termination of employment, up to the amount of the participant's account. Benefits may be paid in a lump sum distribution, installment distribution or an annuity. Once a participant has reached the age of 59½, distributions may be made, at the participant's election, from any accounts which are 100% vested.

Forfeited Accounts

Forfeitures are portions of account balances that participants surrender by terminating employment prior to becoming fully vested. Forfeitures of nonvested Sponsors' contributions are generally used to reduce the Sponsors' matching contribution but may also be used to reduce the Sponsors' qualified nonelective contributions or offset Plan expenses. The balance in the forfeiture account at December 31, 2024 and 2023 was \$489 and \$305, respectively. There were \$3,223 and \$12,760 of forfeitures used to offset Sponsor contributions for the years ended December 31, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Cash

Cash is held in a noninterest bearing account.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expense. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The excess contributions of \$25,098 and \$22,913 were distributed by the Plan to the applicable participants prior to March 15, 2025 and 2024, respectively. The 2024 and 2023 employee contributions are net of the excess contributions.

Subsequent Events

The Plan has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

John Hancock Life Insurance Company (U.S.A.), the qualified institution of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts – Valued at the net asset value (NAV) of units held by the Plan at year-end. The NAV, as provided by the administrator of the fund, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund, minus its liabilities, and then divided by the number of units outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The pooled separate accounts are available under the Sponsor's group annuity contract issued by John Hancock. The pooled separate accounts are invested solely in shares of an underlying mutual fund, collective trust or exchange traded fund.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their Company contributions.

NOTE 7 PLAN TAX STATUS

The Company adopted a volume submitter profit-sharing plan with a cash or deferral arrangement which received a letter from the Internal Revenue Service (IRS) stating that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are pooled separate accounts administered by John Hancock, a qualified institution of the Plan and, therefore, the investment transactions qualify as party-in-interest transactions. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Certain employees and officers of the Sponsor, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan.
