Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of eGenesis, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. 1. Description of Plan

The following description of the eGenesis, Inc. 401(k) Plan (the Plan) provides only general information. Plan participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of eGenesis, Inc. and Huckleberry Farms, LLC (the Company) that have attained 21 years of age, excluding cleaning staff and interns. Employees are allowed to enter the Plan for participant and employer matching contributions immediately once eligible. The Plan was originally established on January 1, 2019. The Plan was most recently amended effective August 2023, in which the Plan adopted a new pre-approved plan that included insignificant changes. The Plan Administrator is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

The Plan is subject to the provisions of the Internal Revenue Code of 1986 (IRC) and the Employee Retirement Income Security Act of 1974 (ERISA).

Setting Every Community Up for Retirement Enhancement (SECURE) Act and SECURE 2.0 Act

The SECURE Act and the SECURE 2.0 Act had various provisions in effect during the year ended December 31, 2024. The most significant change required including long-term part-time (LTPT) employees who attained 500 or more hours of service in three consecutive 12-month eligibility computation periods beginning in 2021 as eligible employees for participant contributions. The Plan is required to be formally amended on or before December 31, 2025 for the SECURE Act and on or before December 31, 2026 for the SECURE 2.0 Act.

Contributions

Each year, participants may contribute pre-tax, Roth, and catch-up contributions to the Plan up to 100% of their eligible compensation, as defined. Participants that have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the applicable participant. Employees have the option to opt out of automatic enrollment or change their elective deferral percentages at any time.

The Plan provides for the Company to make discretionary employer matching contributions to employees over the age of 21, excluding cleaning staff and interns. The formula for the discretionary employer matching contribution, if any, is solely determined by the Company. During the years ended December 31, 2024 and 2023, the Plan made discretionary employer matching contributions for eligible participants. During the year ended December 31, 2024, the Plan matched 100% of eligible compensation that was contributed to the Plan by each participant, limited to \$1,000 annually. During the year ended December 31, 2023, the Plan matched 100% of the first 3% of eligible compensation that was contributed to the Plan by each participant, limited to \$1,000 annually. The contribution computation period for discretionary employer matching contributions is the plan year. During the year ended December 31, 2024, discretionary employer matching contributions totaled \$91,975 and was received by the Plan on or before December 31, 2024. As of December 31, 2023, \$4,849 in discretionary employer matching contributions was receivable to the Plan, which was funded to the Plan during the year ended December 31, 2024.

Contributions...continued

The Plan also provides for discretionary profit-sharing contributions to participants who are employed on the last day of the plan year, unless terminated after reaching normal retirement age (65), death, or disability. The Company elected not to make discretionary profit-sharing contributions for the year ended December 31, 2024.

All contributions and compensation are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary employer matching and profit-sharing contributions, and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note Receivable from Participant

The Plan permits its participants to obtain loans against their account balances, excluding Roth deferral accounts. A plan participant may borrow from his or her vested account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000, reduced by the highest outstanding balance in the last 12 months, or 50% of his or her vested account balance. Notes receivable from participants bear interest at the Wall Street Journal prime rate plus 1% at the date the loan application was processed (8.50% as of December 31, 2024). Participants may only have one loan outstanding at any given time. All loans must be repaid in level payments through payroll deductions for actively employed participants on at least a quarterly basis over a period of no more than 5 years with the exception of loans used to purchase a primary residence. Upon termination of employment, any remaining payments are due within 60 days after termination unless transferred or rolled out of the Plan. Repayments may be suspended for 12 months for a bona fide leave of absence and for the entire time the borrower is on qualified military leave. Loans may not be refinanced. The Plan Administrator shall consider a loan in default if any scheduled payment remains unpaid as of the last business day of the calendar quarter in which a loan is initially considered past due. Any unpaid balance at the time of default shall incur a 10% penalty if the participant is under the age of 59 ½. As of December 31, 2024, the rate of interest on the outstanding note receivable from a participant is 9.50% maturing in 2025. As of December 31, 2023, there were no notes receivable from participants. Certain other restrictions may apply to notes receivable from participants as defined in the plan document.

Vesting

Participants are immediately 100% vested in all contribution sources, plus earnings thereon.

Forfeitures

As of December 31, 2024 and 2023, forfeited accounts totaled \$5,459 and \$811, respectively. Forfeitures during the year ended December 31, 2024 represent corrective actions by management resulting in forfeitures of funds from participant accounts, which may be used to reduce future employer contributions. During the year ended December 31, 2024, \$13,053 of forfeited accounts were used to reduce the funding of discretionary employer matching contributions.

Payment of Benefits

Withdrawals may be made from a participant's account if still employed by the Company at age 59 ½, death, disability, or termination of employment. A participant's vested account shall be distributed to the participant (or to the participant's beneficiary in the event of the participant's death) in the form of cash in a single lump-sum payment or partial withdrawals. If a participant terminates service, the entire vested amount in his or her account may be distributed or rolled over into another qualified plan, as directed by the participant. Participants who are eligible for a hardship withdrawal may elect to withdraw all or a portion of their elective deferral account. Participants are entitled to receive a distribution from their rollover contribution account at any time. The Plan Administrator can elect to distribute funds out of the Plan when a participant terminates employment and has a vested balance in the Plan of less than \$5,000. Distribution shall be made to an eligible participant from his or her vested account as soon as reasonably practicable following the date the participant's application for distribution is received by the Plan Administrator, but in no event later than the participant's attainment of age 73.

All distributions are subject to the applicable provisions of the Plan.

Investment Elections

Each participant shall direct the investment of his or her account and shall elect among various mutual funds. Each participant has the ability to change his or her investment allocations at any time.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting. The financial statements have been prepared in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets generally accepted accounting principles in the United States of America (GAAP) to ensure net assets available for benefits and changes in net assets available for benefits are consistently reported. References to GAAP issued by the FASB in these notes are to the FASB Accounting Standards Codification (ASC).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by investment advisers and the trustees. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. As of December 31, 2024, accrued, but unpaid interest has been deemed insignificant to the Plan. Interest from notes receivable from participants is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the note receivable from the participant to be a distribution, the notes receivable from participants balance is reduced and a benefit payment is recorded within the statement of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. For the year ended December 31, 2024, the Company paid certain other administrative expenses incurred by the Plan.

3. Fair Value Measurements

The Plan discloses the fair value of investments in accordance with FASB ASC Topic No. 820, *Fair Value Measurements* (ASC 820). The framework under ASC 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means; or
 - If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds - Valued at the daily closing price as reported by each mutual fund. Mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission, which are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Information Prepared and Certified by Plan's Trustees

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustees of the Plan, Ascensus Trust Company and Newport Trust Company LLC, have certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 and the related investment and notes receivable from participants activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

5. Tax Status

The Plan has adopted a pre-approved plan in which the IRS determined, by an opinion letter dated June 30, 2020 (effective April 15, 2021), that the Plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become fully vested in their accounts.

7. Party-in-Interest Transactions

Certain investments of the Plan are funds managed by The Vanguard Group, Inc., which qualify as party-in-interest transactions as that term is defined in Section 3(14) of ERISA. In addition, the Plan issued a note receivable to a participant, which is secured by the balance in the participant's account and constitutes a party-in-interest transaction.

8. Risk and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

The Plan has evaluated subsequent events for potential disclosure or recognition through September 9, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the SECURE 2.0 Act expanded LTPT provisions to include employees who attained 500 or more hours of service in two consecutive 12-month eligibility computation periods beginning in 2021 as eligible employees for participant contributions. Further, participants from ages 60 to 63 will be allowed to contribute catch-up contributions equal to 150% of the standard limit.
