Mural Consulting Corporation 401(k) Profit Sharing Plan and Trust Notes to the Financial Statements

1. Description of Plan

The following brief description of the Mural Consulting Corporation 401(k) Profit Sharing Plan and Trust is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General – The Plan is a Section 401(k) defined contribution plan with salary deferral provisions, which was established on January 1, 2017. Under the Plan, all employees of Mural Consulting Corporation (Company) who have attained the age of eighteen are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – After completing 3 consecutive months of Eligibility Service (not more than 12) beginning on the Employee's date of hire. An Employee will be eligible to become a Participant in the Plan for purposes of the contributions after completing the number of three consecutive months of Eligibility Service.

Contributions – Each year, participants may make pretax deferred savings contributions in the form of salary deductions, up to the maximum allowed by law. Participants who have attained the age 59.5 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled employees have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated fund until changed by the participant.

The Company, at its sole discretion, may elect to make a contribution to the Plan on behalf of all eligible employees. The Company made no discretionary contribution during the plan year ended December 31, 2024.

Participants' Accounts – Each participant's account is credited with the participant's contributions, an allocation of the Company's contribution (if any), and gains and losses from the investment funds selected. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – A participant is fully vested in participant contributions, plus actual earnings, gains and losses thereon, at all times. Employer contributions and earnings thereon become vested after completion of four years of service or upon death, disability, or normal retirement.

The measuring period for vesting is tied to the Plan Year, ensuring alignment with the plan's operational cycle. Additionally, the plan employs the Hours-of-Service method to determine service, with a requirement of 1,000 hours of service constituting a Year of Vesting Service. Participants should not have below 500 hours of service but not exceeding 1,000 hours may result in a Break of Vesting Service, affecting the pace of their vesting schedule.

These vesting provisions aim to balance rewarding long-term dedication while acknowledging participants' contributions in the earlier stages of their service, ultimately fostering a sense of financial security and engagement in their retirement savings journey.

Mural Consulting Corporation 401(k) Profit Sharing Plan and Trust Notes to the Financial Statements

Payment of Benefits – A participant’s account balance may be withdrawn upon retirement, death, disability, or termination of employment as defined by the Plan. Benefits are payable in either a single lump-sum amount or installment payments equal to the value of the participant’s account if the vested value of the participant’s account is greater than \$5,000. If the vested interest is less than \$5,000, the participant may only receive the distribution in a lump sum. In service withdrawals from transfer accounts, distributions after age 59 ½ and hardship distributions are also allowed by the Plan. A Participant be entitled to request a distribution of their Individual Account attributable to Elective Deferrals on account of Severance from Employment pursuant to Plan Section 5.01(A)(2). The Plan also permits hardships distributions because of a hardship incurred by the Primary Beneficiary of an Employee. The Permissible Withdrawal period will be 90 days following the date the first automatic contribution was made.

2. Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition– Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events – Subsequent events have been evaluated through July 11, 2025, which is the date the financial statements were available to be issued.

5. Plan Termination

6. Tax Status

The Plan as amended and restated as of March 31, 2023, is an individually designed plan. While the restated Plan document does not have a determination letter from the IRS, the Company and Plan management believe that the Plan is currently designed and operated in compliance with applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.
