Service

Benefits Service

All of an employee’s Years of Service while a Participant in the Plan plus full Years of Service prior to January 1, 2021.

The Plan froze benefit accruals as of April 15, 2023.

Vested Service

All of an employee’s Years of Service while a Participant in the Plan after January 1, 2021. Years of Service is defined as all Plan Years with 1,000 or more Hours of Service with the employer.

Compensation

Definition

Compensation is the total Earned Income for the prior Plan Year. “Earned Income” is the net earnings from employment, without regards to items not included in gross income and in other deductions. Net earnings are reduced by contributions made by the Employer to a qualified plan to the extent deductible under Code Section 404.

Averaging

Highest five consecutive years of compensation out of the last ten Plan Years

Vesting

All participants Accrued Benefit shall be vested according to the following schedule:

Normal Retirement

Eligibility

The normal retirement date for each participant is the first of the month on or next following age 65.

Benefit

The amount of monthly retirement benefit to be provided for each Participant who retires on the Participant's Normal Retirement Date shall be equal to the Participant's Accrued Benefit (herein called the Participant's Normal Retirement Benefit). A Participant's monthly Accrued Benefit is based on a retirement benefit formula equal to one-twelfth (1/12) of (1) or (2) below:

(1) For all owner Highly Compensated Employees they will receive the following: 1.4% of such Participant's Final Average Annual Compensation multiplied by all of his Years of Benefit Service; plus 0.65% of a Participant's Final Average Annual Compensation in excess of his applicable "Social Security Covered Compensation" Table multiplied by all of his number of Years of Benefit Service, but not to exceed 35 years.

(2) For all other Employees they will receive the following: 1.0% of such Participant's Final Average Annual Compensation multiplied by all of his Years of Benefit Service; plus 0.65% of a Participant's Final Average Annual Compensation in excess of his applicable "Social Security Covered Compensation" Table multiplied by all of his number of Years of Benefit Service, but not to exceed 35 years.

The Plan froze benefit accruals as of April 15, 2023.

Accrued Benefit

The Monthly Accrued Benefit, with respect to the formula above, as of any date, is calculated using actual service and compensation as of the date of determination.

Delayed Retirement

Eligibility is the first of the month on or next following the actual date the participant terminates employment after normal retirement date. The benefit is based on service and average compensation as of the actual retirement date, or actuarial equivalent of normal retirement benefit, if greater.

Early Retirement

Eligibility

Age 63 with 10 Years of Vesting Service.

Benefit

early retirement benefit shall equal the Participant's Accrued Benefit reduced by one-one hundred eightieth (1/180) for each of the first twenty-four (24) months that early retirement benefits precede the Participant's Normal Retirement Date.

Disability Retirement

Totally and Permanently Disabled. Unable to engage in any substantial gainful occupation because of physical or mental impairment. The benefit is the Accrued Benefit as of the Disability Retirement Date, commencing at the Normal Retirement Date. If the payment begins prior to Normal Retirement Date, the monthly payment will be reduced.

Death Benefit***Benefit***

Beneficiary benefit equal to the actuarial equivalent of the accrued benefit.

Type of Payment

Monthly benefit at what would have been the Participant's Earliest Retirement Date.

Date of Payment

Contingent upon death after the vesting date and prior to actual retirement.

Methods of Payments

Under the Normal Form of payment, a participant's retirement annuity is payable monthly for life. A participant may elect to receive the annuity under one of the following actuarially equivalent optional modes:

- Benefit is payable monthly for life, without further payments after death.
- Benefit is paid to the participant for life, with such benefit (50%, 75% or 100% of such benefit thereof) continued after death for the subsequent lifetime of the eligible spouse.
- A reduced benefit is paid to the participant for life, with 120, 180 or 240 monthly payments guaranteed. If the participant dies within the guarantee period, the payments continue to a beneficiary until 120, 180 or 240 payments have been paid.
- A lump sum payment of the actuarial equivalent of the accrued benefit funded by the employer.

Unless the participant has elected an option above, it is automatically assumed that a participant married at least one year has elected a Joint and Last Survivor option with 100% of the initial amount continued to the surviving spouse as contingent annuitant.

Contributions

The entire cost of the plan is borne by the Employer.

Amendments

The employer reserves the right to amend the Plan at any time.
