Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. NOTE 1 – DESCRIPTION OF THE PLAN

The following description of The Kudzu Fabrics, Inc. 401(k) & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Kudzu Fabrics, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

The Company is the administrator of the Plan (Plan Administrator). Lincoln Financial Group Trust Company, Inc. (Custodian) has been appointed to serve as the custodian of the Plan's assets.

Eligibility

Employees are eligible to participate in the Plan upon reaching three months of service and the age of nineteen. Entrance into the Plan is quarterly on the first day of January, April, July or October following the employee's initial date of eligibility. Once participants meet the eligibility requirements, the participant becomes automatically enrolled into the Plan on the first day of the following quarter, unless they opt out.

Contributions

Each year, participants may contribute eligible pretax annual compensation, as defined in the Plan, so as not to exceed limits set forth in the Internal Revenue Code (IRC). Once participants become eligible, they are automatically enrolled into the Plan at a deferral rate of 2% of eligible compensation with a yearly automatic deferral increase by 1% of eligible compensation up to a maximum of 8%. The Company matches employee contributions for the first 25% of a maximum of 6% of eligible employee compensation that an eligible employee contributes to the Plan. The Company may contribute additional amounts at the discretion of the Company's Board of Directors. In October 2024, the Company's Board of Directors elected to suspend the Company matching contribution effective November 1, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations. For the year ended December 31, 2024, the maximum contribution allowed by an employee under 50 years of age is \$23,000. For an employee at or over 50 years of age, the maximum contribution allowed is \$30,500.

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the investment options offered by the Plan. The Plan Administrator has the ability to change the available investment options at any time.

Participant Accounts

Each participant's account is credited with the (a) participant's contribution, allocation of (b) the Company's contributions, and (c) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions portion of their accounts is based on years of service. A participant is fully vested after six years of credited service.

Elective deferral contributions, qualified matching contributions, and qualified nonelective contributions are 100% vested. Other employer contributions that are not 100% vested when made are based on years of service and are subject to the vesting schedule below:

Notes Receivable from Participants

Participants may borrow up to two loans from their fund accounts at a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account. Principal and interest are paid through semi-monthly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or separation from service, a participant may elect to receive their benefits as either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in the form of installments. A participant who is employed and who has attained a normal retirement date may also elect to make a cash withdrawal of his or her entire vested interest in his or her account.

Forfeitures

Forfeited, non-vested accounts may be used to pay Plan expenses and then reduce future employer contributions.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are determined by the closing price on actively traded markets, and subsequently recorded at fair value. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. The Plan's gains and losses on investments bought and sold as well as held during the Plan year are included in the net appreciation/(depreciation) in fair value of investments. Unrealized gains/(losses) are considered as the difference between the current value of securities as of the end of the Plan year and either the current value at the end of the preceding year or the actual cost if such investments were purchased during the present year. Realized gains/(losses) on sales of investments are considered the difference between sales proceeds and the current value of investments at the beginning of the year or the actual cost if such investments were bought during the year.

The Plan invests in the Lincoln Stable Value Account, a fixed group annuity issued by The Lincoln National Life Insurance Company. The contract is considered a fully benefit-responsive investment contract and is therefore reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts since this is the amount received by participants if they were to initiate permitted transactions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are classified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value investments.

Contributions

Contributions from the Plan participants and the matching contributions from Employer are recorded in the year in which the employee contributions are withheld from the eligible compensation.

NOTE 3 – FAIR VALUE MEASUREMENT

The Plan utilizes Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures* (ASC 820). ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices which are observable for the asset or liability; and
- Inputs derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies

NOTE 4 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Lincoln National Life Insurance Company. Lincoln National Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The average yield and crediting interest rates was approximately 2.30% for the year ended December 31, 2024. The crediting interest rate is based on a formula agreed upon by the issuer, but may not be less than 1.00%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan’s ability to receive amounts due is dependent on the issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of

equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 5 – PARTY-IN-INTEREST

Plan investments include a guaranteed investment contract managed by the Custodian, and therefore, this transaction qualifies as a party-in-interest transaction which is exempt from the prohibited transaction rule under ERISA. Notes receivable from participants are also defined by ERISA as party-in-interest transactions.

NOTE 6 – TAX STATUS

The Plan sponsor adopted a simplified ERISA volume submitter 401(k) plan which received a favorable opinion letter from the IRS dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

NOTE 7 – FORFEITURES

Forfeitures of \$7,471 and \$2,262, respectively, were available at December 31, 2024 and 2023, to reduce the Company's future expenses and/or contributions. Expenses of \$5,273 were paid from forfeited non-vested accounts during the year ended December 31, 2024.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 9 – CERTIFIED INVESTMENT INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and

This information has not been audited by the Plan’s independent auditors.

NOTE 11 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 12 – SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 8, 2025, the date these financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.
