Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Triple B Corporation 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Triple B Corporation 401(k) Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Triple B Corporation 401(k) Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Triple B Corporation 401(k) Savings Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.

- conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Triple B Corporation 401(k) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Note 1 – Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of Triple B Corporation 401(k) Savings Plan (the “Plan”) are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Valuation of Plan Investments and Income Recognition:

The Plan’s investments are stated at fair value (see Note 5). Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Contributions:

Contributions from participants are recorded in the period in which they are withheld from the participant’s compensation. Matching contributions from the Company are recorded in the period in which the related participant contributions are recorded.

Excess Contributions:

Certain contributions are considered to be excess contributions based on year-end compliance test results performed by the Plan’s third-party administrator and are required to be refunded to the participants. At December 31, 2024 and 2023, the Plan had excess contributions payable of \$125,064 and \$117,732, respectively, which will be refunded to the participants in the following year.

Payment of Benefits:

Benefits are recorded when paid.

Estimates:

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Subsequent Events:

The Plan has evaluated subsequent events through the date these financial statements were available to be issued which was July 30, 2025.

Note 2 – Description of the Plan

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General:

The Plan is a defined contribution plan effective January 1, 1995. The Plan is designed to benefit participating employees of the Triple B Corporation (the “Company”) by allowing voluntary contributions by participants through payroll deductions and matching

employer contributions, if any. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility:

Effective January 1, 2024, an employee is generally eligible to participate upon completion of 90 days of service, as defined in the Plan document, and attaining the age of 21. Once eligible, an employee can enter the Plan on the next available Plan entry date. Plan entry dates are the first day of each month.

Prior to 2024, an employee generally is eligible to participate upon completion of one year of service, as defined in the Plan document, and attaining the age of 21. Once eligible, an employee can enter the Plan on the next available Plan entry date. Plan entry dates are the first day of the Plan year and the first day of the seventh month of the Plan year.

Contributions:

Participants may elect to defer up to 90% of their compensation each year as either pre-tax or Roth contributions subject to Internal Revenue Service (IRS) annual limits and certain other limits for highly compensated employees. The Company's contributions are at the discretion of the Company's Board of Directors in amounts, if any, that match the participant's deferrals from their compensation or other discretionary contributions. The Company made no contributions in 2024. Participants may also contribute amounts representing distributions from other qualified plans ("rollover contributions from other qualified plans").

Participant Accounts:

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and net earnings. Allocations are based on participant contributions or account balances, as defined in the Plan. Participants are 100% vested in their contributions and vesting in Company contributions is earned ratably over six years of service. Participants individually direct their investments from available choices through Fidelity Investments. A participant becomes immediately 100% vested in the event of death or disability while still an employee of the Company.

Forfeitures:

Forfeitures are created when participants terminate employment and take a distribution from their account before becoming fully vested in Company contributions to the Plan. Any such forfeited amounts will be used to reduce future Company contributions to the Plan. There were no forfeitures in 2024.

Benefits:

Upon termination of employment with the Company, participants will be entitled to a distribution of their vested interest. Benefits are recorded when they are paid. Benefits are

paid in a lump sum equal to the value of the participant's vested interest in his or her account. Distributions can also be made during a participant's employment upon attainment of age 59½ or under certain hardship provisions as defined in the Plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Plan Administration:

The Board of Directors of the Company appoints the Plan Administrator who is currently an employee of the Company. Some of the expenses for administration of the Plan are paid by the Company. Such amounts are excluded from these financial statements. Certain investment related expenses are charged directly against fund investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions, if any, at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will be 100% vested in their accounts.

Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Income Tax Status:

The Company adopted a Fidelity Management and Research Company (FMR) non-standardized pre-approved plan document. FMR received an approval letter from the IRS dated June 30, 2020, which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed and currently being operated, in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 3 – Information Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee of the Plan, Fidelity Management Trust Company, has certified as to the completeness and accuracy of the following information reflected in the accompanying financial statements and supplementary schedule:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and dividend and interest income reflected on the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024.
- Investments reflected on the supplemental schedule of assets (held at end of year).

Note 4 – Related Party and Party-in-interest Transactions

The Plan's investments are primarily held in custodial accounts with Fidelity Investments (Fidelity) under the direction of Fidelity Management Trust Company (FMTC), as trustee and therefore, transactions with Fidelity qualify as exempt party-in-interest transactions. Each participant has individual discretion and responsibility for investment allocations selected from available money market and mutual fund investment vehicles through Fidelity. Available funds include various funds from Fidelity mutual fund companies as well as some funds from other fund families.

Note 5 – Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used as of December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value. As required by ASC 820, assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The valuation of all investments is classified within Level 1 of the fair value hierarchy as described above.

Money market fund: Valued at stated cost plus accrued interest, which approximates fair value.

Mutual funds: Reported at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
