Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Finsler Corporation 401(k) Retirement Plan (the "Plan") provides only general information. The Plan's sponsor is Finsler Corporation. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A) GENERAL

Effective January 1, 1997, Finsler Corporation (the "Company") established a defined contribution plan covering eligible employees who have completed three months of continuous service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the Internal Revenue Code ("Code").

B) CONTRIBUTIONS

Participants may elect to contribute to the Plan a portion of their compensation, as defined by the Plan, on a pre-tax basis, subject to Internal Revenue Service ("IRS") and other limitations. Additionally, participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contribution). Catch-up contributions are permitted for participants who are 50 or older during the Plan year. Eligible employees are automatically enrolled at a default rate of 3% unless declined or election of a different contribution rate. The total maximum allowable contribution per participant to the Plan directly from the participant was \$23,000 for the fiscal Plan year, not including additional catch-up contributions allowed for participants over the age of 50, which were \$7,500.

The Company made discretionary matching contributions of approximately \$276,000, which were equal to 50% of eligible participant contributions up to a maximum of 6% of total eligible compensation for the year ended December 31, 2024. The Company may also elect to make discretionary profit-sharing contributions. There were no discretionary profit-sharing contributions made during the year ended December 31, 2024.

C) VESTING

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in employer contributions plus actual earnings thereon is based on years of continuous service. Vesting in the Company's discretionary matching and non-elective contributions is as follows:

1	20%

5 or more	100%

Participants are 100% vested, regardless of years of service, when they reach normal retirement age, are totally and permanently disabled, or death occurs.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

D) PAYMENT OF BENEFITS

Benefits are payable on termination of service due to retirement, termination, disability or death. Participants or their beneficiaries may elect to receive a lump-sum distribution, annual installments, or partial withdrawals as defined in the Plan document. Eligible participants may also make hardship withdrawals, as defined.

E) PARTICIPANT ACCOUNTS

Each participant's account in the Plan is credited with the participant's contribution, an allocation of any Company discretionary contribution and the Plan's earnings and charged with benefit payments and an allocation of the Plan's losses and administrative expenses. Plan earnings and losses are allocated based upon account balances while contributions are credited based upon elective deferrals and compensations, as defined. Administrative expenses are charged directly to the accounts of the participant who incur those fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

F) INVESTMENT OPTIONS

Participants may direct their elective 401(k) contributions, rollovers, if any, as well as Company discretionary matching and non-elective contributions to the Plan in a variety of investment options as more fully described in the Plan document. Participants may change their investment options and deferral percentages at their discretion.

G) FORFEITED ACCOUNTS

Pursuant to the Plan, forfeited non-vested accounts may be used to pay Plan expenses or reduce future employer contributions. The Company utilized approximately \$63 in forfeitures to pay Plan expenses during the year ended December 31, 2024. There were no non-vested forfeitures at December 31, 2024. At December 31, 2023, the Plan had approximately \$63 in non-vested forfeiture balances.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

A) BASIS OF ACCOUNTING

The Plan's financial statements are prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America for employee benefit plans.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

B) USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

C) INVESTMENT VALUATION AND INCOME RECOGNITION

Assets of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Mutual funds are valued at the net asset value ("NAV") of shares held by the Plan.

Purchases and sales of securities are recorded on a trade date basis. Dividend and interest income are recorded by the custodian in the period earned. Net realized and unrealized appreciation or depreciation in fair value of investments consists of the change in unrealized appreciation or depreciation and the realized gain or loss on the sales of investments during the year. Acquisition costs are included in the cost of investments purchased and sales are recorded net of selling expenses. Investments are self-directed by the individual Plan participants.

D) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

E) PAYMENT OF BENEFITS

Benefits are recorded when paid.

F) ADMINISTRATIVE EXPENSES

The Plan agreement allows for the Company to absorb the majority of the Plan's administrative and investment related expenses. Investment related expenses are included in net appreciation of fair value of investments through revenue sharing arrangements. During the fiscal year ended December 31, 2024, approximately \$82,000 in administrative expenses were incurred by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

G) RECENT ACCOUNTING PRONOUNCEMENTS

The Company evaluates new accounting pronouncements for relevance and impact on the Plan's financial statements. Management does not expect that timely adoption of new pronouncements will have a material impact on the Plan's net assets available for benefits.

H) MANAGEMENT REVIEW OF SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 25, 2025, the date when the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

Accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. During 2024 and 2023, Level 1 inputs were available and therefore used. No level 2 and 3 inputs were used by the Plan.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. These funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds held by the Plan are deemed to be actively traded.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the fiscal year ended December 31, 2024 are reported in net appreciation in fair value of investments.

NOTE 4 - STABLE VALUE FUND

The Plan has an investment in a stable value fund at December 31, 2024 and 2023. Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited, which approximates fair value. The investment balance at December 31, 2024 and 2023 totaled \$1,337,421 and \$1,623,794, respectively. The objective of the investment is to provide liquidity and safety of principal, along with a competitive, guaranteed rate of return. Crediting rates for the Plan's investment are set by the issuer using a process similar to that used by banks or other insurance companies for similar products. The crediting rate is declared in advance and is reset quarterly. The fund's declared crediting rate will never be below 1 percent annually. The fund's NAV increases with the daily equivalent of the crediting rate and the plan's unit value increases along with the fund's NAV offset by the plan's asset management fees. Past crediting rates are not indicative of future rates. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions. Contract value is guaranteed by the issuer as there are no wrap contracts supporting the liquidity of the fund. Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. If the plan sponsor views the occurrence of any of these events as probable as of the measurement date, details about market value adjustments or other withdrawal restrictions can be obtained through the plan's account manager.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to suspend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 6 - TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Code. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company is the administrator of the Plan, and as such, executes the normal duties associated therewith. Costs incurred for audit, legal, and other administrative functions are paid by the Company.

Reliance Trust Company serves as the record keeper and custodian of the Plan, and therefore, fees and expenses paid to the custodian qualify as party-in-interest transactions. Standard Insurance Company serves as the administrator of the Plan and as such, fees paid for distribution services qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.
