1. Description of Plan

The following description of the Invitae 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan covering substantially all employees of Invitae and CombiMatrix Molecular Diagnostics, Inc. (the "Company" or "Employer"). An employee became eligible to participate in the Plan upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Employer filed for Chapter 11 bankruptcy in February 2024. In May 2024, the sale of the Employer was approved to Labcorp. Effective August 14, 2024, the Employer approved a resolution to terminate the Plan. All assets have been distributed by November 2024.

Contributions

Participants could elect to have a percentage deducted from their compensation as defined by the Plan document. Participant contributions could be deducted on a pre-tax, after-tax or roth basis. Participants who attained age 50 before the end of the plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. A participant could elect to increase, decrease or suspend deductions according to procedures established by the Company. There is an annual limit as to the amount that could be deducted from compensation that is determined by the Internal Revenue Code ("IRC").

The Company, at its discretion, could make discretionary matching contributions to the Plan.

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of (a) the Employer's contribution and (b) Plan earnings (losses) thereon. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account. All investments were participant directed.

Vesting

A participant was 100% vested in his or her deferral, rollover accounts and Employer matching contributions including allocated earnings thereon at all times.

Notes Receivable from Participants

The Plan offered a loan feature whereby a participant (borrower) enrolled in the Plan could borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). Loans were collateralized by the balance in the participant's account and bore interest at the available market financing rates. The loan must be repaid within a five-year period, unless the loan was used to acquire the principal residence of the borrower which extended the repayment beyond five years. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

Benefits were paid upon retirement, death, age 59 1/2 or other termination of employment. Participants could elect for payment to be made in a lump sum or in an amount the participant designates from time to time. Benefits could also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which were considered hardship withdrawals, could not exceed the amount required to relieve the financial need.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The Employer approved to terminate the Plan effective August 14, 2024. As a result, the Plan has changed its basis of accounting for periods starting January 1, 2024, from the accrual basis to the liquidation basis.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") required management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan followed U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and were related to assets with unadjusted quoted prices in active markets. Level 2 inputs related to assets with other than quoted prices in active markets which could include quoted prices for similar assets or liabilities or other inputs which could be corroborated by observable market data. Level 3 inputs were unobservable and were used to the extent that observable inputs did not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value was measured using the net asset value ("NAV") per share as a practical expedient were not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

All of the Plan's investments were stated at fair value except for the group annuity contract, which was stated at contract value. Mutual funds were valued at the daily closing price as reported by the fund. Mutual funds held by the Plan were registered with the Securities and Exchange Commission. These funds were required to publish their daily net asset value and to transact at that price. The self-directed brokerage accounts were valued based on the account's underlying investments held as of the end of the plan year and consisted of mutual funds and common stock. The common/collective trusts were valued at the NAV of units held by the Plan. The NAV, as provided by the trustees of the trusts, was used as a practical expedient to estimate fair value. The NAV was based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient was not used when it was determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The group annuity contract was valued at contract value, which represented contributions plus credited interest less participant withdrawals and fees.

Investment Valuation and Income Recognition (continued)

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation in value of investments included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceased to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance was reduced and a benefit payment was recorded upon a distributable event.

Other Income – Revenue Sharing

During 2024, the Plan received revenue sharing of \$77,917, which was included with other income on the statement of changes in net assets available for benefits and was used to offset eligible Plan expenses during 2024.

Payment of Benefits

Benefits were recorded when paid.

Corrective Distributions

During 2024, the Plan made corrective distributions of \$23,740 to affected participants as a result of excess participant deferrals.

Expenses

Certain expenses of maintaining the Plan were paid by the Company and were excluded from these financial statements. Investment related expenses were included in net appreciation in value of investments.

Transfer of Assets

As a result of the Plan termination (see Note 1), the Plan transferred assets of \$41,260,382 to the Laboratory Corporation of America Holdings 401(k) Savings Plan.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 15, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements including investments held at December 31, 2023, and net appreciation in value of investments, interest and dividend income and interest on notes receivable from participants for the period from January 1, 2024 to November 27, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively “Empower”), qualified institutions.

Common/Collective Trusts

The Plan invested in 10 common/collective trusts (the “Trusts”) with American Century. The NAV for each of these Trusts was determined each business day. Issuances and redemptions of units could be made on such days, based upon the NAV per unit as of the Trusts valuation date last proceeding the date on which such order to contribute or redeem assets was received.

There were no unfunded commitments for the common/collective trusts.

Group Annuity Contract, at Contract Value

The Plan invested in the Key Guaranteed Portfolio Fund (the “Portfolio Fund”) as an investment option for Plan participants. The Portfolio Fund was a general account product offered through a group annuity contract and was fully benefit-responsive. Participant principal and interest were fully guaranteed by the entire general account assets of Empower Annuity Insurance Company of America, the issuer of the Portfolio Fund. Each quarter an interest rate was established for all money, regardless of when it was deposited. The credited interest rate could stay the same or change each quarter. Participants could transfer their account balance to any other investment option offered under the Plan at any time with no restrictions or penalties. The Plan was not invested in the Portfolio Fund at November 27, 2024.

5. Tax Status

The Plan's prototype plan document preparer has obtained an opinion letter dated November 14, 2022 from the Internal Revenue Service ("IRS") stating that the Plan was designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter, however, the Plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP required Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

6. Party-in-Interest Transactions

Certain Plan investments were managed by Empower. Empower were the trustee and custodian as defined in the Plan document and, therefore, these transactions qualified as exempt party-in-interest transactions under ERISA.

Certain administrative functions were performed by officers or employees of the Employer at no cost to the Plan.

Participants who were active employees could borrow from their accounts and such loans qualified as exempt party-in-interest transactions under ERISA. These loans were recorded as notes receivable from participants in the statements of net assets available for benefits.

7. Non-Exempt Party-In-Interest Transactions

During the 2024 Plan year, the Employer failed to remit to the Plan certain participants' contributions amounting to \$4,500 within the period described by the Department of Labor regulations. Delays in remitting the contributions to the Plan were due to administrative oversight. The Employer is in the process of calculating and remitting lost earnings for the \$4,500 of delinquent contributions.
