## **INDEPENDENT AUDITORS' REPORT**

To the Plan Administrator and Participants of  
National Board of Medical Examiners 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C)***

We have performed audits of the financial statements of the National Board of Medical Examiners 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Notes to Financial Statements December 31, 2024 and 2023

### NOTE A - DESCRIPTION OF THE PLAN

The following description of National Board of Medical Examiners ("NBME") 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### [1] General:

The Plan is a defined-contribution 401(k) plan covering all employees of NBME hired on or after January 1, 2015 except for nonresident aliens, leased employees, interns, and co-op employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Ascensus Trust Company is the Plan trustee and Vanguard Group, Inc. ("Vanguard"), through Vanguard Retirement Plan Services and a partnership with Ascensus, LLC ("Ascensus"), is the recordkeeper of the Plan.

#### [2] Contributions:

Plan participants may begin contributing a portion of their eligible compensation as a pre-tax deferral on the first day of the quarter on or after the date of hire. There is no service or age requirements to begin contributing. Participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In no event may participant contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified defined-benefit or contribution plans. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation.

NBME may provide discretionary employer contributions to the Plan, including matching and profit-sharing contributions, subject to determination by the Plan administrator and annual approval by the Board of Directors. To qualify for discretionary employer contributions, participants must be at least 21 years old and meet eligibility requirements. Contributions begin on the first day of the quarter on or after the date of hire, provided the age requirement is met. Effective January 1, 2024, the Plan was amended to include a discretionary profit-sharing contribution. Employees hired on or before December 31, 2021, who participated in NBME's defined-benefit plan, are not eligible for the profit-sharing contribution. Additionally, participants must be employed on the last day of the Plan year to receive profit-sharing contributions.

For the year ended December 31, 2024, NBME made discretionary matching contributions equal to 50% of each participant's annual contributions, up to 6% of eligible compensation, as defined by the Plan. These contributions are funded alongside participant contributions through biweekly payroll deductions and are reconciled annually to ensure compliance with Plan provisions. In addition, NBME provided discretionary profit-sharing contributions equal to 5% of each participant's eligible compensation, as defined by the Plan. These contributions are accrued annually as of the last day of the Plan year and funded in the subsequent year. Discretionary matching and profit-sharing contributions for the year ended December 31, 2024, were \$890,490 and \$596,184, respectively. Participants direct the investment of both participant and employer contributions into various investment options offered by the Plan.

**NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)**

**[3] Participant accounts:**

Each participant's account is credited with the participant's contributions and allocations of (a) NBME's discretionary matching contributions, (b) NBME's discretionary profit-sharing contributions and (c) Plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**[4] Vesting:**

Participants are immediately vested in their contributions and rollovers, plus actual earnings thereon. Participants who terminate employment due to death, disability, or attainment of age 65, the Plan's normal retirement age, are fully vested in their total account balances. For the remainder of participants, vesting in NBME's discretionary employer contributions, plus the earnings or losses thereon, is as follows:

**[5] Notes receivable from participants:**

Active participants may borrow from their participant accounts if they have a balance of at least \$2,000 of their own contributions in their account and have no other outstanding loans at the time they apply for a loan. Participants are not eligible for a loan if they are currently in default on another loan or have incurred a deemed distribution on a previous loan. Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. A participant may borrow from his or her account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50%, of the vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. Each loan is secured by the balance in the participant's account and bears interest at a rate of 1% above the prime interest rates as published in the Wall Street Journal Money Rate Section. As of December 31, 2024 and 2023, the interest rate on all outstanding loan balances ranged from 4.25% to 9.5%. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**[6] Payment of benefits:**

On termination of service, a participant with a vested account balance of \$1,000 or less will receive a lump-sum distribution. A participant with a vested account balance exceeding \$1,000 may elect to receive a lump-sum distribution or a partial distribution. In addition, participants are permitted to take distributions prior to termination under certain conditions specified in the Plan document.

Participants may also, at any time, take distributions of all or part of their rollover or transfer contributions attributed to another qualified plan.

##### [7] Forfeitures and suspense account:

If a Plan participant terminates employment before becoming fully vested in their employer discretionary contributions, the nonvested employer discretionary contributions plus the related earnings are forfeited at the earlier of the date the participant receives a distribution of their entire vested balance or incurs five one-year breaks in vesting service. Forfeited balances may be used immediately to pay for Plan expenses and reduce employer discretionary contributions. Forfeited balances may be restored if the participant is rehired within five years of termination and have repaid their plan distributions. The Plan may reinstate previously forfeited benefits using current available forfeitures.

During the year ended December 31, 2024, forfeitures of \$15,275 were used to reduce employer contributions and \$25,548 were utilized to pay Plan expenses. Forfeited nonvested accounts available as of December 31, 2024 and 2023 were \$7,196 and \$27,284, respectively.

The Plan also maintains a suspense account, which includes certain unallocated amounts in the Plan, such as employer contributions exceeding the amounts allocated to participants. Balances in the suspense account may be used to pay Plan expenses or to reduce employer discretionary contributions. For the year ended December 31, 2024, \$13,521 was used to reduce employer contributions. Amounts available at December 31, 2024 and 2023 were \$981 and \$12,390, respectively.

#### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### [1] Basis of accounting:

The accompanying financial statements are prepared on the accrual method of accounting.

##### [2] Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized/unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### [3] Payment of benefits:

Benefits are recorded when paid.

##### [4] Plan expenses:

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by NBME. Expenses that are paid by NBME are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net realized/unrealized appreciation in fair value of investments.

##### [5] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Ascensus LLC, acting as an authorized representative of Ascensus Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024 and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

#### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; or (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 or 2023.

#### NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market funds* – Valued at one dollar per share held by the Plan at year-end. Money market funds held by the Plan are mutual funds invested in highly liquid, near-term instruments and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The money market funds held by the Plan are deemed to be actively traded.

*Common/collective trust fund* – Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The investment strategy seeks to invest in well-run non-US businesses capable of generating sustainable growth. There are no unfunded commitments at December 31, 2024 and 2023. Participant transactions can occur daily, however, there is a requirement that the plan sponsor provide advance written notice of five business days for plan sponsor directed withdrawals which will exceed \$1 million.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **NOTE E - PLAN TERMINATION**

Although it has not expressed any intent to do so, NBME has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their discretionary matching contributions and earnings thereon.

#### **NOTE F - TAX STATUS**

The Plan has adopted a Non-Standardized Pre-Approved Profit-Sharing Plan with a cash or deferred arrangement sponsored by Ascensus. On June 30, 2020, the IRS stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and, therefore, the related trust was exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

#### **NOTE G - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Ascensus Trust Company is the Plan trustee and Vanguard, through Vanguard Retirement Plan Services and a partnership with Ascensus, provides recordkeeping services. Certain investments are shares of mutual funds managed by Vanguard and, therefore, transactions related to these investments qualify as party-in-interest transactions. Payments for services to parties-in-interest were \$31,024 for the year ended December 31, 2024.

#### **NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of the investments as of December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

#### **NOTE I - MUTUAL FUND FEES**

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

#### **NOTE J - SUBSEQUENT EVENTS**

Management evaluated subsequent events through September 5, 2025, the date on which the financial statements were approved and made available for issuance.

On August 25, 2025, the Plan was amended with an effective date of January 1, 2026. The amendment establishes the option for participants to make Roth elective deferrals. The amendment also limits participants' deferral contributions to a maximum of 80% of eligible compensation rather than 100% of eligible compensation. All other provisions of the Plan remain unchanged.
