



## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 and 2023

### NOTE A- DESCRIPTION OF PLAN

The following description of the ITR Industries, Inc. and Affiliates 401 (K) Profit Sharing Plan ("The Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution plan covering all eligible employees of the Company who are eighteen years of age or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

**Contributions.** Each year, participants may contribute pretax annual compensation up to the maximum amount allowed under the law as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Annually, the Employer, in its discretion, may make a Matching Contribution to participants accounts equal to a percentage, determined by the Sponsor, of participants Tax-deferred Contributions for the payroll period.

**Participant Accounts.** Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined.

**Vesting.** Participants are immediately vested in their contributions plus actual earnings and are 100% vested in the Company's contribution upon entering the plan.

**Payment of Benefits.** If employment terminates for reasons other than death or disability, participant is entitled to receive 100% of vested account balance. All distributions from the plan will be made in one lump sum payment or can be rolled over to another retirement plan or individual retirement account. If employment terminates due to death or disability, participants (or beneficiary) are entitled to receive 100% of vested account balance in one lump sum immediately (or within 5 years if termination by death) or in installments over remaining life expectancy if termination due to disability.

**Excess Contributions Payable.** This represents a participant's contributions (including earnings) in excess of the maximum amount permissible under law refunded to participant. For the years December 31, 2024 and 2023 the Plan had excess contributions payable of \$-0- and \$-0- respectfully.

**Administrative Expenses:** Consist of fees paid by the plan based on asset value of funds allocated to participants, as per service agreement and administrative expenses related to distributions fees charged each participant upon distribution of funds.

**Financial Hardship:** The plan allows for withdrawal due to financial hardship determined under federal rules.

**Participant Loans:** The plan does not allow participants to borrow money from the plan.

### NOTE B- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the plan are prepared on the accrual basis of accounting.

Investments are stated at fair value, which generally represents last reported sales price on the last business day of the year. Short-term, highly liquid investments are treated as investments rather than cash equivalents and are included in investments.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investment assets for the year ending December 31, 2024 are held by Charles Schwab Trust Bank.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

### NOTE C- FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan can access at the measurement date.

**Level 2:** Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

In July 2015, the FASB issued ASU 2015-12, Plan Accounting: Defined Benefit Pension Plans (Topic 960), Defined Contribution Pension Plans (Topic 962), Health and Welfare Benefit Plans (Topic 965): (Part I) Fully Benefit-Responsive Investment Contracts, (Part II) Plan Investment Disclosures, (Part III) Measurement Date Practical Expedient. Part I eliminates the requirements to measure the fair value of fully benefit-responsive investment contracts and provide certain disclosures. Contract value is the only required measure for fully benefit-responsive investment contracts. Part II eliminates the requirements to disclose individual investments that represent 5 percent or more of net assets available for benefits and the net appreciation or depreciation in fair value of investments by general type. Part II also simplifies the level of disaggregation of investments that are measured using fair value. Plans will continue to disaggregate investments that are measured using fair value by general type; however, plans are no longer required to also disaggregate investments by nature, characteristics, and risks. Further, the disclosure of information about fair value measurements shall be provided by general type of plan asset. Part III is not applicable to the Plan. The ASU is effective for fiscal years beginning after December 15, 2015, with early adoption permitted. Parts I and II are to be applied retrospectively.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and December 31, 2023.

**Mutual funds-** are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Collective investment trust-** valued at daily closing price as reported by the Trust. CIT's held by the Plan are registered with the US Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The CIT held by the Plan are deemed actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at report date.

### NOTE D- PLAN TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect. However, in the unlikely event of termination, the assets then remaining, after providing for the expenses of the Plan and for the payment of any accumulated shares theretofore approved, shall be distributed among the participants. Each participant shall receive that part of the total remaining assets in the same ratio as their accumulated shares bears to the aggregate amount of the accumulated shares of all participants.

### NOTE E- TAX STATUS

The Plan has adopted the Defined Contribution Pre Approved plan of its' plan provider, USI Consulting Inc. The determination letter dated June 30, 2020 from the Internal Revenue Service has determined the plan's provider that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan's provider believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax- exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan has concluded that as of December 31, 2024, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE F- RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Accordingly, as permitted by 29 CFR 2520.103-5 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures, except for comparing such information certified by the custodian.

**NOTE I- PARTY-IN-INTEREST TRANSACTIONS**

USI Consulting Group, Inc. and its affiliates are the trustee and record keeper for the Plan and manages Plan investments and offers various investment products and options. Therefore, these transactions qualify as party in interest. Administrative fees paid by the Plan to the trustee for investment products and management services amounted to \$50,400 and \$47,633 for the year ended December 31, 2024 and 2023 respectively.

**NOTE J- NON-EXEMPT TRANSACTIONS**

As reported on the supplemental schedule of delinquent participant contributions (Schedule H, Part IV, Line 4a), certain Plan contributions were not remitted to the trust within timeframe specified by the Department of Labor's Regulation 29 (CFR 2510.3-102), thus constituting nonexempt transactions between the Plan and the Companies for the year December 31, 2024. Total late participant contributions amounted to \$22,800. The Plan Sponsor has remitted late contributions and reimbursement of the plan for lost earnings is pending.
