Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Etaí's Food 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Etaí's Food 401(k) Profit Sharing Plan & Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Etai's Food 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a participant directed defined contribution plan. The Plan is a multiple-employer plan established for Etai's Food and related employers Restaurant Holding Company, LLC, Izzio Artisan Bakery, LLC, and YAS and DMC, LLC (the Company). The Plan is administered as a single employer plan and all Plan assets are available to pay benefits to all participants under the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The U.S. Congress enacted the SECURE Act which includes provisions that impact benefit plans. Provisions of the SECURE Act are operationally available at this time, but Plan documents will not require formal amendment until 2025. SECURE increased the RMD age from 70 ½ to 73, allows for long-term part-time employees to participate and allows for in service withdrawals for childbirth and adoption expense. The Plan is currently operating according to these provisions.

Eligibility. The Plan covers all employees of the Company who are age eighteen or older and completed two months of service.

Contributions. Participants can make pre-tax elective deferrals and after-tax Roth elective deferrals of up to 100% of their annual compensation, as defined by the Plan, on either a pre-tax or post-tax (Roth) basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make matching contributions equal to a discretionary percentage and non-elective profit sharing contributions equal to a discretionary amount.. The Company did not make matching or non-elective profit sharing contributions for the year ended December 31, 2024. Participants are required to complete one year of service to be eligible for matching and non-elective profit sharing contributions.

The Plan includes an automatic deferral feature whereby a participant is treated as electing to defer 2% of eligible compensation on a pre-tax basis unless the participant made an affirmative election otherwise. The automatic deferral feature provides for an annual increase in the percentage deferred and is ultimately capped at 5%.

Participant Accounts. Each participant's account is credited with the participant's contribution and employer contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings. The Company does not currently make any discretionary contributions. Per the Plan document if discretionary contributions were made they would vest at a rate of 20% per year for a period of six years.

Investment Options. Employees direct their contributions and their share of the Company's contributions (if applicable) to investments in either guaranteed investment contracts or various registered investment companies. Participants may change their investment allocations at any time.

Participant Loans. Participants may borrow from their fund accounts a minimum of \$1,000 up to what is generally a maximum of \$50,000 or 50% of their vested account balances, whichever is less. The loans, which have terms not exceeding 5 years (unless for the purchase of a home), are secured by the balance in the participant's account and bear interest at the prime rate plus one at the time of the loan. Principal and interest are paid on a monthly basis to the custodian through payroll deductions. If a loan is in default, it will be deemed a distribution to the participant.

Fees. Participant accounts will be charged specifically for the administrative cost of setting up and maintaining any loans and for processing any requests for distribution.

Payment of Benefits. Participants who terminate employment with the Employer prior to retirement receive a distribution of their account balance in the event their vested account balance is less than \$5,000. In the event their vested account balance is greater than \$5,000, the participants can elect to receive their distribution, to roll over the distribution, or to retain their account balance with the plan. Participants may request an in-service distribution once attaining age 59 ½ or for hardship as defined by the Plan.

Participants who retire or participants' beneficiaries, in the event of death, have several options available under which they may receive benefits. Such benefits include receiving payment in a lump sum or selecting from various periodic payment options which are available to the participant and/or the participant's beneficiary as more fully described in the Plan documents.

Forfeited Accounts. Forfeitures of terminated participant's non-vested accounts are used to reduce employer's contributions and to offset plan expenses. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts. For the year ended December 31, 2024, there were no forfeited non-vested accounts used to reduce Plan expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments in registered investment companies are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments in guaranteed investment contracts are stated at contract value as described in Note 5. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Administrative Expenses. Administrative expenses of the Plan are paid by either the Plan or the Employer, as provided in the Plan document. Certain administrative functions are performed by the employees of the Employer. No such employee receives compensation from the Plan. Recordkeeping fees and expenses relating to specific participant transactions, such as participant loans and distributions, are charged directly to the participant's account.

Fee Income. In the event that recordkeeping revenue received in connection with plan services under revenue sharing arrangements exceeds agreed upon compensation levels, such excess revenue is deposited to a suspense account and to be used to pay plan expenses or to be allocated to accounts of eligible participants. Administrative expense refunds, and the corresponding administrative expenses, are recognized on a gross basis on the statement of changes in net assets available for benefits.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments receivable held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company, the Plan custodian.

NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework

provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5- GUARANTEED INVESTMENT CONTRACT

The Plan has entered into a fully benefit-responsive investment contract with the custodian who maintains the contributions in a general account. The account is credited with actual earnings on the underlying investments (principally longer term fixed-income securities) and charged for Plan withdrawals and transaction fees charged by the custodian. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than three percent. Such interest rates are reviewed on a monthly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total Plan termination, retirement incentive programs, and the liberalization of Plan withdrawal or transfer rules. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The custodian may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, Plan disqualification, and failure to adopt the Plan in a reasonable period of time.

The quarterly nominal crediting rate in effect at the end of the reporting period is a value which is reset every quarter based on the cell structure at the beginning of the quarter or month depending on the fund (midterm and long-term funds are quarterly or annually while others can be monthly). This value is made up of the weighted average interest rate of the cells in effect at the beginning of the quarter/month and the interest rate enhancement in effect on the end of reporting period date. This is the crediting rate in effect on the end of reporting date only and is not necessarily the crediting rate seen every day over the reporting period. Therefore, the quarterly nominal crediting rate in effect at the end of the reporting period is not going to equate to the effective rate of return over the reporting period. The average yield based on actual earnings for 2024 is 2.11%. Although it has not expressed any intent to do so, in the event of plan termination, merger, or other significant event the plan may limit the fund's ability to transact at contract value.

NOTE 6 - EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan's recordkeeper, trustee and their subsidiaries, as well as the Employer and Plan participants, are each a "party-in-interest" to the Plan as defined by ERISA. Fees charged to the Plan for investment management services are reflected as a reduction of the return on each fund or included in administrative fees. Participants are also charged for certain transactions, such as the processing of a loan or a distribution. Each of these transactions qualifies as an exempt party-in-interest transaction under ERISA.

The Standard Insurance Company and Reliance Trust Company, as recordkeeper and custodian, respectively, received indirect compensation from investment fund providers for recordkeeping, administration, communication and other shareholder services provided on behalf of the registered investment companies or common collective trusts. Indirect compensation is offset against administrative expenses charged to the Plan. If there is excess, it is deposited into the Plan's forfeiture account.

NOTE 7 - TAX STATUS

Effective January 1, 2022, the Plan amended and restated the plan document by adopting The Standard Retirement Services, Inc. Volume Submitter 401(k) Profit Sharing Plan. The Standard received notification from the Internal Revenue Service on June 30, 2020, indicating the plan, as designed, was exempt from federal income tax. The Plan Administrator and Trustees believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue operations at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 9 - RISKS AND UNCERTAINTIES

The plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balance and amounts reported in the accompanying statement of net assets available for benefits.

NOTE 11 - SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to add a Safe Harbor basic matching contribution and eliminate the discretionary match and non-elective profit sharing contributions. The Safe Harbor match will be 100% of participant's deferrals not to exceed 1% of participant's compensation, plus 50% of participant's elective deferrals that exceed 1% but do not exceed 6% of participant's compensation. Participants are eligible for the Safe Harbor basic match after completing one year of service, and will be eligible to begin receiving the match on the first day of the plan year or the first day of the seventh month of the plan year after completing one year of service. The Safe Harbor basic matching contributions vest 100% after two years of service.

Management has evaluated these amendments and determined they represent subsequent events requiring disclosure but not adjustment to the financial statements as of and for the year ended December 31, 2024.
