Note 1: Description of Plan

The following description of the 403(b) Thrift Plan for Dane County Parent Council, Inc. DBA Reach Dane and Reach Green (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Dane County Parent Council, Inc. DBA Reach Dane and Reach Green (the "Employer"). Participants may begin making pretax or Roth deferrals upon employment. Participants are eligible for Employer contributions after attaining two years of service and the age of 18, with entry dates occurring the first of each month. A year of service represents twelve consecutive months in which the participant completes 501 hours of service. All investments are participant-directed. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

Contributions

Each year, participants may contribute up to 100% of eligible compensation. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer also makes matching contributions of 4% of the participant's annual compensation to the Plan if a participant contributes at least 1% of compensation to the Plan. Employer matching contributions totaled \$271,801 during the year ended December 31, 2024.

Contributions may not exceed the annual maximum allowed by the Internal Revenue Service (IRS).

Participant Accounts

Each participant's account is credited with their participant salary deferral contributions, any rollover contributions, and Employer matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants are fully and immediately vested in all contributions, plus actual earnings thereon.

Payment of Benefits

A participant may withdraw funds from any of their accounts under the Plan prior to their benefit commencement date for any of the following reasons: severance of employment, death, disability, reaching age 59 1/2, or hardship. Payment options include lump-sum and direct rollover. Various annuity options are available for those participants who terminated due to death, disability, or reaching age 59 1/2. Payments may not exceed the value of the participant's interest in their account.

Participants with balances less than \$7,000 who terminate service will have the value of their accounts distributed to them upon termination.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts (FBRICs)). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Note 2: Summary of Significant Accounting Policies (Continued)

Cash Equivalents

The Plan considers investments in Mutual of America's General Account (i.e. the Interest Accumulation Account) to be a cash equivalent.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to various plan activities are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are included in net investment income.

Subsequent Events

The Plan has evaluated subsequent events through August 12, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Mutual funds held in pooled separate accounts: Fair value of mutual funds held in pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts, adjusted by an asset charge. The underlying mutual funds held in the pooled separate accounts are open-end mutual funds registered with the U.S. Securities and Exchanged Commission. The funds must publish their daily net asset value and transact at that price.

Note 3: Fair Value Measurements (Continued)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Insurance Company Non Benefit-Responsive General Contract: The insurance company non benefit-responsive general contract is not available for sale or transfer. Accordingly, fair value is not observable and the issuer of the annuity contract, TIAA (Teachers Insurance and Annuity Association of America) and CREF (College Retirement Equities Fund), values the investments based on accumulated cash contributions, interest credited to the contract, transfers, and withdrawals.

Note 4: Fully Benefit-Responsive Investment Contract (FBRIC)

The Plan invests in a FBRIC with TIAA in the form of a guaranteed investment contract ("GIC") that invests in traditional investment contracts. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. TIAA is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 3%. Additional amounts, when declared, remain in effect through the end of the declaration year which begins each March 1 for accumulating annuities and January 1 for payout annuities.

Certain events limit the Plan's ability to transact at contract value with TIAA including plan termination and other events as specified in the GIC. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit TIAA to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by the Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, interest income, dividend income and FBRIC at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mutual of America Life Insurance Company (Mutual of America) and TIAA and CREF, the Custodians of the Plan.

Note 6: Party-in-Interest Transactions

Certain Plan investments in the general account, pooled separate accounts, insurance company non benefit-responsive general contract, and FBRIC are managed by the custodians of the Plan: Mutual of America and TIAA and CREF. Therefore, these transactions qualify as party-in-interest transactions. Fees paid during the year for administrative services rendered by parties-in-interest were based on customary and reasonable rates for such services. Administrative fees charged directly to participants by Mutual of America totaled \$811 for the year ended December 31, 2024 and no fees were charged by TIAA and CREF.

Note 7: Plan Loans

Unless taken under special CARES Act provisions, Plan participants may borrow from Mutual of America a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their participant account balance subject to annuity contract and plan provisions. Effective August 1, 2023, the plan was amended to allow participants to borrow on the combined vested account balance subject to annuity contract and plan provisions. These loans are issued directly from funds owned by Mutual of America and not directly from a participant's account and therefore are not recorded as an asset on the statements of net assets available for benefits. Effective September 1, 2023, the plan was amended to not limit the number of loans a participant may have outstanding. Loans bear interest rates that may be fixed or variable depending upon the plan and annuity contract provisions. Principal and interest is paid ratably by the participant to Mutual of America. Interest is paid directly to Mutual of America while the principal repayments increase the amount of Mutual of America General Account funds available for the participants' use. The amount of such outstanding loans was \$64,261 and \$43,236 as of December 31, 2024 and 2023.

TIAA and CREF also offers participants a similar loan option, although there are no loans under that option outstanding as of either December 31, 2024 or 2023.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 9: Income Tax Status

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The plan administrator is not aware of any significant uncertain tax positions taken by the Plan.

Note 10: Risks and Uncertainties

The Company invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
