NOTE 1 DESCRIPTION OF PLAN

The following description of the Dachser USA Air & Sea Logistics Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all employees of Dachser USA Air & Sea Logistics Inc. (the "Company") who have completed thirty days of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions – Each year, participants may contribute up to 50 percent of pre-tax annual compensation as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. For participants who have completed 1,000 hours of service and are employed on the last day of the year, the Company may provide a discretionary matching contribution. During the year ended December 31, 2024, the Sponsor matched 100% of employee deferrals up to 3% of compensation per participant. The Plan also allows participant rollover contributions from other qualified plans. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant accounts – Each participant's account is credited with the participant's contributions, Company contributions, and Plan earnings and losses on the participant's investments. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contributions and the earnings thereon is based on years of continuous service with the Company as follows:

Investment options – Upon enrollment in the Plan, a participant may direct employer and employee contributions in any of several investment options approved by the Dachser USA Air & Sea Logistics Inc. 401(k) Plan Retirement Plan Committee. Participants may change their investment options daily.

Payment of benefits – On termination of service, a participant, or their beneficiary, may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or other installment options as provided by the Plan. All fully vested balances are available for distribution after the participant reaches the age of 59 1/2.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Notes receivable from participants – Participants who have participated in the plan may borrow against their account balance. The minimum amount of any loan is \$1,000, and the loan cannot exceed 50% of the vested portion of the participant's account balance or \$50,000, whichever is less. Payments of principal and interest are made ratably through payroll deductions. The loans are secured by the balance in the participant's account and bear interest at 4.25% to 9.50% which is commensurate with local prevailing rates as determined by the Plan administrator.

Forfeited accounts – Forfeited nonvested accounts may be used to pay administrative expenses or applied to employer contributions. The Company applied \$-0- in forfeitures towards employer contributions in the current year. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$75,508 and \$22,901, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Dachser USA Air & Sea Logistics Inc. 401(k) Plan Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized gains and losses on investments are included in the net appreciation in fair value of investments on the accompanying statement of changes in net assets available for benefits.

Benefits paid – Benefits are recorded when paid. As of December 31, 2024, no benefits were due to participants, or their beneficiary, who have withdrawn from participation from the Plan and requested a benefit distribution.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded monthly. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Excess contributions payable – Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Administrative expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expense. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The following is a summary of the Plan’s asset information as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included throughout the Plan’s financial statements and supplemental schedules that was prepared by or derived from information provided by Fidelity Management Trust Company, the trustee, and furnished to the Plan administrator. The Plan administrator has obtained a certification from the trustee that the information provided to the Plan administrator by the trustee related to the following assets is complete and accurate.

Accordingly, as permitted by CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets:

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value fund: Valued at NAV. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate full redemption of the fund, the investment adviser reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Fidelity Management Trust Company provides certain administrative services to the Plan pursuant to a Master Plan Service Agreement (“MSA”) between the Company and Fidelity. Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan.

If the revenue received by Fidelity from such mutual fund service providers exceeds the amount owed under the MSA, Fidelity remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 there were no excess amounts. The Plan or Plan sponsor may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services totaled \$49,472 for the year ended December 31, 2024.

NOTE 6 TAX STATUS

The Company has adopted the Plan based on a volume submitter plan document sponsored by Fidelity Management and Research Company. Fidelity Management and Research Company has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, that states that the form of the volume submitter plan is acceptable under Section 401 of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and all amounts of a participant’s account will become 100% vested.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The net assets available for benefits per the financial statements agree with the net assets available for benefits per the Form 5500.

There are no reconciling differences in contributions received from participants between the financial statement and the Form 5500. Amounts allocated to withdrawing participants are recorded in the Form 5500 for benefits claims that have been processed and approved for payment prior to December 31 but not yet paid as of that date. No approved benefit claims existed at December 31, 2024, which were not paid.

NOTE 10 OPERATIONAL DEFECT AND DELINQUENT EMPLOYEE DEFERRALS

In August 2025, it was determined that the Company failed to fund contributions for a rehired plan participant during the year ended December 31, 2024. While the Company withheld the contributions from the participant's paychecks, the funds were not remitted into the Plan. The plan administrator determined the affected deferrals totaled \$4,917. The Company remitted these deferrals into the Plan on August 13, 2025. The Company also remitted the applicable employer match and lost earnings as part of the corrective action.

Additionally, it was determined in August 2025 that the error continued into the plan year 2025. The applicable corrective action for these contributions also took place on August 13, 2025. The late remittances for the 2025 plan year will be reported in the Plan's financial statements and Form 5500 for the subsequent year ended December 31, 2025.

NOTE 11 DELINQUENT EMPLOYEE DEFERRALS

During the year ended December 31, 2023, the Company erroneously failed to timely remit certain employee deferrals to the Plan aggregating \$2,300. These deferrals were corrected in September 2024. The Company computed the lost earnings on these late remittances and subsequently made a contribution for lost earnings to the affected participants in the Plan.

NOTE 12 SUBSEQUENT EVENTS

The Plan has evaluated all subsequent events through August 18, 2025, the date the financial statements were available to be issued.
