We have performed audits of the financial statements of Ryerson Combined Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Basis for Opinion

Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 – DESCRIPTION OF THE PLAN

This description summarizes major provisions of the Ryerson Combined Retirement Plan (the “Plan”) and is provided for general information purposes only. It does not cover all provisions, limitations, and exclusions of the Plan. A full copy of the summary plan description and additional information about the Plan may be requested from the plan administrator.

General: Joseph T. Ryerson & Son, Inc., a wholly-owned subsidiary of Ryerson Holding Corporation (the “Company”), maintains the Plan. The Plan is a defined contribution profit sharing (thrift-savings) plan that is available to all eligible Bargaining Unit employees of Joseph T. Ryerson and Son, Inc. The Plan, which is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), was adopted effective February 1, 1954. The Plan was completely amended and restated and renamed the Ryerson Combined Retirement Plan effective March 1, 2000, and most recently amended and restated effective January 1, 2013.

Master Trust: Assets of the Plan are co-invested with the defined contribution plans sponsored by the Company and its subsidiaries in the Ryerson Savings Plan Master Trust (Master Trust).

Contributions: Participants may elect to contribute up to 75% of their annual compensation as defined by the Plan, plus any portion of certain bonuses from the Company, subject to certain limitations. Certain Employees eligible to participate in the Plan, based on the terms in the applicable supplement to the Plan document, are automatically enrolled at a 4% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. Certain contributions to the Plan are not currently taxable to the participants but are subject to federal and state income taxes upon distribution. Certain plan participants, based on the terms in the supplement to the Plan document, may contribute after-tax contributions up to either 12% or 20% of their annual compensation. The combination of before-tax contributions and after-tax contributions cannot exceed 75% of the participant’s annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make Roth contributions and contribute amounts representing distributions from other qualified plans.

Certain plan participants receive an employer match based on the terms in the supplement to the plan document. The Company may, at its discretion, by resolution of the Board of Directors of the Company, make additional profit sharing contributions to the Plan on an annual basis. In no event shall the Employer’s contribution exceed the maximum amount allowable under the Internal Revenue Code (IRC). There were no profit sharing contributions to the Plan for the year ended December 31, 2024.

Investment Options: Investments are self-directed by the participants of the Plan. Participants direct the investment of their account balance into various investment options offered by the Plan. Except as may be limited by policies concerning excessive short-term trading, each participant can change the investment percentages or transfer all or part of his or her account from one fund to another on a daily basis. The Plan currently offers various collective trust funds and mutual funds as investment options for participants.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions and (b) the Plan’s earnings and is (c) charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Vesting: Participants vest immediately in contributions and the earnings or losses thereon. As of April 1998, all participants were fully vested. However, participants transferred into the Plan from the Ryerson Savings Plan that are not fully vested will continue to vest in accordance with the vesting schedule under their prior plan.

Withdrawals: Participants may withdraw their contributions and the earnings or losses thereon, subject to certain limitations set forth in the Plan. Certain withdrawals are subject to federal and state income taxes and penalties as required by the Internal Revenue Service (IRS).

Benefit Payments: Distributions are made when a participant has separation from service or attains the age of 59½ years, if the participant's supplement allows for in-service distributions. Upon termination of employment, including retirement, a participant has numerous options available, as described in the Plan, with respect to the distribution of their Plan accounts. Hardship distributions are also permitted.

Notes Receivable from Participants: Notes receivable from the Plan are permitted to be made to participants who are actively employed by the Company and who are not members of Local 773 of the International Brotherhood of Teamsters. Such notes may not exceed the lesser of \$50,000 or 50% of the vested interest of the participant. Notes terms generally range from one to five years; however, notes to purchase or rehabilitate the principal residence of the participant can be for up to ten years. The loans are secured by the balance in the participant's account and interest on notes is based upon a nationally published prime rate in effect at the beginning of the month in which the notes application is accepted.

Plan Transfers: Net plan transfers represent account balances of participants who have had an employee status change that affected eligibility and therefore have transferred between the Ryerson Savings Plan and the Plan.

Administration: The Plan is administered by the Ryerson Employee Benefits Committee ("Committee"), which consists of certain employees of the Company appointed by the Company's Board of Directors.

Fidelity Management Trust Company (Fidelity and Trustee) is responsible for administering, holding, and investing certain assets of the Plan. The costs of certain administrative and investment services provided by Fidelity are paid from participants' accounts or assets within the appropriate investment option, as applicable.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from these estimates.

Risks and Uncertainties: The Master Trust, in which the Plan holds an interest, invests in various investments. These underlying investments are exposed to various risks such as interest rate, market, liquidity, credit risks and market risks associated with global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of the underlying investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investment in the Master Trust is reported at estimated fair value based upon the fair values of the underlying investments held in the Master Trust. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Master Trust's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments: Benefit payments are recorded when paid.

NOTE 3 – PLAN TERMINATION

The Company anticipates that the Plan will continue but reserves the right to terminate the Plan at any time. Upon termination of the Plan, all amounts allocated to the participants' accounts, including all employer contributions and earnings thereon, shall vest immediately. The Trustee shall then direct the method and manner of distribution of the Plan's assets to participants or their beneficiaries.

NOTE 4 – TAX STATUS OF THE PLAN

The Internal Revenue Service has determined and informed the Company by a letter dated March 6, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, Plan management believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment gain (loss) from the Plan's interest in the Master Trust, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 6 – MASTER TRUST ASSETS

The Plan's investments are in the Master Trust, which was established for the investment of assets of the Plan and the assets of the Ryerson Savings Plan, the Central Steel & Wire Company Savings Plan and the Central Coil Processing, LLC Retirement Plan. Each participating retirement plan has a divided interest in the underlying assets of the Master Trust based upon Plan participant investment elections. The value of the Plan's interest in the Master Trust is based on the beginning of year (period) value of the Plan's interest in the trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. Investment income and administrative expenses relating to the Master Trust are allocated to the individual plans based upon their interests in each of the underlying participant-directed investments.

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held as underlying investments of the Master Trust.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in the collective trust funds are based on the net asset values per unit as reported by the fund managers. For the Vanguard Retirement Savings Trust IV, the fund manager does require twelve months advanced notice for Plan Sponsor-initiated redemptions. However, participant-initiated withdrawals from the fund can be made daily without any advance notice. The other collective trust funds held by the Plan provide for daily redemptions by both the Plan Sponsor and participants, with no advance notice requirement.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Master Trust investments are managed by Fidelity or one of its affiliates. Fidelity is the trustee as defined by the Plan; therefore, these transactions and the Plan's payment of fees to Fidelity qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under section 408(b) of the ERISA regulations. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 8 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through August 28, 2025, which is the date the financial statements were available to be issued.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Ryerson Combined Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

NOTE 1 – DESCRIPTION OF THE PLAN

This description summarizes major provisions of the Ryerson Combined Retirement Plan (the “Plan”) and is provided for general information purposes only. It does not cover all provisions, limitations, and exclusions of the Plan. A full copy of the summary plan description and additional information about the Plan may be requested from the plan administrator.

General: Joseph T. Ryerson & Son, Inc., a wholly-owned subsidiary of Ryerson Holding Corporation (the “Company”), maintains the Plan. The Plan is a defined contribution profit sharing (thrift-savings) plan that is available to all eligible Bargaining Unit employees of Joseph T. Ryerson and Son, Inc. The Plan, which is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), was adopted effective February 1, 1954. The Plan was completely amended and restated and renamed the Ryerson Combined Retirement Plan effective March 1, 2000, and most recently amended and restated effective January 1, 2013.

Master Trust: Assets of the Plan are co-invested with the defined contribution plans sponsored by the Company and its subsidiaries in the Ryerson Savings Plan Master Trust (Master Trust).

Contributions: Participants may elect to contribute up to 75% of their annual compensation as defined by the Plan, plus any portion of certain bonuses from the Company, subject to certain limitations. Certain Employees eligible to participate in the Plan, based on the terms in the applicable supplement to the Plan document, are automatically enrolled at a 4% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time. Certain contributions to the Plan are not currently taxable to the participants but are subject to federal and state income taxes upon distribution. Certain plan participants, based on the terms in the supplement to the Plan document, may contribute after-tax contributions up to either 12% or 20% of their annual compensation. The combination of before-tax contributions and after-tax contributions cannot exceed 75% of the participant’s annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make Roth contributions and contribute amounts representing distributions from other qualified plans.

Certain plan participants receive an employer match based on the terms in the supplement to the plan document. The Company may, at its discretion, by resolution of the Board of Directors of the Company, make additional profit sharing contributions to the Plan on an annual basis. In no event shall the Employer’s contribution exceed the maximum amount allowable under the Internal Revenue Code (IRC). There were no profit sharing contributions to the Plan for the year ended December 31, 2024.

Investment Options: Investments are self-directed by the participants of the Plan. Participants direct the investment of their account balance into various investment options offered by the Plan. Except as may be limited by policies concerning excessive short-term trading, each participant can change the investment percentages or transfer all or part of his or her account from one fund to another on a daily basis. The Plan currently offers various collective trust funds and mutual funds as investment options for participants.

Participant Accounts: Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions and (b) the Plan’s earnings and is (c) charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Vesting: Participants vest immediately in contributions and the earnings or losses thereon. As of April 1998, all participants were fully vested. However, participants transferred into the Plan from the Ryerson Savings Plan that are not fully vested will continue to vest in accordance with the vesting schedule under their prior plan.

Withdrawals: Participants may withdraw their contributions and the earnings or losses thereon, subject to certain limitations set forth in the Plan. Certain withdrawals are subject to federal and state income taxes and penalties as required by the Internal Revenue Service (IRS).

Benefit Payments: Distributions are made when a participant has separation from service or attains the age of 59½ years, if the participant's supplement allows for in-service distributions. Upon termination of employment, including retirement, a participant has numerous options available, as described in the Plan, with respect to the distribution of their Plan accounts. Hardship distributions are also permitted.

Notes Receivable from Participants: Notes receivable from the Plan are permitted to be made to participants who are actively employed by the Company and who are not members of Local 773 of the International Brotherhood of Teamsters. Such notes may not exceed the lesser of \$50,000 or 50% of the vested interest of the participant. Notes terms generally range from one to five years; however, notes to purchase or rehabilitate the principal residence of the participant can be for up to ten years. The loans are secured by the balance in the participant's account and interest on notes is based upon a nationally published prime rate in effect at the beginning of the month in which the notes application is accepted.

Plan Transfers: Net plan transfers represent account balances of participants who have had an employee status change that affected eligibility and therefore have transferred between the Ryerson Savings Plan and the Plan.

Administration: The Plan is administered by the Ryerson Employee Benefits Committee ("Committee"), which consists of certain employees of the Company appointed by the Company's Board of Directors.

Fidelity Management Trust Company (Fidelity and Trustee) is responsible for administering, holding, and investing certain assets of the Plan. The costs of certain administrative and investment services provided by Fidelity are paid from participants' accounts or assets within the appropriate investment option, as applicable.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results could differ from these estimates.

Risks and Uncertainties: The Master Trust, in which the Plan holds an interest, invests in various investments. These underlying investments are exposed to various risks such as interest rate, market, liquidity, credit risks and market risks associated with global events. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of the underlying investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investment in the Master Trust is reported at estimated fair value based upon the fair values of the underlying investments held in the Master Trust. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Master Trust's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments: Benefit payments are recorded when paid.

NOTE 3 – PLAN TERMINATION

The Company anticipates that the Plan will continue but reserves the right to terminate the Plan at any time. Upon termination of the Plan, all amounts allocated to the participants' accounts, including all employer contributions and earnings thereon, shall vest immediately. The Trustee shall then direct the method and manner of distribution of the Plan's assets to participants or their beneficiaries.

NOTE 4 – TAX STATUS OF THE PLAN

The Internal Revenue Service has determined and informed the Company by a letter dated March 6, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, Plan management believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and investment gain (loss) from the Plan's interest in the Master Trust, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

NOTE 6 – MASTER TRUST ASSETS

The Plan's investments are in the Master Trust, which was established for the investment of assets of the Plan and the assets of the Ryerson Savings Plan, the Central Steel & Wire Company Savings Plan and the Central Coil Processing, LLC Retirement Plan. Each participating retirement plan has a divided interest in the underlying assets of the Master Trust based upon Plan participant investment elections. The value of the Plan's interest in the Master Trust is based on the beginning of year (period) value of the Plan's interest in the trust plus actual contributions and allocated investment income less actual distributions and allocated administrative expenses. Investment income and administrative expenses relating to the Master Trust are allocated to the individual plans based upon their interests in each of the underlying participant-directed investments.

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held as underlying investments of the Master Trust.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective Trusts: The fair values of participation units held in the collective trust funds are based on the net asset values per unit as reported by the fund managers. For the Vanguard Retirement Savings Trust IV, the fund manager does require twelve months advanced notice for Plan Sponsor-initiated redemptions. However, participant-initiated withdrawals from the fund can be made daily without any advance notice. The other collective trust funds held by the Plan provide for daily redemptions by both the Plan Sponsor and participants, with no advance notice requirement.

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. Certain Master Trust investments are managed by Fidelity or one of its affiliates. Fidelity is the trustee as defined by the Plan; therefore, these transactions and the Plan's payment of fees to Fidelity qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under section 408(b) of the ERISA regulations. Notes receivable from participants also reflect party-in-interest transactions.

NOTE 8 – SUBSEQUENT EVENTS

Plan management has evaluated subsequent events for recognition and disclosure through August 28, 2025, which is the date the financial statements were available to be issued.
