Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kulite Semiconductor Products, Inc. Employees' Profit Sharing and Salary Reduction Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.



NOTE 1 DESCRIPTION OF PLAN

The Kulite Semiconductor Products, Inc. Employees' Profit Sharing and Salary Reduction Plan (Plan) is administered by Kulite Semiconductor Products, Inc. (Company or Sponsor). The following brief description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Description and Plan Document, which are available from the Company.

General

The Plan is a defined contribution and salary reduction plan that was established in 1972. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Fidelity Management Trust Company is the Trustee of the Plan.

Eligibility

All full-time employees who are age 21 or older, excluding residents of Puerto Rico or leased employees of the Company, are eligible to participate in the Plan. Employees become eligible to participate on the first day of each month. There is no service requirement.

Contributions

Participants may elect to make voluntary salary reduction contributions of up to 60% of eligible compensation to their tax-deferred account subject to certain statutory limitations. Such contributions are invested in funds chosen by the participants from the available choices. All employees who are eligible to make elective deferrals and who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions in accordance with, and subject to, certain statutory limitations. Employees may change the amount of their elective deferrals at the beginning of each month. Participants may elect to roll over contributions that were received from an eligible retirement plan into the Plan even if they have not yet satisfied the age and eligibility requirements described above.

The Plan permits Roth contributions, rollover contribution of Roth contributions, and an automatic enrollment provision with an initial pre-tax deferral contribution of 3% to be increased annually by 1% until a deferral rate of 10% is reached. Employees hired or rehired prior to January 1, 2020, are excluded from the automatic enrollment provision.

The Company may make discretionary matching contributions to the Plan for each Plan year as the Company shall determine. Discretionary matching contributions are computed based on eligible compensation and employee elective deferrals made on a quarterly basis. The Company made discretionary matching contributions of \$874,463 and \$808,319 for the Plan years ended December 31, 2024 and 2023, respectively.

Contributions (Continued)

The Company may make a discretionary, nonelective contribution to the Plan on behalf of each employee. This amount is determined by the Board of Trustees for each Plan year. Employees must be employed as of the last day of the Plan year and be at least 21 years of age to receive this discretionary contribution. These contributions will be allocated in a flat-dollar amount equal to all other eligible employees. The Company made discretionary nonelective contributions of \$390,000 and \$375,500 for the Plan years ended December 31, 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (1) the Company's discretionary matching contributions, (2) discretionary contributions, and (3) Plan earnings or losses and investment expenses. Allocations are based on a participant's earnings or account balances, as defined.

The Plan permits participants to self-direct the investments of their accounts in a variety of investment options. All participants have elected to self-direct their accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in amounts attributable to employer contributions is based on a number of years of continuous service, with 100% vesting after six years of credited service. Only whole years of service are counted to compute years of service for vesting purposes.

Benefit Payments

On termination of service, death, disability, or retirement (defined as age 65), a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or equal annual installments, as defined, or any combination of a lump-sum amount and installments.

Participants may elect to withdraw all or a portion of their rollover contributions.

In-Service Withdrawals

Active participants may begin to withdraw their vested account balance when they reach the age of 59½. In the event a participant suffers financial hardship, as defined in the Plan, the participant may generally withdraw all or part of their employee salary reduction contributions' portion of their account.

Participants are required by law to receive a minimum required distribution from the Plan no later than April 1 of the calendar year the participant turns 72 or terminates their employment, whichever is later, unless the participant is a 5% owner.

Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures on nonvested accounts can be used to pay administrative expenses or to reduce future employer contributions under the Plan. During the years ended December 31, 2024 and 2023, \$88,222 and \$112,000, respectively, was used to offset employer contributions. At December 31, 2024 and 2023, forfeited, nonvested accounts totaled \$61,374 and \$51,427, respectively.

Investments

Upon enrollment in the Plan, participants may direct their employee and Company contributions by percentages into any of the investment options available. Participants may change their investment options at any time.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices are used to value investments, if readily available. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Plan Sponsor, as provided by the Plan Document. Expenses that are paid directly by the Plan Sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan, that are paid by the Plan, are recorded as deductions in the accompanying statements of changes in net assets available for benefits. In addition, certain investment-related expenses are included in "Net Appreciation in Fair Value of Investments" presented in the accompanying statements of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Mutual Fund Fees

Investments in mutual funds may be subject to sales charges in the form of front-end loads, back-end loads or 12b-1 fees. Allowable fees under Section 12b-1 of the Investment Company Act of 1940 are annual fees deducted to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and thus not separately identifiable as an expense.

Excess Contributions Payable

Excess contributions payable consists of amounts due to participants related to the December 31, 2024 and 2023, ADP discrimination testing. At December 31, 2024 and 2023, \$8,669 and \$28,966, respectively, are required to be distributed to these participants based on the results of these tests. The excess contributions were paid back to the participants on January 15, 2025, and January 19, 2024, for the respective years.

Subsequent Events

The Company has evaluated its subsequent events and transactions occurring after December 31, 2024 through September 10, 2025, the date that the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends, for the years ended December 31, 2024 and 2023, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

NOTE 4 FAIR VALUE MEASUREMENTS

Fair value measurements establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds/Money Market – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Level 1 input)

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are held by the Trustee, Fidelity Management Trust Company. Any transactions involving the Trustee, the Plan Sponsor, or the third-party administrator are considered party-in-interest transactions.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 TAX STATUS

The Plan is a non-standardized pre-approved profit sharing plan with CODA and has obtained an opinion letter, dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. To the extent that a participant directs that their contributions be invested through the self-directed brokerage account option, the participant solely determines the extent to which such amounts will be diversified, if at all.
