NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the SPR Packaging, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of SPR Packaging, LLC ("the Company" or "the Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company is the Plan Sponsor and Plan Administrator. Prior to January 16, 2024, Millennium Trust Company, LLC served as the Plan's trustee. Effective January 16, 2024, Millennium Trust Company, LLC rebranded and became Inspira Financial Trust, LLC (Inspira). MTG LLC d/b/a Betterment Securities (Betterment) serves as the recordkeeper to the Plan.

Eligibility

Employees of the Company that are not nonresident aliens or represented by a collective bargaining agreement are eligible to participate in the Plan. Employees of the Company are eligible to participate in the Plan upon the attainment of 18 years of age and completion of one month of service. Contributions begin on the first day of the calendar month coincident with the payroll period following completion of each of these eligibility requirements. Eligibility for any of the Company's discretionary profit-sharing contributions requires the participant to be employed on the last day of the Plan year.

Contributions

The Plan allows participants to contribute up to 100% of their annual compensation, subject to certain limitations of the Plan and the Internal Revenue Code (IRC). Participants may direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. The Plan provides an automatic enrollment provision in which newly eligible participants are enrolled to contribute 6% of their annual salary, unless the participant elects otherwise.

The Plan provides for a safe harbor matching contribution. Under this provision, the Company contributes an amount equal to 100% of employee contributions not to exceed 3% and 50% of the amount of employee contributions in excess of 3%, but not to exceed 5%. The Company may also make a discretionary additional non-safe harbor match on behalf of participants. The Company elected not to make any discretionary contributions during 2024 or 2023.

Participant Accounts

Participant accounts are credited with participant contributions, Company's safe harbor matching and discretionary contributions, and actual earnings and losses thereon. Plan expenses are allocated based on participant account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are vested immediately in all employee and employer contributions and actual earnings and losses thereon.

Benefit Payments

Upon termination due to retirement, death, resignation or permanent and total disability, the value of the participant's account may be paid in a lump sum or rolled over to another qualified plan. The normal retirement age is the date a participant reaches the age of 65. Additionally, the Plan provides for in-service withdrawals once a participant has reached the age of 59 ½, even if still employed.

Benefit payments from the Plan will be made in a lump sum distribution if the balance is less than \$1,000 and the participant does not direct the Plan otherwise. Effective June 20, 2023, the Plan was amended to include a force-out provision of participant accounts that are between \$1,000 and \$5,000 upon participant termination.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's account.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance, with a minimum required borrowing of \$1,000. Loan terms range from one to five years but may be extended if proceeds are used for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% as of the first month of the calendar quarter in which the loan is requested. Principal and interest are paid ratably through payroll deductions. Participants are limited to one loan outstanding at any time during the Plan year.

Administrative Expenses

The Plan pays certain administrative expenses associated with the administration of the Plan. Certain administrative expenses are paid by the Company.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, all participant accounts are fully vested.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Cash

Cash includes bank demand deposit accounts. The Plan's cash balances may at times exceed federally insured limits. The Plan has not experienced any losses in this account and believes it is not exposed to any significant risk with respect to cash.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Fair Value Measurements – Definition and Hierarchy

Financial Accounting Standards Board Accounting Standards Codification 820 (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 – Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 – Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 – Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the lowest level input that is significant to the fair value measurement.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, economic conditions, world affairs, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the accompanying financial statements.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Exchange-traded funds: Valued at fair value based on quoted market prices in active markets.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

Inspira is the trustee of the Plan assets. As such, transactions involving Inspira and the Plan qualify as party-in-interest transactions. Additionally, transactions involving notes receivable from participants qualify as party-in-interest transactions, as well as transactions between the Company and the Plan.

6. INCOME TAX STATUS

The Plan is designed from a prototype plan provided by Betterment. The Internal Revenue Service (IRS) has determined and informed Betterment, by the letter dated June 30, 2020, that the written form of the underlying prototype plan document is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
