Opinion



Notes to Financial Statements

NOTE 1. DESCRIPTION OF PLAN

The following brief description of CBL & Associates Management, Inc. (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established January 1, 1986, is a defined contribution employee benefit plan covering all employees who have attained age 21 and completed sixty days of service. Effective April 1, 2024, the Plan was amended to change days of service to thirty days. Employees may become participants in the Plan on the first day of the month coinciding with or following the date eligibility requirements are met. Each plan year begins on January 1. The employer, as defined by the Plan, is CBL & Associates Management, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Administration

Administration of the Plan is vested in the Company who may appoint a plan administrator. The Trustee for the Plan is State Street Bank and Trust Company. A trust agreement provides for the investment of trust funds and prescribes the powers, duties, obligations, and functions of the Trustee. Transamerica Retirement Solutions Corporation (Transamerica) is the recordkeeper and CBL & Associates Management, Inc. is the plan administrator.

Contributions

The Plan is a contributory plan whereby an employee who elects to participate may contribute a minimum of 1 percent of their annual compensation as defined by the Plan. There is no maximum participant contribution other than limitations defined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The amount of employer discretionary contributions is 50 percent of eligible contributions made by a participant up to a maximum of five percent of the participant's compensation. Contributions are subject to certain other limitations. Participants direct the investment of their contributions and the employer's contribution into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at five percent of eligible compensation and their contributions invested in a designated target fund until changed by the participant.

Effective January 1, 2023, the Plan was amended to allow for Roth elective deferrals. In addition, Roth elective deferrals are eligible for hardship withdrawals.

The Plan records employer and employee contributions receivable when compensation is paid. No allowance for credit losses has been recorded at December 31, 2024 and 2023, as employer and employee contributions receivable have never historically incurred losses and current conditions and supportable forecasts show zero risk of nonpayment.

Participant Accounts

Each participant's account is credited with the participant's contributions, the employer's contributions, if any, an allocation of fund earnings and charged with an allocation of administrative expenses. Fund earnings are allocated based on participant earnings or account balances as defined in the Plan. The benefit to which a participant is entitled is the total amount that can be provided from the participant's account.

Vesting

Plan participants are immediately vested in their contributions, Company matching contributions and all earnings allocated to their accounts.

NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits

Benefit payments for death, disability, or retirement begin as soon as administratively possible. Payments for required minimum distributions may be deferred until the first day of April following the calendar year in which a participant reaches age 70 1/2 or retires except that distributions to a five percent owner of the employer must commence by the first day of April following the calendar year in which the participant reaches age 70 1/2. A participant who has reached age 59 1/2 may, upon their request, begin to receive their retirement benefits before their actual retirement. For termination of service for other reasons, a participant may receive the value of the vested interest of their account as a lump sum distribution.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The policies that materially affect net assets available for benefits and changes in net assets available for benefits are summarized as follows:

Basis of Accounting

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Benefits Committee determines the Plan's valuation policies utilizing information provided by the Trustee, State Street Bank and Trust Company. See Note 7 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to participant contributions. There were no excess contributions for the years ended December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments and administrative expenses.

Under the terms of the Plan, administrative expenses may be paid by the Company. If not paid by the Company, the expenses shall become a liability of the Plan. The Company, however, may reimburse the Plan for any administrative expenses incurred, and such reimbursement shall not be considered as an employer contribution.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management performed an evaluation of subsequent events through August 28, 2025, the date these financial statements were available to be issued.

NOTE 3. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain of the Plan's investments are shares of investment funds managed by Transamerica. Transamerica is the recordkeeper and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for record keeping services are included in net appreciation (depreciation) in fair value of investments and administrative expenses.

NOTE 4. PLAN TERMINATION PROVISIONS

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 5. TAX STATUS OF THE PLAN

The Company has adopted a Volume Submitter 401(k) Profit Sharing Plan. The volume submitter plan sponsor has received a favorable opinion letter from the Internal Revenue Service, dated June 30, 2020, stating that the volume submitted plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirement of the IRC and, therefore, the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7. FAIR VALUE MEASUREMENTS

ASC Topic 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 7. FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds: Carrying value is a reasonable estimate of fair value given the short term nature of money market funds.

Collective trust funds: Valued at the NAV of units of the collective trusts (the Funds). The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the Funds less its liabilities. This practical expedient is not used when it is determined to be probable that the Funds will sell the investment for an amount different than the reported NAV. Redemptions and withdrawals, subject to certain restrictions, are generally permitted daily. There were no outstanding commitments at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7. FAIR VALUE MEASUREMENTS (CONTINUED)

- (a) In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in the table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic condition or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the period. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Levels 1, 2 or 3.

NOTE 8. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

In 2023, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Transamerica totaling \$7,574,559 and \$7,036,698 at December 31, 2024 and 2023, respectively. Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a regular basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.
