## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Aflac Incorporated Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance, and therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control-related matters that we identified during the audits.

**Other Matters**

*Supplemental Schedules Required by ERISA*

The supplemental schedules of Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and Schedule H, Line 4(j) – Schedule of Reportable Transactions for the year ended December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

## **1. DESCRIPTION OF THE PLAN**

The following brief description of the Aflac Incorporated Pension Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

### **General**

The Plan is a noncontributory defined benefit pension plan, established effective January 1, 1983, for the benefit of employees of Aflac Incorporated (the Company) and the domestic employees of certain of its subsidiaries. The Plan is frozen to new employees hired on or after October 1, 2013, and to employees rehired on or after October 1, 2013. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was amended to freeze future benefits earned on January 1, 2024. The freeze will not reduce or eliminate any pension benefits earned through December 31, 2023; however, no future benefits will accrue. In addition to the Plan freeze on January 1, 2024, the Plan was terminated effective December 31, 2023. The Plan was amended to allow for a limited-period payment election window during 2024, in connection with the Plan's termination.

The Plan was amended in 2023 to allow for a lump sum window for certain participants, as defined, which commenced October 1, 2023.

### **Trustee**

Vanguard Fiduciary Trust Company (Vanguard) served as the Plan's trustee and custodian through May 31, 2024. Effective June 1, 2024, US Bank assumed trustee and custodial responsibilities for the Plan. Mercer Investments, LLC serves as the investment advisor to the Plan.

### **Pension Benefits**

Effective October 1, 2013, the Plan was frozen to new employees hired on or after October 1, 2013, and to employees rehired on or after October 1, 2013. Prior to October 1, 2013, employees became Plan participants on the earlier of January 1 or July 1 following the completion of one year of credited service, as defined by the Plan, and attainment of age 21. Participants generally have no vesting rights until completion of five years of service, at which time the participants become fully vested. Under the terms of the Plan, participants are eligible for normal retirement income upon reaching age 65 or after completion of five years of participation, if later. Participants whose whole years of credited service plus attained age in whole years equals or exceeds 80 (Rule of 80) are eligible for early retirement with unreduced benefits. Participants who are at least 55 years of age and have 15 years of service are eligible for early retirement with reduced benefits. Normal retirement benefits are determined by application of benefit percentages (based on years of service) to the participant's average compensation, using the five consecutive years within the 10-year period preceding retirement that produce the highest average compensation.

Benefits are also payable to participants who become disabled. If an active employee with a vested benefit dies and is married on the date of death and is survived by their spouse, a death benefit will be paid to the surviving spouse at the participant's earliest retirement age.

**Funding Policy**

The Company makes contributions to the Plan sufficient to provide the Plan with assets with which to pay benefits to Plan participants. The Company has determined to terminate and wind down the Plan; therefore, the Company would be obligated to fund any existing unfunded termination liabilities to the extent that all participants of the Plan would receive all benefits due to them under the terms of the Plan. In the unlikely event that the Company would not be able to meet its unfunded obligations, then participants may be eligible for continuation of benefits under insurance provided by the Pension Benefit Guaranty Corporation (PBGC).

The annual contribution by the Company is actuarially determined with the assistance of consulting actuaries using the projected unit credit actuarial cost method (in accordance with the Pension Protection Act of 2006) and is designed to fund, with respect to each participating employee, the remaining unfunded cost of all benefits under the Plan. As of December 31, 2024 and 2023, the Plan met the minimum funding requirements of ERISA.

Plan contributions are made and the actuarial present value of accumulated plan benefits is reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

In accordance with accounting principles generally accepted in the United States of America (GAAP), the Plan's financial statements are presented on the liquidation basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of income and expenses during the reporting period. Actual results could differ from these estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain

investment securities, it is at least reasonably possible that changes in the values of investment securities could occur and that such changes could materially affect the amounts reported in the statements of net assets available for pension benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Expenses**

Certain Plan administration costs are paid directly or reimbursed by the Company. Expenses paid directly or reimbursed by the Company are not reflected in the financial statements of the Plan.

**3. ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated plan benefits are those future periodic payments, including lump-sum distributions, which are attributable to the employees' service rendered to the valuation date. Such benefits include those expected to be paid to: (a) retired or terminated employees or their beneficiaries; (b) beneficiaries of employees who have died after normal retirement; and (c) present employees or their beneficiaries. Benefits under the Plan are based on employees' eligible compensation for each Plan year. The accumulated plan benefits for active employees are based on their average compensation during the five years ending on the date as of which the benefit information is presented (the valuation date). Benefits payable under all circumstances – retirement, death, disability and termination of employment – are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits has been determined by independent actuaries and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal or retirement) between the valuation date and the expected dates of payment. The significant actuarial assumptions used in the valuations include: (a) assumed rates of return on investments of 5.04% (5.50% in prior year); (b) average weighted retirement at age 62; (c) Pri-2012 Total Dataset Mortality Table projected with Mortality Improvement Scale MP-2021, with employee rates before benefit commencement and healthy annuitant rates after benefit commencement. The foregoing actuarial assumptions are based on the presumption that the Plan will continue. The impact of the Plan termination on the actuarial present value of accumulated plan benefits is reflected within Note 9.

The computations of the actuarial present value of accumulated plan benefits were made as of January 1, 2024. Had the valuations been performed as of December 31, there would be no material differences.

#### **4. PLAN TERMINATION**

The Plan was terminated effective December 31, 2023. In accordance with the termination, the Company will fund any remaining unfunded termination liabilities. To the extent that the Company is unable to fund all remaining liabilities, the net assets of the Plan will be allocated as prescribed by ERISA and its related regulations. Subject to the requirements of the PBGC, in the event of Plan termination, benefits will be provided in the following order: first – participants, spouses, beneficiaries and contingent annuitants who were receiving benefits or who are eligible to receive benefits at least three years prior to termination of the Plan; second – all benefits guaranteed by the PBGC; third – all vested benefits; and fourth – all other benefits.

**5. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three valuation hierarchy levels. Level 1 valuations reflect quoted market prices for identical assets or liabilities in active markets. Level 2 valuations reflect quoted market prices for similar assets or liabilities in an active market, quoted market prices for identical or similar assets or liabilities in non-active markets or model-derived valuations in which all significant valuation inputs are observable in active markets. Level 3 valuations reflect valuations in which one or more of the significant inputs are not observable in an active market.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**6. TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated October 31, 2024, that the Plan qualifies in accordance with applicable sections of the Internal Revenue Code (IRC) as a tax-exempt entity. Accordingly, no provision for Federal income taxes has been recorded. Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. FINANCIAL INFORMATION CERTIFIED BY TRUSTEES**

Certain information related to investments disclosed in the accompanying financial statements and ERISA, the required supplemental schedules, including investments at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard and US Bank.

**8. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are held in shares of mutual funds managed by Vanguard. Vanguard previously served as the Plan trustee and custodian until May 31, 2024.

Administrative fees were also paid to the trustee, actuary and investment advisor. As such, these expenses qualify as party-in-interest transactions.

**9. SUBSEQUENT EVENTS**

As part of the Plan termination in January 2025, the Plan entered into a purchase agreement with Principal Life Insurance (Principal) whereby Principal provided a nonparticipating single premium group annuity contract supported by a comingled separate account to the Company. The Plan disposed of its assets and paid to Principal the related annuity premium of approximately \$418 million to settle its obligations, accordingly the Plan had no remaining obligations to plan participants. Effective April 1, 2025, Principal began making annuity payments to plan participants.
