## INDEPENDENT AUDITOR'S REPORT

**To the Sponsor of the  
CRIHB 401(k) Profit Sharing Plan  
Roseville, California**

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of the CRIHB 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### 1. DESCRIPTION OF THE PLAN

The following description of the CRIHB 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering the employees of the California Rural Indian Health Board, Inc. (the Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Administration** – The Sponsor is the administrator of the Plan and, as such, carries out the duties imposed under ERISA. The Sponsor has delegated certain responsibilities for the operation and administration of the Plan. Empower Retirement (the Trustee) is the appointed custodian of the Plan's assets. Administrative and recordkeeping services are provided by Retirement Administration, Inc., and Three Bell Capital is the Plan's financial advisor and fiduciary consultant.

**Eligibility** – All full-time employees, age 18 or older, of the Sponsor are eligible to participate in the Plan immediately unless they are an excluded employee (part of a collective bargaining unit, nonresident alien, or leased employees). Part-time or temporary employees that are scheduled to work less than 500 hours in a given year are also excluded from the Plan, however if they do work 500 hours in a given year, they are no longer part of the excluded class of employees.

**Contributions** – Participants may contribute up to the maximum amount allowed by IRS limitations through salary deferrals. Participants may also contribute amounts representing distributions from other qualified retirement plans. Contributions are subject to certain limitations. The Sponsor provides a matching contribution of 100% of the participant's salary deferral, not to exceed 6% of the participant's compensation. During 2024 the Sponsor also provided a non-elective profit-sharing contribution of 4% through February 23, 2024 and 2% for the remainder of the year.

**Investment election** – The Plan offers various investment alternatives through the Trustee. Plan participants direct their contributions among these investment alternatives.

**Participant accounts** – Employee and matching contributions are credited to participants' accounts following each pay period. In addition, participant accounts are credited with the earnings on their investments as earned. The vested balance in a participant's account is the benefit to which the participant would be entitled upon termination or retirement.

**Vesting** – Participants are immediately vested in all employee and employer contributions, plus actual earnings thereon.

**Payment of benefits** – Benefits are payable upon retirement, termination, disability, hardship, or death. Benefits are paid in either substantially equal payments, a single lump sum distribution or a rollover to another qualified plan or an individual retirement account.

**Administration expenses** – The expenses associated with administering the Plan are paid from the Plan net assets and therefore, are reflected in the Plan's financial statements.

**Notes receivable from participants** – Under the terms of the Plan, participants may borrow from their accounts up to 50% of their vested account balance. Notes receivable must be for a minimum of \$1,000 and are capped at the lesser of one-half of the participant’s vested account balance or \$50,000. A participant may have one loan outstanding at any time. The loans are secured by the balance in the participant’s account. The loan interest rate, is set at 2 percent above the prime rate, as defined and fixed through the duration of the loan.

## 2. SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting** – The financial statements of the Plan are prepared on the accrual basis accounting in accordance with accounting principles generally accepted in the United States of America.

**Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** – Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value for mutual funds equals the quoted market price in an active market on the last business day of the Plan year. As a practical expedient, the investments in collective trust funds are excluded from the fair value hierarchy and valued at their Net Asset Value (“NAV”) as reported by the fund manager of the collective trust.

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan’s investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income and gains (losses) are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan’s gains and losses on investments purchased and sold as well as held during the year.

**Notes receivable from participants** – Notes receivable are valued at the outstanding note balance, plus accrued unpaid interest, which approximates fair market value. Interest income is recorded on an accrual basis and recognized in the period it is assessed. If a participant ceases to make loan payments and the Plan administrator deems the loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Contributions** – Employee contributions are recorded in the period payroll deductions are made. Matching contributions from the Sponsor are recorded in the period when the related employee contributions are recorded.

**Benefit payments** – Benefits are recorded when paid.

**Risks and uncertainties** – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Income taxes** – The Plan received a determination letter from the IRS dated June 30, 2020 stating that the Plan was designed in accordance with the provisions of the Internal Revenue Code. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

**Subsequent events** have been evaluated for recognition and disclosure through August 25, 2025, the date which these financial statements were available to be issued. Management concluded that no material subsequent events have occurred since December 31, 2024, that require recognition or disclosure in such financial statements.

### 3. BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The Empower Investment Fixed Account (EIFA) is a guaranteed annuity account that guarantees principal and a contractually specified interest rate. It offers the opportunity for stability of principal and a declared interest rate which is subject to reset quarterly. This contract does have surrender charges if it is terminated by the contract holder or a plan terminates its interest in such contract within certain time periods. This contract is considered benefit-responsive. The EIFA contract value as reported on the statements of net assets available for benefits was \$286,126 and \$204,943 at December 31, 2024 and 2023, respectively.

### 4. INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Retirement (the trustee of the Plan).

### 5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within a fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust funds:* The investments underlying the collective trust fund investments generally include shares of common stock and fixed income investments whose values are determined on the basis of quoted prices in an active market. The Plan's collective trust fund investments are valued based on NAV per share or unit as a practical expedient as reported by the fund manager, multiplied by the number of shares or units held as of the measurement date. Accordingly, these NAV-based investments have been excluded from the fair value hierarchy.

### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to provisions of ERISA.

### 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 8. PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Retirement Administration, Inc. is the Plan recordkeeper; Three Bell Capital is the Plan's financial advisor and fiduciary consultant; and Empower Retirement is the Plan's Trustee, therefore, the Plan's payment of fees to Retirement Administration, Inc., Three Bell Capital, and Empower Retirement qualify as party-in-interest transactions. Certain Plan investments are managed by Empower Retirement, therefore, the related transactions are party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Sponsor.
