Independent Auditor's Report

Opinion

We have audited the financial statements of Automatic Fire Protection, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements fairly present, in all material respects, the Plan's net assets available for benefits as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

NOTE 1: PLAN DESCRIPTION

The following description of the Automatic Fire Protection, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. On October 20, 2024 the Plan's name was changed from Automatic Fire Protection, Inc. 401(k) Profit Sharing Plan to Automatic Fire Protection, LLC 401(k) Plan. There were no other changes to the Plan's provisions or operations due to this name change.

General

The Plan was established July 1, 2006, under the provisions of the Internal Revenue Service Code Section 401(a), as a defined contribution plan to benefit participating employees of Automatic Fire Protection, Inc. (the Employer or Company). The Plan allows eligible employees to accumulate funds for retirement, death, and disability benefits. Subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), the Plan has received a favorable opinion letter from the Internal Revenue Service.

Plan Administration

The Plan is administered by the Plan Administrator, appointed by the Company's management. The Plan's custodian, Empower Annuity Insurance Company of America, is responsible for the custody and management of the Plan's assets.

Eligibility to Participate

Employees become eligible to participate in wage deferrals upon attaining age of 18 and performing a minimum of 6 months of service. After meeting the eligibility requirements, employees may enter the Plan at the beginning of the next month.

Employee Contributions

Participants in the Plan may elect to have compensation deferred through payroll deductions. The maximum contribution amount for 2024 is \$23,000. For those 50 or older, an added contribution of up to \$7,500 in salary deferral catch-up is allowed for a total possible contribution of \$30,500.

Participants may roll over amounts representing distributions from other qualified defined contribution plans.

Employer Contributions

The Employer may make matching contributions equal to a discretionary percentage, determined by the Employer, of the participant's elective deferrals. If the Employer elects to make a matching contribution, it must be contributed to the Plan by the last day immediately following the Plan year quarter.

The Employer shall have the right to make an additional discretionary contribution, which shall be allocated to each eligible participant. The discretionary contribution and the allocation thereof shall be unrelated to any employee contributions. Forfeitures may be used to pay the Plan's administrative expenses or to reduce any Employer contribution.

As required by the Internal Revenue Code, the Plan includes special rules in years that the Plan is determined to be a "Top Heavy Plan." The Plan becomes a "Top Heavy Plan" when it allocates more than 60% of the contributions or benefits to "Key Employees". "Key Employees" are generally owners, officers, shareholders, or highly compensated individuals. If the Plan becomes top-heavy in any year, the Company may be required to contribute with a special vesting schedule to non-key employees.

Participant Investment Options

Participants may direct their salary deferral contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options at any time throughout the year.

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and the Company's discretionary contribution, as well as the participant's share of the Plan's income and any related administrative expenses. Allocations of income and expenses are based upon the proportion that each participant's account balance bears to the total of all participant account balances. The benefit to which each participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeiture Accounts

At December 31, 2024 and 2023, there were no forfeited nonvested accounts.

Notes Receivable from Participants

Participant loans are not permitted under the Plan.

Payment of Benefits

On termination of service due to death, disability, or retirement, or for any other reason, a participant may request distribution and receive a lump sum equal to the value of the participant's vested interest in his or her account.

Vesting

Participants are immediately vested in contributions plus actual earnings and in the Company's contribution portion of their accounts.

Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to fully terminate the Plan, subject to the provisions of ERISA. In the event of a full Plan termination, participants will become 100% vested in their accounts.

Subsequent Events

The Plan Administrator has evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets generally accepted accounting principles (GAAP) in the United States of America to ensure that net assets available for benefits and changes in net assets available for benefits are consistently reported. References to GAAP issued by the FASB in these footnotes are to the FASB Accounting Standards Codification (FASB ASC).

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines the Plan's valuation policies utilizing information provided by the investment advisor, custodians, and insurance company. See **NOTE 4** for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought, sold, and held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Administrative functions are performed by officers or employees of the Company but receive no compensation from the Plan. Investment-related expenses are included in the net appreciation in the fair value of investments.

Recent Accounting Pronouncements

The Plan has adopted all recent accounting pronouncements issued by the FASB (including its Emerging Issues Task Force) and the American Institute of Certified Public Accountants that management believes will have a material impact on the Plan's present or future financial statements.

NOTE 3: INFORMATION CERTIFIED BY CUSTODIANS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Talcott Resolution Life Insurance Company, the custodians of the Plan, have certified the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the Schedule H, Line 4(i) - Schedule of Assets (held at the end of the year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

NOTE 4: FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following describes valuation methodologies used for assets measured at fair value. As of December 31, 2024, or 2023, there have been no significant changes in the methodologies used.

Pooled separate accounts: The unit values of pooled separate account units are estimated based on the value of the underlying assets owned by the fund minus the fund's liabilities, divided by the number of participation units outstanding. This value is the net asset value (NAV). Net asset value is used as a practical expedient to determine fair value for these accounts.

The methods above may produce a fair value calculation that may not indicate the net realizable value or reflect future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with market participants, using different methodologies or assumptions to determine the fair value could result in a different fair value measurement at the reporting date. The following tables are set forth by level within the fair value hierarchy of the Plan's assets at fair value as of December 31, 2024 and 2023:

NOTE 5: GROUP ANNUITY CONTRACT WITH TALCOTT RESOLUTION LIFE INSURANCE COMPANY

The Plan holds a fully benefit-responsive guaranteed investment contract with Talcott Resolution Life Insurance Company (Talcott) totaling \$1,540,546 and \$1,291,683 as of December 31, 2024 and 2023, respectively. Talcott maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. The contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. As reported to the Plan by Talcott, contract value represents contributions made under the contract, plus earnings, fewer participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. Future economic and regulatory developments may affect the issuer's ability to meet its contractual obligations.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable to occur that might limit the ability of the Plan to transact at contract value with the contract issuers, and that also would limit the plan's ability to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6: RELATED PARTY AND PARTY-IN-INTEREST

Certain Plan investments as of December 31, 2024, are mutual funds managed by Empower Retirement, LLC. Empower Annuity Insurance Company of America and Talcott Resolution Life Insurance Company are the custodians as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Investment fees paid to parties in interest are netted against investment returns.

NOTE 7: INCOME TAX MATTERS

Effective June 30, 2020, the Plan adopted a non-standardized pre-approved profit-sharing plan sponsored by July Business Services. The plan has received an advisory letter from the Internal Revenue Service (the IRS) as to the Plan's qualified status. The plan advisory letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that is more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participant's account balances and the amounts reported in the statements of net assets available for benefits.
