Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Eat’n Park Hospitality Group 401(k) Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audits.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Eat'n Park Hospitality Group 401(k) Retirement Plan (Plan) sponsored by Eat'n Park Hospitality Group, Inc. (Company) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company has appointed a Retirement Plan Committee to provide oversight of the Plan's administrative functions, determine the appropriateness of the Plan's investment offerings and monitor investment performance. Effective April 1, 2024, the Plan name was changed to the Eat'n Park Hospitality Group 401(k) Retirement Plan.

Eligibility - Employees of the Company are eligible to participate in the Plan upon attainment of age 21.

All employees must attain 1,000 hours of service during each Plan year and be employed on the last day of each Plan year to receive employer matching contributions for the Plan year unless the employee terminates during the Plan year because of death or disability, or the employee attains the normal retirement age (age 65) during the Plan year or previous Plan year.

Contributions - Participating eligible employees may elect to contribute up to 100% of either pretax or after-tax eligible compensation, as defined in the Plan. In 2024 and 2023, the Company made discretionary employer matching contributions up to 40% of the first 10% of participants' contributions. Participants are also permitted to make rollover contributions from qualified plans of prior employers. Participants may direct their employee and any employer matching contributions into various investment options offered by the Plan. Both employee and employer contributions are subject to certain Internal Revenue Code (IRC) limitations.

The Company may annually allocate a non-elective contribution determined at the discretion of the Company's board of directors. The non-elective contribution, if any, is allocated among the eligible participants in proportion to each participant's eligible compensation. There were no non-elective contributions made by the Company in 2024 or 2023.

Participant Accounts - Each participant's account is credited with the participant's contributions, the Company's matching contributions, non-elective contributions, if any, and earnings/losses of the participant's investments. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures of terminated participants' nonvested account balances are used to offset Plan expenses or reduce the Company contributions to the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$60,000 and \$46,000, respectively. During 2024 and 2023, forfeited nonvested accounts were used to reduce employer contributions in the amount of approximately \$72,000 and \$41,000, respectively.

Vesting - Participants are immediately vested in their contributions plus earnings thereon. Vesting in the Company's matching and non-elective contribution portions of their accounts plus earnings thereon is based on years of service. Participants become 100% vested after three years of credited service with no vesting prior to that time.

Notes Receivable from Participants - Participants may borrow from their fund accounts up to a maximum of 50% of their vested account balance not to exceed \$50,000. Loan terms generally range from one to three years or up to five years for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits - After termination of service, a participant will receive a lump-sum amount equal to the vested value of his or her combined account, if requested. Terminated participants with a combined balance of less than \$5,000 will be cashed out of the Plan by the recordkeeper.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by management in the preparation of the accompanying financial statements follows:

Basis of Accounting and Use of Estimates - The accompanying financial statements have been prepared on the accrual basis of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan to make estimates that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Fully benefit-responsive investment contracts held by a defined contribution plan are reported at contract value. Contract value is the relevant measurement attribute for that portion of the assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The statements of net assets available for benefits and the statements of changes in net assets available for benefits are presented on a contract value basis.

The Plan's investments in mutual funds and pooled separate accounts are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments in mutual funds are stated at fair value as measured by quoted prices in an active market. Pooled separate accounts are stated at fair value as determined by the issuer of the account based on the fair value of the underlying investments. Interests in pooled separate accounts are generally redeemable on a short-term basis in accordance with the Plan provisions. See Note 4 for a discussion of fair value measurement.

Investment transactions are accounted for on the trade date (date the order to buy or sell is executed). Interest income is accrued when earned and dividend income is recorded on the ex-dividend date. Capital gain distributions from mutual funds are included in income. All gains and losses (realized and unrealized) on investments recorded at fair value, bought and sold as well as held during the year, are included in net appreciation reported within the statements of changes in net assets available for benefits. Gains, losses, dividends and interest income reported on investments recorded at contract value are included in interest and dividend income within the statements of changes in net assets available for benefits.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Benefits Paid - Benefits paid to participants are recorded when paid.

Plan Expenses - Expenses in connection with administration of the Plan are paid by the Plan and reflected separately as administrative expenses in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through July 22, 2025, the date the financial statements were available to be issued.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEES (UNAUDITED)

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Prudential Bank & Trust, F.S.B., Empower Trust Company, LLC and Empower Annuity Insurance Company (the trustees of the Plan), qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

Prudential Bank & Trust, F.S.B. was the trustee through March 31, 2023, and Empower Trust Company, LLC and Empower Annuity Insurance Company were the trustees from April 1, 2023 through December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

NOTE 4 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts - Valued at NAV as reported by the underlying mutual funds.

NOTE 5 - GROUP ANNUITY CONTRACT WITH NATIONAL INSURANCE COMPANY

The Plan holds a fully benefit-responsive guaranteed investment contract (GIC) with Empower Annuity Insurance Company. Empower Annuity Insurance Company maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses. The GIC is included in the financial statements at contract value. Empower Annuity Insurance Company owns a promise to pay interest at crediting rates, which are announced in advance and guaranteed for a six-month period. This contract is not a traditional GIC, therefore there are no cash flows that could be discounted.

Contract value represents contributions made under the contract, plus transfers to the fund and credited interest, less participant withdrawals, transfers out of the fund and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The GIC does not have any restrictions that impact the ability of the Plan to collect the full contract value. The GIC does, however, allow disbursements to be deferred over a period of time in the event of severe adverse economic conditions. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. Empower may not terminate the contract at any amount less than the contract value.

Empower Annuity Insurance Company is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with Empower Annuity Insurance Company, but may not be less than 1.50%. Such interest rates are reviewed on a semiannual basis for resetting. The crediting rate of the product will be established based on current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without the use of a specific formula.

NOTE 6 - TAX STATUS

The Plan had received a determination letter from the Internal Revenue Service dated September 16, 2022, stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. There have been Plan amendments adopted since initially qualifying under the Plan administrator's determination letter. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 - RELATED-PARTY TRANSACTIONS AND PARTIES-IN-INTEREST

Certain Plan investments are managed by Empower Trust Company LLC and Empower Annuity Insurance Company. Also, Empower Retirement, LLC is the recordkeeper. These transactions qualify as party-in-interest transactions. Certain administrative functions are performed by officers and employees of the Company at no cost to the Plan.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their combined accounts.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of assets available for benefits.
