Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Nixon Uniform Service, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of Plan

The following description of Nixon Uniform Service, Inc. (the Company) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all associates of the Company who are age twenty-one or older and have completed thirty days of service, except residents of Puerto Rico, collective bargaining employees and nonresident aliens with no U.S. income source. The entry date for eligibility to receive discretionary Company matching and nonelective contributions is the first day of the quarter after meeting age requirements of twenty-one years and service requirements of at least 1,000 hours of service with the Company during the plan year for which the contributions are made and who are employed by the Company on the last day of such Plan year. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The trustees are responsible for the oversight of the Plan. The Retirement Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the trustees.

Contributions

Participants are eligible to contribute up to 100% of eligible compensation into the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also make Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. The Plan provides for a 4% automatic deferral amount unless the participant makes a contrary election. The automatic deferral amount increases 1% per year up to a maximum of 6%. New participants enter the Plan on the first day of each quarter following thirty days of service. Participant elective deferral contributions equal a portion of compensation as specified in the written salary reduction agreement. The salary reduction agreement may be effective at any date following a participant's entry date. Elective deferral contributions shall be limited as needed to meet nondiscrimination tests and the total amount permissible by law.

At any time, the Company may make discretionary matching and/or nonelective contributions into the Plan. The contributions will be allocated to the accounts of participants who have completed one year of service and at least 1,000 hours of service with the Company during the plan year for which the contributions are made and who are employed by the Company on the last day of such Plan year.

Contributions, Continued

The Company matches employee contributions at a rate of 100% of each employee's contributions up to a maximum of 3.5%. The Company may make a nonelective employer contribution based on a discretionary formula for participants whose earnings exceeded the Social Security wage base. Eligible participants would receive an additional contribution of 3.5% on those excess wages. The Company made no nonelective employer contributions to the Plan in 2024. Company contributions not received by the Plan as of year-end are recorded as employer contributions receivable in the accompanying statements of net assets available for benefits.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's discretionary matching and/or nonelective contributions, as well as allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and rollover contribution plus actual earnings thereon. Participants are vested in the Company's contributions, plus earnings thereon, in accordance with the following table:

Forfeitures

Forfeitures of terminated participants' nonvested account balances may be used to pay plan expenses or to reduce future employer contributions. Forfeited non-vested accounts totaled \$56,406 and \$29,557 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$4,225 and \$48,000 of forfeited nonvested accounts were used to pay plan expenses and reduce employer contributions, respectively.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, or 50% of their vested account balances. The notes are secured by the participant-borrower's vested account and bear interest at one percent above prime as of the date of the note's origination. Terms of the note may not extend beyond five years except for loans for the purchase of a home, for which the plan administrator may permit a longer payment term. Principal and interest are paid through payroll deductions over the term of the note.

Payment of Benefits

Upon termination of employment, retirement, or death, a participant or named beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account under various alternatives including a lump-sum distribution or annuity options, as described in the plan document. The normal form of distribution under the Plan is a lump sum. Annuity options are offered to certain employees with money purchase pension assets that were transferred into the Plan. A participant may elect to receive an in-service distribution from his or her deferral contribution account without terminating employment upon attainment of age 59 ½ or upon hardship, subject to plan provisions. The plan administrator may elect to authorize a lump-sum distribution for terminated participants whose vested account balances are less than \$5,000.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess Contributions Payable

At December 31, 2024 and 2023, liabilities of \$30,363 and \$5,515, respectively, are recorded for amounts refundable by the Plan to participants for contributions made in excess of amounts allowed by the Internal Revenue Service (IRS).

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of certain distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 31, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the net asset value (NAV) of units of a trust company collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(4) Financial Information Certified by a Qualified Institution

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Trust Management Company (Fidelity), a qualified institution.

(5) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of registered investment companies and a common collective trust managed by Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions and are exempt under prohibited transactions rules.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

(7) Income Tax Status

The Plan uses a Volume Submitter Profit Sharing Plan with CODA (Volume Submitter Plan) plan document sponsored by Fidelity. Fidelity received an opinion letter from the IRS dated June 30, 2020, which states that the Volume Submitter Plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
