

#### 1. Description of Plan

The following description of the DEMCO 401(k) Retirement Savings & Investment Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering employees of DEMCO New York Corporation (the Company) who have attained age 18 and completed six months of service. These employees are eligible for elective deferrals and matching contributions. The Company also hires employees under prevailing wage rate agreements from time to time. Employees hired under a prevailing wage rate arrangement who have completed one hour of service are eligible to receive non-elective employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Plan Administration

The Plan is administered by DEMCO New York Corporation, which acts as the Plan Sponsor. The Plan has adopted and operates under a Non-Standardized Pre-Approved Plan developed by DATAIR Employee Benefit Systems, Inc. John Hancock Life Insurance Company of New York (John Hancock) and Actuarial Pension Analysts, Inc. (APA) are the Custodian and Third Party Administrator of the Plan, respectively. The Plan Trustees are responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

##### Contributions

Each year, participants may elect to contribute a portion of their compensation on a pre-tax basis, an after-tax basis or a combination of the two, subject to the maximum allowed by the Internal Revenue Service (IRS) and as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company is also required to make non-elective company contributions for prevailing wage rate employees as defined in the prevailing wage rate agreement. Non-elective contributions were approximately \$129,000 for the year ended December 31, 2024. In addition, the Company will match 50% of an employee's contribution, up to 5% of the employee's compensation, subject to offset by any non-elective contribution allocated to the participant. The Company's match contributions were approximately \$118,000 for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

##### Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as Plan earnings. Eligible employees will receive an allocation of the non-elective company contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Vesting

Participants are vested immediately in their contributions and Company non-elective contributions plus actual earnings thereon. Vesting in the Company matching contribution portion of their accounts, plus earnings thereon, is based on years of continuous service. A participant's vested percentage increases by 20% each year after the second year of employment, reaching 100% after six years of credited service.

##### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. No more than two loans can be outstanding at any one time. The loans are secured by the balance in the participant's account. The loan interest rate is set at 2% above the prime rate, as defined. All loans are required to be repaid within five years, unless the loan is used to purchase a principal residence, the term is extended to ten years. Principal and interest are paid ratably through weekly payroll deductions.

##### Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In-service withdrawals are also permitted for certain financial hardships or when a participant attains age 59 ½, subject to the specific criteria set forth in the Plan Agreement.

##### Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$800 and \$400, respectively. These accounts will be used to reduce future employer contributions or administrative expenses of the Plan. In 2024, employer contributions were reduced by approximately \$21,000 from forfeited nonvested accounts.

#### 2. Summary of Significant Accounting Policies

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers and custodian. See Note 3 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

##### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions payable at December 31, 2024. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

#### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Individual separate accounts*: subaccounts under the separate accounts are invested in underlying mutual funds and valued at net asset value.

#### 4. Certified Investment Information

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to certain investments held as of December 31, 2024 and 2023 totaling \$11,842,580 and \$10,380,927, respectively, and net appreciation in fair value of investments for the year ended December 31, 2024 totaling \$1,286,073, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company of New York, a qualified institution.

Notes receivable from participants as of December 31, 2024 and 2023 and related interest income on notes receivable from participants for the year ended December 31, 2024 are not certified.

#### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

#### 6. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by John Hancock Life Insurance Company of New York (John Hancock). As defined by ERISA Section 3(21), the Investment Adviser, Wilshire, acts as a fiduciary for the Plan. John Hancock, Wilshire and Actuarial Pension Analysts, Inc. (APA) are the Custodian, 3(21) Investment Adviser and Third Party Administrator (TPA), respectively, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Administrative fees paid by the Plan to John Hancock and Wilshire amount to approximately \$69,900 and TPA fees of approximately \$6,300 was paid to APA for the year ended December 31, 2024.

#### 7. Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 8. Subsequent Events

The Plan has evaluated subsequent events through September 11, 2025, which is the date the financial statements were available to be issued. There were no material subsequent events that required recognition or disclosure within these financial statements.
