### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of SDI Technologies Inc. Employee 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits do not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Note 1 - Description of Plan

SDI Technologies Inc. (the "Company" and "Plan Sponsor") established the SDI Technologies Inc. Employee 401(k) Savings Plan (the "Plan"), effective as of August 1, 1987.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

1. *General and Eligibility.* The Plan is a defined-contribution plan covering all employees of the Company and its affiliates not subject to collective bargaining agreements. Employees are eligible to participate after completing three months of service and having attained the age of twenty-one. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan trustees are responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.
2. *Participant Contributions.* Each year, participants may elect to contribute up to 100% of eligible compensation, provided such amount will not cause the Plan to exceed certain limitations prescribed by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. These amounts are credited to each participant's elective contribution account and rollover contribution account, respectively. Additionally, participants aged fifty or older who are making contributions to the Plan are allowed to make catch-up contributions as defined in the Plan. Both pre-tax and Roth contributions are permitted.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The automatic deferral percentage will increase by 1% per year up to a maximum of 10% of eligible compensation. The automatic increase does not apply to highly compensated employees and employees automatically enrolled prior to December 1, 2017.

3. *Employer contributions.* The Company may, at its discretion, make a matching contribution for the plan year not to exceed certain limitations prescribed by the IRC. Those participants who have completed one year of service are eligible for an allocation of the Company's matching contribution. For calendar year 2024, the Company's matching contribution was 50% of the first 8% of each participant's pre-tax compensation contribution, as defined in the Plan. The Company's matching contribution is allocated directly to the participant's account to be invested at the participant's discretion. The Company's matching contribution for the year ended December 31, 2024 totaled approximately \$288,000.

4. *Participant accounts.* Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's matching contribution and (b) Plan earnings and charged with an allocation of Plan administrative expenses. Allocations are based on participant earnings, specific participant transactions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
5. *Vesting.* Participants are immediately fully vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 25% vested after two years of credited service. Vesting increases by 25% for each subsequent year of credited service. A participant is 100% vested after five years of credited service. Additionally, a participant is 100% vested upon death, disability, or attaining normal retirement age, as defined by the Plan.
6. *Investment options.* Participants may direct the investment of the balance in their account into investment options offered by Empower, the custodian of the Plan. Empower offers, through other investment funds, fourteen registered investment companies ("RIC" or mutual funds), twelve common collective trust accounts ("CCT"), and one fixed income guarantee option account ("FIGO").
7. *Notes Receivable from Participants.* Participants may borrow only one note at any one time from their account ranging from a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The note repayment period cannot exceed five years unless such note is used to acquire the participant's principal residence. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% per annum to 9.00% per annum as of December 31, 2024. Principal and interest are paid through bi-weekly payroll deductions.
8. *Payment of benefits.* On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period, as defined. Normal retirement is the date a participant attains age 65. Participants are able to take a hardship withdrawal from their account, as defined by the IRC. For termination of service due to other reasons, participants receive the value of the vested interest in his or her account as a lump-sum distribution. If the participant's vested account balance is less than \$5,000, then the participant will receive benefits as a lump-sum amount.
9. *Forfeited accounts.* As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$100 each of the years. These accounts may be used to first pay any expenses of the Plan and then be allocated to the employer contribution accounts of participants entitled to an employee contribution allocation for the plan year. The Plan expects to utilize the full balance of the forfeited nonvested accounts in 2024. For the year ended December 31, 2024, forfeited nonvested accounts utilized to offset employer contributions amounted to approximately \$700.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for the fixed income guaranteed option, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in the fair value of investments include the Plan's gains and losses on investments bought and sold, as well as held during the year. For the FIGO, interest income is recorded at the rate in effect the day it is directed into the account.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expense

Substantially all expenses related to the administration of the Plan and the management of plan assets are borne by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts. Investment-related expenses are included in net appreciation/depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") 820, "Fair Value Measurements and Disclosures" establishes a framework for measuring fair value. The framework provides a hierarchy that prioritizes the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The hierarchy consists of three broad levels:

- Level 1 - Quoted prices in active markets for identical assets. This level has the highest priority.
- Level 2 - Quoted prices for similar assets in active markets, quoted prices for identical or similar assets not traded in active markets and other observable inputs.
- Level 3 - Prices or valuations that are unobservable. This level has the lowest priority.

Registered investment companies: Valued at the quoted marked price reported on the active market on which the investment is traded.

Common collective trusts invest exclusively in trust funds and are valued at the net asset value (“NAV”) of the collective trust funds, which are not publicly traded. These investments held can be redeemed at NAV as of the measurement date and are redeemable on a daily basis with a one-day redemption notice period. The NAV, as provided by the custodians, serves as a practical expedient to estimate the fair values. There are no unfunded commitments related to the collective trust funds.

Note 5 - Fixed Income Guaranteed Option

The Plan's investment in the Fixed Income Guaranteed Option ("FIGO") with Empower meets the fully benefit-responsive investment contract criteria and is, therefore, reported at contract value as determined by Empower. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fully benefit-responsive investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The interest crediting rate is based on a composite crediting rate, with a guaranteed minimum interest rate. The composite crediting rate and guaranteed minimum interest rate are calculated based upon the terms of the contract with Empower and are reset on a semiannual basis. The contract provides that the guaranteed minimum interest rate cannot be less than 1.4% per annum.

The FIGO is valued at contract value which is the amount plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity. As of December 31, 2024 and 2023, the FIGO at contract value amounted to approximately \$4,091,000 and \$5,479,000 respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

Note 6 - Tax Status

The Internal Revenue Service (“IRS”) has issued an opinion letter dated November 14, 2022 that the form of the prototype plan that the Plan Sponsor has adopted as the Plan is acceptable under section 401 of the IRC. The Plan and prototype plan have been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain tax position that will more likely than not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts. Any unallocated assets of the Plan will be allocated to participant accounts and distributed in such a manner as the Company may determine.

Note 8 - Related Party Transactions and Party In Interest Transactions

One of the Plan’s investments is a guaranteed income fund managed by Empower and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation/depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan paid certain expenses related to the Plan’s operations and investment activity to various service providers. These transactions are party-in-interest transactions. The Plan sponsor pays directly any other fees related to the Plan’s operations.
