Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Meredith Employees' Retirement Income Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of December 20, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits in liquidation for the year ended December 20, 2024, and the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet

our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Adoption of Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of the Plan approved a plan of liquidation on September 13, 2022, and management determined liquidation is imminent. As a result, the accompanying financial statements are prepared on a liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

The supplemental schedule of reportable transactions in liquidation for the year ended December 31, 2024 (referred to as the “supplemental schedule”), is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. Notes to Financial Statements in Liquidation

1. Description of the Plan

The following description of the Meredith Employees' Retirement Income Plan (the Plan) provides only general information. Participants should refer to the Plan Document for more complete information of the Plan's provisions.

General—The Plan is a defined benefit pension plan covering certain employees of Meredith Operations Corporation (the Company or Plan Sponsor).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Company, which has overall responsibility for the operation and administration of the Plan. The Meredith Employees' Retirement Benefit Committee (the Committee) determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Plan Termination—On September 13, 2022, the Committee approved the termination of the Plan effective December 31, 2022, and determined that the Plan termination was imminent. As a result, the Plan changed its basis of accounting to the Liquidation Basis for presenting the 2022 and after financial statements. The Plan distributed all Plan assets during 2024 and terminated with a final liquidation date of December 20, 2024. Assets were distributed to participants based on their elections of either a lump sum payment, or annuity payments, consistent with the provisions of the Plan. The responsibility for paying future benefits for those participants that elected an annuity was transferred from the Plan to a qualified insurance company. After all required payments had been made, there were funds remaining in the Plan that were transferred to a qualified replacement plan, as defined under Section 4980(d) of the Internal Revenue Code (Code).

Investments—The Plan's investments were held in registered investment companies and pooled separate accounts held by State Street Bank and Trust Company. State Street Bank and Trust Company was the custodian of the Plan. Principal Life Insurance Company (Principal) was the Plan's trustee.

Eligibility—Effective December 31, 2018 the Plan was closed to new entrants.

Pension Benefits—Vesting was based on years of service. A participant became 100 percent vested after three years of service. If participants terminated before becoming vested, they forfeited the right to receive benefits. If participants terminated employment with a vested account balance prior to Plan termination, they could elect an immediate lump sum or annuity, or leave the account balance in the Plan.

Normal postretirement benefits, when measured as of any date prior to the participant's normal retirement date, was equal the participant's cash balance projected with interest to the normal retirement date, and converted to an annuity that was the actuarial equivalent of the projected cash balance. Actuarial equivalence for this purpose was determined in accordance with actuarial factors as outlined in the Plan Agreement.

Death Benefits—In the event of death before retirement for a participant who does not have an eligible spouse, a lump sum death benefit equal to the participant's vested cash balance as of the date of death was payable to the participant's beneficiary. For a participant who had an eligible spouse, the death benefit was a monthly benefit for life that was actuarially equivalent to the participant's vested cash balance. The spouse could instead elect to receive a lump sum payment equal to the participant's cash balance, or certain other actuarially equivalent annuity forms. A participant may, with the consent of his/her spouse, waive the spouse benefit in which case payment will be made to the designated beneficiary.

In the event of death after retirement, benefits were in accordance with the form of income in effect on the participant's retirement date.

2. Summary of Significant Accounting Policies

Basis of Accounting—The financial statements have been prepared on the liquidation basis of accounting, under which Plan assets are stated at their estimated net realizable values and liabilities are stated at their net settlement amounts.

Use of Estimates—The preparation of financial statements in accordance with the accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, disclosure of contingent assets and liabilities, the actuarial present value of accumulated plan benefits at the date of the financial statements, and the changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan may invest in investment securities. Investment securities are exposed to various risks such as interest rate, credit, and overall market volatility.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates and employee demographics.

Investment Valuation and Income Recognition—Investments are reported at fair value. Shares of mutual funds are valued at quoted market prices which represent the net asset values of shares held by the Plan at period end. Fair value of the investments in pooled separate accounts are valued based on the net asset value (NAV) as quoted by the fund trustee, based on observable market quotes of the underlying securities within the fund.

Investment and other income includes interest income and dividend income. Net realized appreciation in investments includes gains and losses on investments sold during the period, net of expenses. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits—Benefit payments to participants are recorded upon distribution.

Administrative Expenses—The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan are recorded as deductions in the Statement of Changes in Net Assets Available for Benefits In Liquidation.

The accompanying financial statements have been prepared using the liquidation basis of accounting. When a plan uses liquidation basis of accounting, it considers the period over which the liquidation will occur, as well as the nature of expenses that will be incurred and reported by the Plan during the liquidation period. These future expense amounts were accrued in the Statement of Net Assets Available for Benefits in Liquidation at December 31, 2023 as "accrued expenses expected to be incurred in liquidation". These expenses were paid in full in 2024.

3. Funding Policy

The Company agreed to make contributions to the Plan to sufficiently provide the Plan with assets with which to pay pension benefits to Plan participants. The Company's funding policy was generally to contribute to the extent necessary to maintain the Plan's fully funded status. Contributions made to the Plan equaled an amount selected by the Company within the limits of minimum and maximum funding in accordance with ERISA. The Plan has met the ERISA minimum funding requirements. No contributions were required to be made to the Plan in 2024.

4. Accumulated Plan Benefits

Accumulated plan benefits are those future periodic payments, including lump sum distributions, that are attributable under the Plan's provisions to service rendered by employees as of the valuation date. Accumulated plan benefits include benefits expected to be paid to (i) retired or terminated employees or their beneficiaries, (ii) beneficiaries of employees who have died, and (iii) present employees or their beneficiaries. The actuarial present value of accumulated plan benefits is determined by an independent actuary and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The more significant assumptions used in the December 31, 2023 valuations were as follows:

- The cash balance interest crediting rate assumption used was 2.39% .
- The Pri-2012 employee, healthy retiree and contingent survivor (post retiree death) sex distinct mortality tables, without collar or amount adjustments with generational projection using scale MP-2021 were used to determine the life expectancy of participants to better reflect recent general population experience;
- The lump sum conversion rate for pre-1998 terminations was 5.45% for years 0-5, 5.52% for years 6-20, and 5.43% for years 21+ ;
- The discount rate used was 5.20%;
- The actuarial cost method utilized was the Unit Credit Cost Method; and
- The assumed average retirement age was 62.

The foregoing actuarial assumptions were based on the presumption that the plan would terminate in 2024.

5. Investments

Certain information related to investments for the Plan disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2023, and net appreciation in fair value of investments and investment income for the period ended December 20, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by State Street Bank and Trust Company.

6. Fair Value Measurements

Fair value is a market-based measurement, not an entity-specific measurement. Therefore, a fair value measurement should be determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering market participant assumptions in fair value measurements, a fair value hierarchy was established, which prioritizes the inputs used in measuring fair values. The hierarchy gives the highest priority to Level 1 measurements and the lowest priority to Level 3 measurements. The three levels of the fair value hierarchy are described as follows:

- Level 1: Observable inputs obtained from independent sources, such as quoted market prices for identical assets and liabilities in active markets.
- Level 2: Other inputs, which are observable directly or indirectly, such as quoted market prices for similar assets or liabilities in active markets, quoted market prices for identical or similar assets or liabilities in markets that are not active and inputs that are derived principally from or corroborated by observable market data.
- Level 3: Unobservable inputs for which there is little or no market data and require the Plan to develop its own assumptions, based on the best information available in the circumstances, about the assumptions market participants would use in pricing the assets or liabilities.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The following table sets forth the fair value of the Plan's assets by level as of December 31, 2023.

The investments in registered investment companies' NAV is derived from shares held in mutual funds as reported by the investment manager. The pooled separate accounts' NAV represents the amount at which units are redeemed on a regular basis as reported by the investment manager.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

7. Federal Income Tax Status

The Plan received a determination letter from the Internal Revenue Service (IRS) dated November 30, 2020, stating that the Plan is qualified under Section 401(a) of the Code and therefore, the related trust is exempt from taxation. Subsequent to receiving the letter, the Plan was amended and restated. Additionally, the Plan received a determination letter dated February 26, 2024, stating the Plan remained qualified upon its termination. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan was operated in compliance with the applicable requirements of the Code and therefore believes the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 20, 2024 and December 31, 2023, there are no uncertain positions taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Party-in-Interest Transactions

Certain investments in the Plan are shares of mutual funds managed by the custodian, or trustee, and its affiliates. Transactions with the custodian and trustee qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transactions provisions of ERISA and the IRC.

9. Subsequent Events

The Plan is being audited by the Pension Benefit Guaranty Corporation ("PBGC") due to the PBGC requirement to audit all terminated plans with more than 1,050 participants. Subsequent events have been evaluated through September 10, 2025, which is the date the financial statements were available to be issued.
