Opinion

We have audited the financial statements of Safeway Insurance Group Profit Sharing and 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion



NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. PLAN DESCRIPTION

The following description of the Safeway Insurance Group Profit Sharing and 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General—The Plan is a defined contribution plan covering all employees of Safeway Insurance Company and its participating subsidiaries (collectively, the “Group” or the “Plan sponsor”), who have attained age 21 and completed one year of service, were credited with at least 1,000 hours of service, and were employed on the last day of the Plan year. A Section 401(k) provision is incorporated into the Plan for all employees of the Group who have attained age 21 and completed one half year of service. The Board of Directors of the Group controls and manages the operation and administration of the Plan. Bank of America, N.A. serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions—Participants are eligible to contribute up to 100% of pretax annual compensation under the 401(k) provision of the Plan, subject to certain Internal Revenue Code (“IRC” or the “Code”) limitations. In addition to pretax contributions, participants may elect to make Roth contributions, which are made on an after-tax basis and subject to the same IRS contribution limits. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Effective January 1, 2019, the Plan was amended and restated. The Plan has elected to adopt the safe harbor matching provision under Section 401(k)(12) of the Code. The Group provides a safe harbor matching contribution of 100% of the first 3% and 50% of the next 2% of compensation contributed each pay period by the participant (the “matching contribution”). Participants are immediately 100% vested in the matching contribution.

Additional amounts may be contributed at the discretion of the Group’s Board of Directors. Under the profit sharing provision of the Plan, the Group may make a discretionary contribution of an amount determined annually by the Group’s Board of Directors. The account of each eligible participant is credited with an allocation of the contribution, equal to the ratio of the participant’s compensation for the Plan year to the compensation for that Plan year of all participants entitled to the contribution (the “profit sharing contribution”). For the year ended December 31, 2024, the Group awarded a profit sharing contribution of \$3,023,147.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions are subject to certain IRC limitations.

Participant Accounts—Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, the matching contribution, along with allocations of the profit sharing contribution, Plan earnings, and forfeitures of terminated participants’ nonvested accounts. Each participant’s account is charged with withdrawals and allocations of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances,

as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments—Participants direct their contributions as well as the employer contributions in any of the investment options offered by the Plan. Participants may change or transfer their investments daily. The Plan currently offers 1 common and collective trust and 31 mutual funds as investment options.

Vesting—Participants are immediately vested in their contributions and the matching contributions, plus actual earnings thereon. Vesting in the profit sharing contribution is based on years of service. Currently, participants vest in the profit sharing contribution at 20% after two years of service, 40% after three years of service, 60% after four years of service, 80% after five years of service, and 100% after six years of service.

Notes Receivable from Participants—Participants are eligible to borrow from their individual accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. Loan terms range from one to five years or up to 10 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a fixed rate, determined quarterly by the Plan administrator. Principal and interest is paid ratably through semi-monthly payroll deductions. The interest rates on existing loans as of December 31, 2024, range from 3.25% to 8.5%, with maturity dates through 2033.

Payment of Benefits—Upon termination of service, benefits are distributed in a lump-sum amount or in periodic installments equal to the value of the vested account balance. Terminated participants with vested account balances of \$5,000 or less are automatically paid out to the terminated participant, unless such participant elects to roll over his or her account balances to an IRA or to another employer's qualified plan; provided, however, that if the terminated participant's vested account balance exceeds \$1,000 (but does not exceed \$5,000), the vested balance is contributed to an IRA established by the Plan administrator on the participant's behalf.

Forfeited Accounts—At December 31, 2024 and 2023, unallocated forfeited nonvested accounts totaled \$32,131 and \$75,635, respectively. During 2024, the December 31, 2023 unallocated forfeited amounts were allocated to the remaining participants. Forfeited nonvested accounts are allocated to Plan participants in the ratio in which the compensation of each participant for the Plan year bears to the total compensation for the Plan year of all participants otherwise entitled to share in the employer contributions.

Life Insurance Contracts—Participants in the Plan prior to January 1, 1996 had the option to use a portion of their profit sharing contribution to pay insurance premiums on individual life insurance policies with a third-party life insurance company. This option is no longer available.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides various investments, including mutual funds and a common and collective trust. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict.

Given the nature of the Plan's investments, the Plan does not believe it is directly invested in any underlying specific security which presents a concentration risk to the Plan, however indirect concentration risk to underlying specific securities may exist across various investment securities.

Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—Investments of the Plan are stated at fair value, except for life insurance contracts, which are reported at contract value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to footnote 3 for discussion on fair value measurements. In accordance with GAAP, life insurance policies are valued at cash surrender value, which is contract value, and the value at which the investment is reported in the Plan's Annual Report on Form 5500.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses—Administrative expenses of the Plan are paid by the Plan or the Plan sponsor, as provided in the Plan document. Participants pay administrative costs for loans, distributions and qualified domestic relation orders.

All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

Contributions – Employee and employer contributions are recorded when earned.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no participants who had elected to withdraw from the Plan in 2024 or 2023, but had not yet been paid at December 31, 2024 and 2023, respectively.

Other Income—Other income arises when investment managers return a portion of the investment fees to the trustee to offset administrative expenses. Any excess resulting from this revenue sharing remains in an unallocated account from which future Plan expenses can be paid. The Plan held undistributed administrative revenues of \$286,978 and \$317,623, at December 31, 2024 and 2023, respectively. During 2024, \$55,252 of administrative expenses were paid from the unallocated account.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Group has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, the accounts of each affected participant shall become fully vested.

6. FEDERAL INCOME TAX STATUS

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service ("IRS"). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

The Plan uses a prototype plan document sponsored by Bank of America, N.A., which received an opinion letter from the IRS, dated June 30, 2020, stating that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed in compliance with the applicable requirements of the IRC and has maintained its tax-exempt status.

Therefore, no provision for income tax has been included in the Plan's financial statements.

7. RELATED-PARTY TRANSACTIONS AND EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts.

Certain administrative services are performed by the Group at no cost to the Plan. Other administrative costs are paid by the Plan, the Plan Sponsor, or the Participants. Furthermore, a portion of investment fees paid to investment managers are returned to the trustee of the Plan to offset administrative expenses. Through a revenue sharing agreement between the Plan and the trustee of the Plan, any excess returned fees remain in an unallocated account from which future Plan expenses can be paid. See footnote 2 for more information.

These transactions are not deemed prohibited party-in-interest transactions as there is a statutory or administrative exemption from the Code and/or ERISA's rules on prohibited transactions.
