### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Procure Software LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of November 13, 2024 and December 31, 2023, and for the period from January 1, 2024 through November 13, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

### ***Basis for Opinion***

As described in Note 1 to the financial statements, the Plan Sponsor terminated the Plan effective February 25, 2024, and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used to present the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditor's Responsibilities for the Audit of the Financial Statements***

### Note 1 – Description of the Plan

The following description of the Procure Software LLC (the "Company," "Plan Sponsor," or "Plan Administrator") 401(k) Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

**General.** The Plan was a defined contribution plan, which went into effect January 1, 2002, that was generally available to all employees of the Company and Participating Employers (collectively, the "Employer"). Employees were eligible to make salary deferral contributions and receive Employer safe harbor matching contributions upon attainment of age 18 and entered the Plan with respect to these contributions on the date the eligibility requirements were met. Employees were eligible to receive discretionary Employer matching contributions and discretionary Employer profit sharing contributions upon attainment of age 18 and completion of 6 months of service and entered the Plan with respect to these contributions on the first of the month coincident with or next following the date the eligibility requirements were met. The Plan excluded union employees, residents of Puerto Rico, and nonresident aliens. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan were not guaranteed by the Pension Benefit Guaranty Corporation.

**Plan Termination.** In connection with a Merger Agreement with Genesis Ulimitate Holding Co., a wholly owned subsidiary of Roper Operations Company II, LLC, the Plan Sponsor's Managing Member resolved to terminate the Plan effective February 25, 2024. In connection with the Plan termination, the following:

- The Plan was frozen. No new participants will enter the Plan and there will be no more participant or Employer contributions to the Plan;
- All participants became 100% vested in their accounts effective February 25, 2024;
- The Plan's termination created a distributable event for all the Plan's participants and the Plan was fully liquidated on November 13, 2024; and
- As further discussed in Note 2, the Plan changed its basis of accounting from the going-concern basis of accounting to the liquidation basis of accounting.

**Change In Service Provider.** On December 1, 2022, Standard Insurance Company ("Standard") announced the closing of the acquisition of Securian Financial's ("Securian") retirement plan recordkeeping business. The Plan's conversion to the Standard's platform occurred in February 2024.

**Plan Amendment.** On May 6, 2024, the Plan was amended to implement the Further Consolidated Appropriations Act of 2019 ("FCAA") in general, and Division O of that Act; the Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE"); a provision of the Bipartisan American Miners Act ("BAMA"), which is also part of FCAA; a section of the Coronavirus Aid, Relief, and Economic Security Act ("CARES"); the SECURE 2.0 Act of 2022; and other law changes.

### Note 1 – Description of the Plan (continued)

**Contributions.** The following types of contributions were allowed under the Plan:

- Salary Deferral Contributions – Participants had the option to contribute a percentage of their eligible pre-tax compensation, as defined in the Plan document, subject to limitations. Participants also had the option to elect to make an after-tax Roth contribution to the Plan. A participant's total contribution could not exceed \$23,000 (\$30,500 if 50 or older) in calendar year 2024. The Plan had an eligible automatic contribution arrangement ("EACA"). Unless a newly eligible participant, or a participant with a deferral election in place of less than 3%, made an affirmative election otherwise, 3% of their compensation was withheld and contributed to the Plan as an elective deferral contribution.
- Employer Safe Harbor Matching Contributions – The Employer made safe harbor matching contributions each Plan year to eligible participants. During the period from January 1, 2024 through February 25, 2024 (Plan Termination Date), the Employer made a safe harbor matching contribution equal to 100% of a participant's elective deferrals not exceeding 3% of the participant's compensation, plus 50% of a participant's elective deferrals in excess of 3% but not in excess of 5% of the participant's compensation.
- Discretionary Employer Matching Contributions – The Employer had the option to make a matching contribution to eligible participants equal to a percentage of salary deferrals up to a maximum of 4% of compensation. During the period from January 1, 2024 through February 25, 2024 (Plan Termination Date), the Employer did not make a discretionary Employer matching contribution.
- Discretionary Employer Profit Sharing Contributions – The Employer had the option to make a discretionary Employer profit sharing contribution to eligible participants who were actively employed on the last day of the Plan year. Participants who terminated employment during the year due to death, disability, or attainment of normal retirement age were also eligible to share in an allocation of the discretionary Employer profit sharing contribution. This contribution was allocated based on a grouping method whereas each participant constituted a separate classification. During the period from January 1, 2024 through February 25, 2024 (Plan Termination Date), the Employer did not make a discretionary Employer profit sharing contribution.
- Rollover Contributions – Certain amounts distributed to participants from other qualified employee benefit plans could be rolled into the Plan.

All contributions were allocated to the Plan's investment funds at the direction of the participants.

**Participant Accounts.** Each participant's account was credited with the participant's contributions (salary deferral and rollovers, if any) and an allocation of (a) the Employer's contributions (safe harbor matching, discretionary matching, and discretionary profit sharing), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

### Note 1 – Description of the Plan (continued)

**Vesting.** Participants were immediately vested in their salary deferral contributions, Employer safe harbor matching contributions, rollover contributions, and related earnings thereon. Effective February 25, 2024 (Plan Termination Date), all participants became 100% vested in their accounts. Prior to February 25, 2024 (Plan Termination Date), with certain exceptions, discretionary Employer matching contributions and discretionary Employer profit sharing contributions were subject to a four year graded vesting schedule, whereas participants become 100% vested in these account after completing 4 years of service. Additionally, employed participants became 100% vested in their accounts upon attainment of normal retirement age, death, disability, and partial termination of the Plan.

**Forfeitures.** When certain terminations of participation occurred, the non-vested portion of a participant's account represented a forfeiture. Forfeitures could be used to reduce future Employer contributions or could be used to pay administrative expenses of the Plan. During 2024, \$125,2017 of forfeitures were used to reduce Employer contributions and \$344 was used to pay administrative expenses. As of November 13, 2024 and December 31, 2023, there was \$0 and \$125,217, respectively, of unutilized forfeitures in the forfeitures account.

**Notes Receivable from Participants.** Participants had the option to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000 or (ii) 50% of their vested account balance. Loan terms ranged up to a maximum of 5 years (a longer term was available if used for the purchase of a principal residence). The loans were secured by the balance in the participant's account and bore a reasonable rate of interest commensurate with local prevailing rates at the date the loan was granted as determined by the Plan administrator. Principal and interest payments were paid ratably through participant ACH payments.

**Investment Options.** Participants had the option to direct their investments into various pooled separate accounts.

**Payment of Benefits.** The Plan's termination effective February 25, 2024, created a distributable event for all the Plan's participants. Prior to February 25, 2024 (Plan Termination Date), benefits to participants or beneficiaries generally were payable as a lump sum, installments, partial withdrawals, or rollover distribution equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. A terminated employee with a balance less than a certain dollar threshold, as defined by the Plan document, could be automatically paid out by the Plan upon termination. Additionally, participants had the option to request in-service withdrawals of their rollover contributions account, upon attainment of age 59½, for a qualified reservist distribution, for a deemed severance of employment, or upon incurring a financial hardship, as defined in the Plan document, if certain criteria were met.

### Note 2 – Summary of Significant Accounting Policies

**Change in Basis of Accounting.** As further discussed in Note 1, the Plan was terminated effective February 25, 2024, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used to present the 2023 financial statements to the liquidation basis of accounting used in presenting the 2024 financial statements.

### Note 2 – Summary of Significant Accounting Policies (continued)

**Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** The Plan's investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determined the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Net appreciation in fair value of investments included the Plan's gain and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants.** Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan document.

**Contributions.** Participant contributions and the related Employer matching contribution were recognized in the period in which participant contributions were withheld from compensation.

**Benefit Payments.** Benefits were recorded when paid.

**Administrative Expenses.** Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Also included in administrative expenses were claims processing, recordkeeping, custodial, investment advisory, consulting, and other administrative fees. Certain indirect investment related and other Plan expenses were included in investment income.

### Note 3 – Fair Value Measurements

Topic ASC 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the authoritative guidance are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

- Pooled separate accounts ("PSAs") are valued at the net asset value ("NAV") of units held by the Plan at year end. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the PSAs less their liabilities. This practical expedient is not used when it is determined to be probable that the PSAs will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5 – Tax Status

The Plan Sponsor had adopted a Minnesota Life Insurance Company Non-Standardized Defined Contribution Pre-Approved Plan ("pre-approved plan"). The pre-approved plan received an opinion letter from the IRS on June 30, 2020, which stated that the pre-approved plan was qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the pre-approved plan and the Plan have been amended since receiving the IRS opinion letter, the Plan Administrator believes that the Plan and related trust were designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan was qualified under Section 401(a) of the IRC and the related Trust was tax exempt as of November 13, 2024 and December 31, 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service ("IRS"). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of November 13, 2024 and December 31, 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan was subject to routine audits by taxing jurisdictions; however, there were no audits for any tax periods in progress.

### Note 6 – Party-in-Interest Transactions

The Company provided to the Plan certain accounting and administrative services for which no fees were charged.

The Plan's investments were separate accounts offered by Standard Insurance Company and Minnesota Life Insurance Company. As Standard Insurance Company and Minnesota Life Insurance Company were the custodians of the Plan, these transactions qualified as party-in-interest transactions. Additionally the Plan maintained notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

### Note 7 – Concentrations

As of December 31, 2023, there were two investments which individually represented more than 10% of net assets available for Plan benefits.

### Note 8 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 1, 2025, which is the date the financial statements were available to be issued.
