Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Skyline Construction Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Skyline Construction Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Notes to Financial Statements

Note 1 – Plan Description

The following is a general description of the Skyline Construction Employee Stock Ownership Plan (the Plan) and participants should refer to the Plan agreement, as amended and restated, for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan that covers substantially all employees of Skyline Construction Enterprises, Inc. (the Corporation). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and the Corporation serves as the plan administrator.

Eligibility – The Plan covers all of the employees of the Corporation with the exception of leased employees and employees who are nonresident aliens. Employees are eligible to participate in the Plan upon reaching age 21 and after completing 12 months and 1,000 hours of service. Participants must be employed on the last day of the Plan year to be eligible for a contribution, except in the case of death, disability, or retirement.

Contributions – Contributions to the Plan may be made by the Corporation in such amounts, and at such times, as may be determined by the Corporation. Contributions may be in cash or property, including shares of the Corporation's common stock. The contribution was paid in 26,062 shares and \$198,019 to the Plan. Contributions are made as allowable under Section 404 of the Internal Revenue Code (IRC). The Plan does not permit employee contributions. Contributions are subject to regulatory limitations.

Participant accounts – The Plan is a defined contribution plan under which a separate individual participant account is established. Each participant's account is credited as of the last day of each plan year with an allocation of employer contributions, investment activity, forfeitures of terminated participants' nonvested account balances, and administrative expenses. Contributions are allocated based on a participant's eligible compensation relative to total eligible compensation.

Each participant has a Company Stock Account (CSA) and an Other Investment Account (OIA). The CSA reflects a participant's interest in the Corporation's common stock. The OIA reflects the participant's interest in assets other than the Corporation's stock. Each participant's CSA is credited with the participant's allocable share of Corporation stock purchased or contributed in-kind, forfeitures of Corporation stock, and any stock dividends on Corporation stock. Each participant's OIA is credited or charged with the participant's allocable share of net income, gain or loss of the trust, and forfeitures other than in Corporation stock.

Diversification – Diversification will be offered to participants so that they may have the opportunity to move part of the value of their investment in company stock into investments that are more diversified. Within 90 days after the close of each plan year in the qualified election period, each qualified participant is permitted to direct the Plan as to the investment of not more than 25% of the shares of employer securities allocated to the participant's CSA to other investment options elected by the participant. In the sixth year, the diversification percentage increases to not more than 50%. Participant's direction must be completed no later than 90 days after the close of the 90-day election period. The Plan's advisory committee (the Plan Committee) will either permit the participant to diversify their account and offer at least three investment options, or in lieu of offering such investment options in the Plan, the Plan Committee may direct that all amounts subject to diversification elections be distributed. Total diversification during the year ended December 31, 2024, was \$30,898.

Notes to Financial Statements

Vesting – Vesting in the Corporation’s contributions is based on years of continuous service. A participant vests ratably over five years of credit service.

Forfeitures – Forfeitures are the nonvested portion of a participant’s account that is lost upon termination of employment. Forfeitures are reallocated to remaining participants in the same manner as the Corporation’s contributions. Forfeitures of terminated, nonvested account balances allocated to remaining participants for the year ended December 31, 2024, totaled 1,714 shares, and \$222,810 in cash.

Payment of benefits – Vested benefits are payable to participants upon retirement, death, disability, or termination of employment. If the total value of a participant’s account is \$10,000 or less, payment will be made in a lump sum. If the total value of the participant’s account is greater than \$10,000, payment will be made in substantially equal installments over a period of five years. The period over which distribution occurs shall be increased by one year, up to five additional years, for each \$210,000 (or fraction thereof) as indexed, by which the value of the account exceeds \$1,070,000.

Segregation – Prior to January 1, 2024, upon termination of employment, the plan exchanged any cash or other liquid assets held in the OIA of active participants’ accounts for shares of Corporation stock in the accounts of terminated participants at an exchange rate determined based on the most recent appraised fair market value of Corporation stock.

On September 27, 2024, the Plan was amended and restated to convert undistributed accounts of inactive participants who became inactive prior to January 1, 2024, to cash. The Company purchased 76,260 shares from the Plan at the fair value on the transaction date of \$7,564,992 to facilitate the share for cash conversion. In future years, the Company may purchase additional shares from the Plan to facilitate further share for cash conversion.

Put option – Participants who receive a distribution of Corporation stock (and if such Corporation stock is not immediately repurchased by the Corporation) are granted two option periods to put the shares to the Corporation. The first option period is the initial 60 days beginning on the date of distribution. The second option period is the 60 days beginning after the new determination date of fair value for the Corporation stock, typically the end of the plan year. The put option is payable in either a lump-sum cash payment or in up to five equal annual installments with interest.

Voting rights – All Corporation stock held by the trust shall be voted by the trustee pursuant to and in accordance with the provisions of the Plan and the trust. In the event of any corporate matter that would constitute a merger, consolidation, reclassification, liquidation, or other related activity as specified under Section 409(e)(3) of the IRC, each participant who has been allocated shares of stock may instruct the trustee as to the voting of those shares.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates. The value of the Corporation's common stock is a significant estimate that is derived from an appraisal of the Corporation's fair market value. Factors impacting the economy, the Corporation, or the Corporation's industry could result in a different fair market value for the Corporation's common stock, and that difference could be material to the value of the Plan's assets.

Investment valuation – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability (the "exit price") in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses, and unrealized depreciation and depreciation of those investments.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Corporation and are excluded from these financial statements.

Plan termination – Although it has not expressed any intention to do so, the Corporation may discontinue its contributions at any time, or partially or fully terminate the Plan, subject to the provisions of ERISA. In the event of any discontinuance of contributions, or partial or full termination, the participants will become 100% vested in their accounts.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits, but arose after the statement of net assets available for benefits date, and before the financial statements are available to be issued.

On July 31, 2025, the Plan sold 90,146 shares to the Company to convert undistributed accounts of inactive participants who became inactive prior to January 1, 2025 to cash, for a total purchase price of \$10,384,819.

The Plan has evaluated subsequent events through August 19, 2025, which is the date the financial statements were available to be issued.

Note 3 – Investments

All investments are nonparticipant directed. The value of Corporation common stock is determined annually by an independent appraisal. The estimated fair value, as determined by an independent appraisal, was \$107.90 and \$93.40 per share as of December 31, 2024 and 2023.

Note 4 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include, quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund – Valued at the daily closing price as reported by the fund. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The fund held by the Plan is deemed to be actively traded. The mutual fund held by the Plan is an open-end mutual fund that is registered with the U.S. Securities and Exchange Commission.

The fair value of Corporation common stock is stated at the fair value determined annually through an independent appraisal. This appraisal was based upon a combination of the discounted future stream of earnings and capitalization of earning techniques and multiple market approaches. The appraisal considers historical and projected cash flow and net income, return on assets, return on equity, market comparable, and estimated fair value of the corporation assets and liabilities.

Methods in arriving at fair value may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes the valuation methods used are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Party-in-Interest Transactions

At December 31, 2024 and 2023, the Plan held 762,165 and 812,363 shares, respectively, of common stock of the Corporation, the sponsoring employer. Note 6 – Tax Status

The Internal Revenue Service (IRS) has determined and informed the Corporation by a letter dated November 15, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and continues to qualify for tax-exempt status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan, and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset), or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market volatility, and credit risks as well as valuation assumptions based on earnings, cash flows, and other such techniques. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the common stock in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits. The Company common stock future value is subject to decisions of management and future conditions within the industry in which the Company operates.
