We have performed audits of the accompanying financial statements of the Park Hotels and Resorts 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Notes to Financial Statements

As of December 31, 2024 and 2023 and for the Year Ended December 31, 2024

#### **1. Plan Description**

The following description of the Park Hotels and Resorts 401(k) Plan (the Plan) provides only general information about Plan provisions. Participants should refer to the Plan document and summary plan description for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering eligible employees of Park Hotels & Resorts Inc. and its consolidated subsidiaries (the Company). The Plan, which is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA), was established on December 29, 2017, effective on January 1, 2018 and most recently amended on September 15, 2022, effective January 1, 2022.

The Plan is administered by Park Intermediate Holdings LLC (the Plan Sponsor), and its trustee and recordkeeper is T. Rowe Price Trust Company (the Trustee or Qualified Institution). The Plan Sponsor reserves the right to amend all or any part of the Plan at any time.

##### **Eligibility**

Participation in the Plan is voluntary. All employees of the Company are eligible for the Plan immediately except leased employees, employees covered under a collective bargaining agreement unless specified by a separate agreement for participation, residents of Puerto Rico, and employees who are not classified as regular full-time or part-time employees.

##### **Contributions**

Participants may make pre-tax and Roth contributions in the aggregate, up to 75% of their eligible compensation each payroll period, up to a statutory annual maximum of \$23,000 (\$30,500 for participants 50 years old or older), as determined by the Internal Revenue Service (IRS). Participants are also eligible for a Company match equaling: i) 100% of the first 3% of eligible compensation and ii) 50% of the next 2% of eligible compensation. All new participants are automatically enrolled in the Plan at a 5% pre-tax 401(k) contribution rate.

The Plan's maximum matching employer contributions, as defined in the Plan document, made on behalf of any participant during a Plan year shall not exceed the annual limitation contained in the Internal Revenue Code (the Code) Section 415(c).

Each participant may contribute to the Plan any amount which is attributable to a distribution from another qualified plan if such distribution meets the requirements for a tax-free rollover. Contributions are subject to certain limitations of the Code.

##### **Participant Accounts**

Each participant's account reflects participant contributions, employer's matching contributions, account fees, benefits paid, and a daily allocation of plan earnings or losses, based on the participant's share in the income, gains or losses of the investment funds in which assets are invested.

##### **Vesting**

All elective contributions, employer's matching contributions, and investment earnings are 100% vested at all times.

##### **Notes Receivable from Participants**

Each participant may borrow from their account a minimum of \$1,000 up to a maximum of the lesser of \$50,000 reduced by the outstanding balance of other loans, or 50% of the value of the vested balance. Loan transactions are treated as transfers to or from the account from which they are made. Loan terms range up to five years, unless the loan is used for the purchase of a primary residence, in which case the loan term is up to 10 years. Each loan is secured by the balance in the participant's account. Loans bear interest at a fixed rate equal to the prime rate charged for a loan made under similar circumstances by persons in the business of lending money plus 1%.

### Notes to Financial Statements

At December 31, 2024, interest rates ranged from 4.25% to 9.50%. Principal and interest are payable in equal installments over the loan term. A loan that is in default is generally treated as a taxable distribution from the plan of the entire outstanding balance of the loan (a "deemed distribution"). Participants may not borrow from their Roth accounts.

#### **Payment of Benefits**

Upon termination of service, participants with vested account balances that exceed \$5,000 may elect to receive their benefits in one lump sum distribution, partial distribution, or installments over various specified periods as provided in the Plan, provided that the amounts will be distributed in accordance with the minimum distribution requirements of the Code. If a participant's account does not exceed \$5,000, the participant's vested account will be rolled over to an individual retirement account established by the Plan if the participant does not elect, within the time frames established by the Plan administrator, to receive a lump sum cash distribution or to make a direct rollover.

#### **Administrative Expenses**

The Plan's administrative expenses are paid by the Plan as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. To the extent permitted by ERISA, expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular fund to which the expenses relate. Any expenses not paid by an employer are paid by the Plan to the fullest extent permitted by law.

#### **Investment Options**

Participants may direct their contributions in 1% increments with certain limitations in one of, or a combination of, the various investment options provided in the Plan.

#### **Withdrawals**

If a participant has a financial hardship, as defined in the Plan's document, the participant may be eligible for a hardship withdrawal from his/her account. Additionally, a participant may withdraw amounts from his/her rollover contributions at any time for any reason, subject to applicable taxes and from all accounts on attainment of age 59½.

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue the Plan, subject to the provisions of ERISA.

## **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedules. Actual results could differ from those estimates.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

#### **Employer Contributions Receivable**

The amount of contributions due and payable by the Company are reflected as employer contributions receivable in the Plan's financial statements.

#### **Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value. U.S. GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price).

In accordance with Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, assets and liabilities measured at fair value are categorized into the following fair value hierarchy:

- Level 1:* Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2:* Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, or inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3:* Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable. These inputs reflect management's judgment about the assumptions that a market participant would use in pricing the investment and are based on the best available information, some of which may be internally developed.

The level in the hierarchy wherein the fair value measurement is classified is based on the lowest level input significant to the fair value measurement in its entirety.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

#### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

As a result of macroeconomic factors, such as inflation, increases in interest rates, potential economic slowdown or a recession and geopolitical conflicts, we expect the volatility in financial markets to continue. As the values of the Plan's individual investments have and will fluctuate in response to changing market conditions, the amount of potential losses that will be recognized in subsequent periods, if any, cannot be determined.

### 3. Information Prepared and Certified by Trustee

Certain information disclosed in the accompanying financial statements and supplemental schedules, including investments at fair value and notes receivable from participants at December 31, 2024 and 2023, net appreciation in fair value of investments, interest income on notes receivable from participants, and dividends for the year ended December 31, 2024, was obtained from information supplied to the Plan Sponsor and certified as complete and accurate by the Trustee of the Plan.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

### 4. Fair Value Measurements

The valuation methodologies used for assets measured at fair value are as follows:

- *Mutual funds*: These investments are public investment vehicles valued using the Net Asset Value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within level 1 of the valuation hierarchy.
- *Self-directed brokerage account*: This investment provides access to invest in a wide array of mutual funds and individual stocks that are publicly traded. Holdings in this account are classified within Level 1 of the valuation hierarchy and are market valued.
- *Common trust funds*: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee is used as a practical expedient which is exempt from categorization within the fair value hierarchy. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The common collective trust allows for daily liquidity, and it did not have unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Party-in-Interest Transactions

The Plan holds certain investments managed by the Trustee at December 31, 2024 and 2023. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA. In addition, notes receivable from participants are considered to be party-in-interest transactions because they are transacted with Plan participants. Administrative expenses paid to the Trustee totaled \$23,297 for the year-ended December 31, 2024.

#### 6. Tax Status of the Plan

The IRS has determined that the prototype Volume Submitter 401(k) profit sharing plan is designed in accordance with applicable sectors of the Code and informed the Trustee of such in a letter dated August 19, 2020. The Plan has adopted the Volume Submitter 401(k) profit sharing plan on January 1, 2018. The Plan Sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, that it has no income subject to business income tax, and that the Plan continues to be tax exempt.

#### 7. Voluntary Compliance

Certain computational errors were identified relating to employer match calculations during the year ended December 31, 2023. Corrective contributions to participant accounts, including lost earnings, were credited to participants' accounts during the year ended December 31, 2024.

#### 8. Subsequent Events

The Company has evaluated all subsequent events through July 30, 2025, the date that the financial statements were available to be issued.
