Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Endurance Lift Holdings 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. DESCRIPTION OF THE PLAN

The following description of the Endurance Lift Holdings 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan, established on March 1, 2012, is a defined contribution plan covering all employees of BSC Administration LLC (the “Company”) subject to certain restrictions for participation eligibility as defined in the Plan document. Effective January 1, 2024, the Plan was amended to add ELS Administration, LLC as a participating employer.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Plan Trustee

Fidelity Management Trust Company (the “Trustee” or “Fidelity”) is the Trustee of the Plan and holds all Plan assets in a trust account. The duties of the Trustee are to receive contributions and to invest and reinvest the trust assets of the Plan.

Eligibility and Service

The Plan’s eligibility requirement allows participation upon three months of service and employees attaining 21 years of age.

Contributions

The Plan provides for voluntary pre-tax and after-tax participant contributions expressed as a percentage of the participant’s eligible compensation, as defined, up to 75% of a participant’s compensation. The contributions are not to exceed the limits set by the Internal Revenue Code (“IRC”). Eligible participants may also make catch-up contributions upon attaining 50 years of age, as defined by the Plan.

The Plan provides for discretionary matching employer contributions, and mandatory safe harbor matching contributions to all participants each Plan year in an amount equal to 100% of the participant’s elective deferrals up to a maximum of 4% of the participant’s compensation for the Plan year. For the year ended December 31, 2024, no discretionary matching employer contributions were made.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s safe harbor contribution, the Company’s discretionary match contribution, rollover contribution, Plan earnings or losses, and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Participants direct the investment of their account balances in any of several investment options. Participants can change their investment options among the various investment funds either through direct transfers from one fund to another or by changing the percentage of future contributions allocated among the investment funds.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, the Company’s discretionary match contributions and the Company’s safe harbor contributions made to the Plan and actual earnings thereon.

Benefit Payments

Benefits are payable from participant account balances, subject to certain restrictions, upon termination of employment, retirement, reaching the age of 59½ or by incurring a disability or hardship, as defined by the Plan. In the case of death, distributions are made to the participant's beneficiary.

Distributions may be made in a lump-sum payment or in a single sum distribution of a portion of the vested balance. If the value of the participant's account balance is less than \$1,000, the payment will be made in cash in a single lump-sum. If the participant's account balance is between \$1,000 and \$5,000 and the participant does not affirmatively consent to receive a distribution, the balance will be rolled into an individual retirement account established on behalf of the participant. Any taxable distribution paid directly to the participant will be subject to mandatory federal income tax withholding of 20% of the requested distribution.

Notes Receivable from Participants

Participants are permitted to borrow funds from the Plan subject to a minimum of \$1,000 up to a maximum amount equal to the lesser of 50% of their vested account balance or \$50,000. Note terms range from one to five years, unless such note is for the purchase of the participant's primary residence, in which case the loan repayment period may not extend beyond 10 years from the date of the loan. Principal and interest are paid ratably through payroll deductions and not less frequently than quarterly. A participant may have up to two notes outstanding at any time, provided that only one note with an initial term greater than five years may be outstanding at any time. Participant notes bear terms as deemed appropriate by the Plan administrator subject to certain provisions of the Plan.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and income Recognition

The Plan's investments in mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The common/collective trust fund is stated at net asset value as a practical expedient.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Unrealized appreciation or depreciation in the fair values of investments held at year-end is determined using the fair value at the beginning of the year or the purchase price if the investment is acquired during the year. The realized gain or loss on the sale of investments is determined using historical cost. Upon the sale of an investment, the current year unrealized appreciation or depreciation is adjusted for unrealized gains and losses recognized in prior years. Unrealized appreciation or depreciation along with realized gains and losses are reported as net appreciation or depreciation in fair value of investments in the statements of changes in net assets available for benefits.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued.

Financial Instruments and Credit Risk

Financial instruments which potentially subject the Plan to credit risk include investments in mutual funds and a common/collective trust. Investments are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits. Plan participants bear the risk of any investment losses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are recorded as distributions, based upon terms of the Plan document, upon liquidation of their account balances.

3. FAIR VALUE MEASUREMENTS

The Plan uses a three-level hierarchy, in accordance with the fair value standard, that establishes a hierarchy for grouping assets and liabilities, based on the significance of inputs. The hierarchy of fair value measurements is described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective Trust - The investment, which is a stable value fund, is valued using the net asset value ("NAV") practical expedient, an estimate of fair value. This NAV practical expedient would not be used if it was determined to be probable that the Plan would sell the investment for an amount different from the reported net asset value. The investment can be redeemed at NAV following a 12 month notice period.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the valuation methods are considered appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INCOME TAX STATUS

The Company adopted a non-standardized pre-approved profit sharing/money purchase/CODA plan which received a favorable opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated the pre-approved plan is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Company believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and was tax-exempt as of December 31, 2024, and 2023.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. CERTIFIED BY THE TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and interest and dividends on investments, interest on notes receivable from participants, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Fidelity.

6. PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the Trustee, therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan provides for notes receivable from participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets would be allocated among the participants of the Plan in accordance with the provisions of the Plan.
